#### Request

Reporter is looking for information on an apartment building in Esquimalt (467 Lampson St) was recently sold and all of the 39 units were served eviction notices. The new owners encouraged residents to take buyout of \$1500 and move out before February when renovations to the building will begin. In the marketing of the building on CBRE website, it was mentioned that "rents for the generous sized suites could be increased either through occurring re-rents or through a renovation." <a href="http://www.cbrevictoria.com/467-lampson-street-esquimalt-bc.php">http://www.cbrevictoria.com/467-lampson-street-esquimalt-bc.php</a>

This looks like a "use renoviction to maximize your ROI." Is it legal to market the potential profitability of a rental building through the use of renovation-based evictions?

#### Suggested Response

We expect everyone to act within the law and in good faith. B.C.'s Residential Tenancy Act currently requires landlords to follow specific rules before ending a tenancy in order to do extensive renovations or to demolish a rental unit.

The tenants don't have to agree to the buyout, and if they get an eviction notice they could file a dispute with the Residential Tenancy Branch. A landlord must act in good faith if they plan to end a tenancy for landlord's use or to do major construction or major renovations or repairs.

Good faith means the landlord has honest intentions and no ulterior motive. The landlord must honestly intend to use the rental site for the purposes stated on the notice to end the tenancy. This requirement applies to purchasers who request a tenancy be ended so that they or a close family

member can occupy the rental unit, as well as those who end a tenancy because they are planning to do major renovations or repairs.

Concerned tenants are encouraged to call the Residential Tenancy Branch, where staff can answer any questions and provide information on their rights and responsibilities under the Residency Tenancy Act.

Government has increased penalties for landlords acting in bad faith to 12 months rent to be paid to the tenant.

Affordable rent is typically defined by the Canadian Mortgage and Housing Corporation's definition. Affordable rent is defined as costing less than 30% of a household's before tax income. There isn't a universal rent or formula used by housing providers in BC. Some units charge a fixed rate and others charge based on rent geared to income. When a provider is charging rent geared to income it usually means 30% of that persons income.

Regarding the projects recently announced in your riding I do not yet know for sure what the unit breakdown will be. With that said it would be unusual for a subsidized housing provider not to provide any units built with accessibility in mind.






