On behalf of Shayne, and our entire Executive Committee, Armin, John, Mike and I wanted to extend our sincere appreciation for everyone's hard work and dedication over the past year to deliver new, safe and affordable housing for all the clients we serve. DAS, in close collaboration with our colleagues in Corporate Services, Operations, Executive Office, Communications, Human Resources, Licensing & Consumer Services, and IT, has celebrated many achievements this year and has much to be proud off! Over this past year, over 400 ExComs were put forward and more than 40 new staff were hired to help respond to and deliver projects for our many new housing programs. We also built many new partnerships, including the signing of MOU's between:

- City of Vancouver
- City of Burnaby
- City of Nanaimo
- School Districts 44 and 68
- Three East Kootenay Bands: Shuswap Indian Band, Tobacco Plains Indian Band and the ʔaḡam Community
- Five Nicola Valley Bands: Lower Nicola Indian Band, Shackan Indian Band, Upper Nicola Indian Band, Coldwater Indian Band, and the Nooaitch Indian Band

And we broke new ground with the addition of the Housing Hub with the expectation of many other partnerships to be formed.

In addition, to the RRH Program and 4 new Building BC Programs, the renovation budget was increased 4 fold and thanks to the AS team, every penny of the \$100M plus budget was spent! The Riverview team continues to knock it out of the park and saw the completion of the Lougheed Highway Improvement Project , the opening of the new PACS/Maples Centre for recovery, and continues to book record filming revenues.

Many BC Housing projects and initiatives received awards and recognition. Thank you to all the staff who helped us take home the Heritage BC Award for Heritage Conservation, the CARE Award for Creating Excellence in Housing Affordability, and the Premier's Award for our delivery of the Rapid Response to Homelessness program.

Congratulations to all on a successful fiscal year end and I look forward to the exciting year ahead!

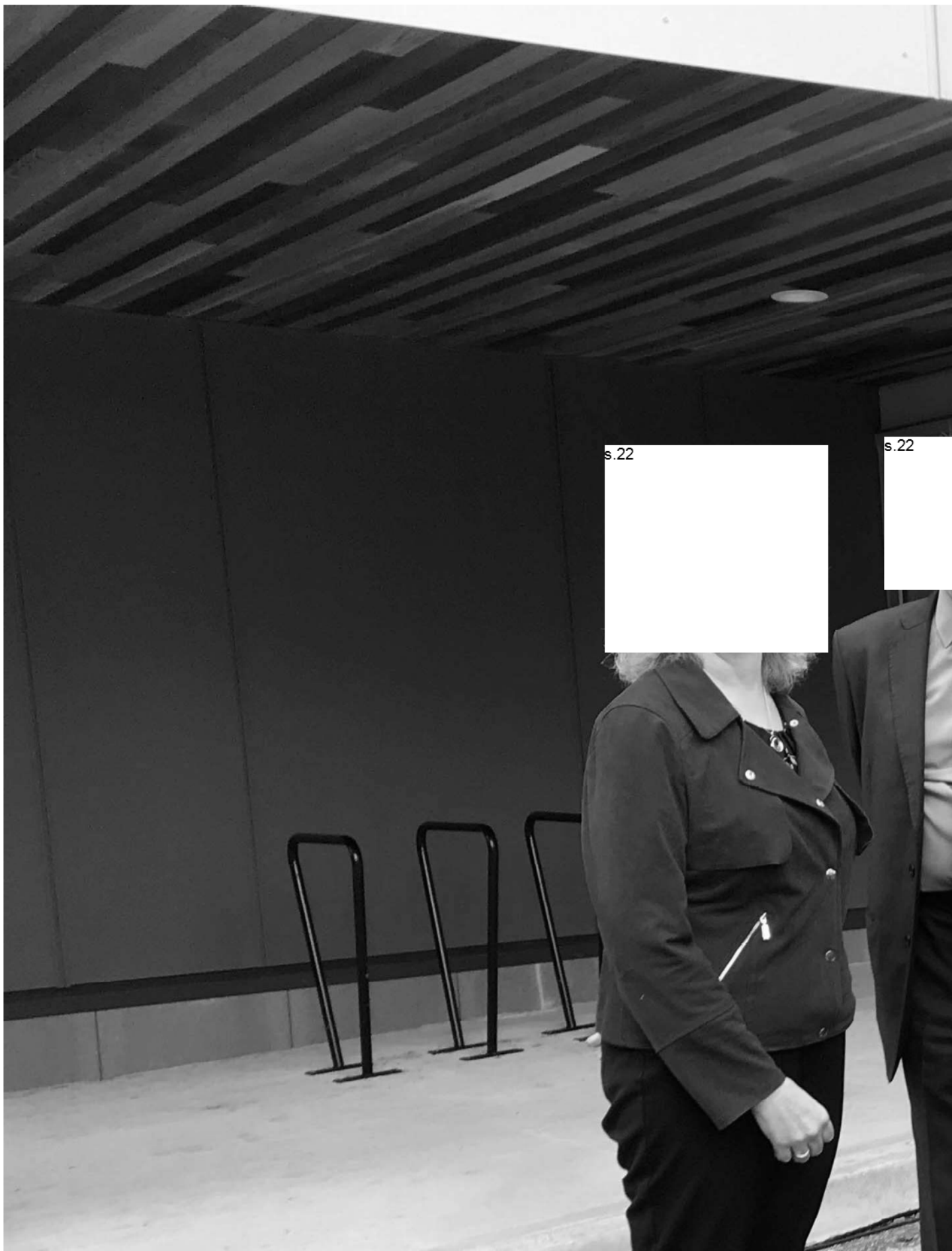
