Hi Daniela,

Attached is a draft EP for an event opportunity for PS Ma on Bowen Island on July 8th to announce expansion of the on-demand transit option.

The project does not have provincial funding and MLA Sturdy is the local MLA, but it is an opportunity for PS Ma – active transportation, Transport 2050, provincial funding to improve transit, etc.

Please let us know if PS Ma is available and interested. It is scheduled for 10:45 a.m.

Below is some background on the pilot from TransLink:

"Bowen Island is now moving into the pilot phase for on-demand transit which is very exciting. It means all residents and visitors on Bowen Island will be invited to download the app and book transit on-demand, which sees commuters set individual drop-off and pick-up points (kind of like Uber for a bus). The pilot program will run for two months and start one week after our announcement (to allow for a one-week education campaign).

It's unclear whether on-demand services will remain on Bowen Island after the pilot, we will review the data and feedback to make decisions from that point. Our framing is this technology potentially playing a huge part in the future of transit for the entire region (I'm happy to talk you through some of the future potentials if you'd like). We have special 'TransLink Tomorrow' bus wraps for two shuttles, which will be in addition to existing fixed route services on the island. So residents will have extra services, nothing being taken away. Importantly, there could be challenges with our pilot as it progresses, and we're being very open about this being a pilot which allows us to learn what works well, what needs improvement, and what people like and don't like etc.

It would be great to have PS Ma involved for our planned launch on July 8th – we're wanting to bring a media contingent over to the Snug Cove Marina for an availability and demonstration with the wrapped buses. Obviously, there's a significant time commitment being on Bowen Island, but we've tried to compress the schedule so we're in and out fairly quickly (to try and make it more appealing for media).

Please let me know your thoughts and PS Ma's interest in attending, speaking, featuring in the release, or all of the above."
