I'm well established again at UBC being a professor again and I had an idea I would like to bounce off you regarding the modular/provincial housing.

Health Canada is offering large research grants to groups developing ways to combat the overdose crisis across Canada. We already won a large grant (\$1.27M) for a project developing on line resources for addicts to support their care and recovery. However helpful, we know from a medical perspective that it not enough, but that "in reach" services must be developed to support individuals in housing. We have been doing some pilot work with Coast Mental Health which is narrowing down what these services might be. For example, in any housing unit,

The goal of the research is to trial different models of in reach support within supportive housing. This is more than intensive case management approach, but going further to determine the best use of the health professions.

We are considering putting in an application and were thinking that the best place to trial models of in reach care would be in the provincial housing, specifically the modular units. In this way, folks moving in will indeed get good medical help on site and we can determine best models of care over a 3 to 4 year period.

For the grant application, we would require a letter of support for the project. Our group would be happy to meet with you (or your staff) and explain further, and provide a draft of the grant.

Let me know if you would consider entertaining the idea.

BCH is waiting for our direction on next steps (posting reports, NR, etc.) – they have shared the reports with partners.

1. Reiderman Residences
2. Chartrand Place
3. Aneki Housing for Women
4. Surrey Temp Modulares (Nancy Gerard, Steve Cobon, Nickerson Place)
5. Sarah Ross House

Also, here are a few key pieces of outcome results from the reports:

1. Between 90% to 97% of all residents remain housed at the developments 6 months after move-in.
2. Between 78% to 100% of survey respondents at the developments reported improvement in overall well-being.
3. The Surrey buildings have been compiled into one report, which is now with the designer. The City of Surrey is very keen to have a copy of this report as they prepare for more supportive housing development in their community.

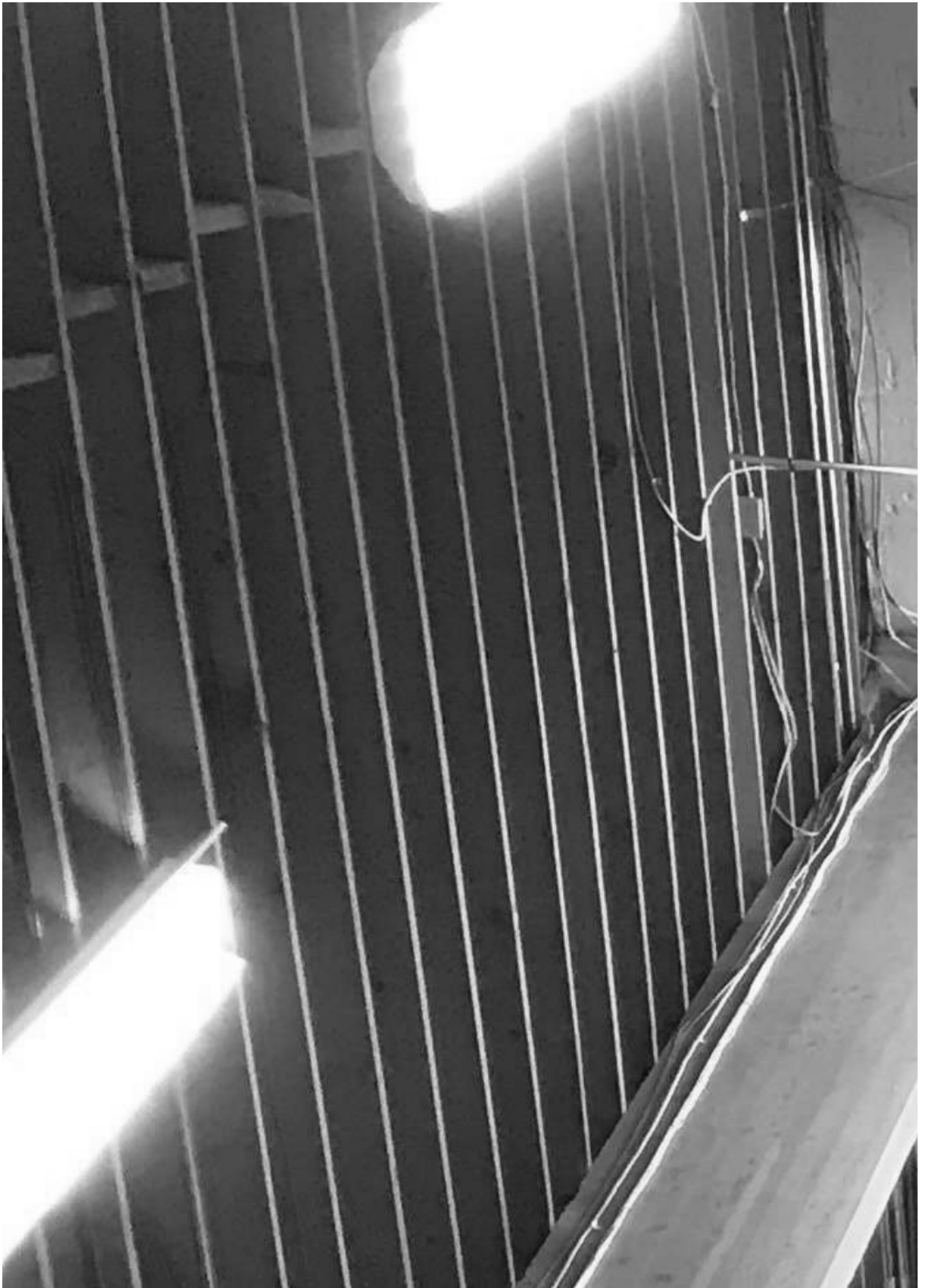

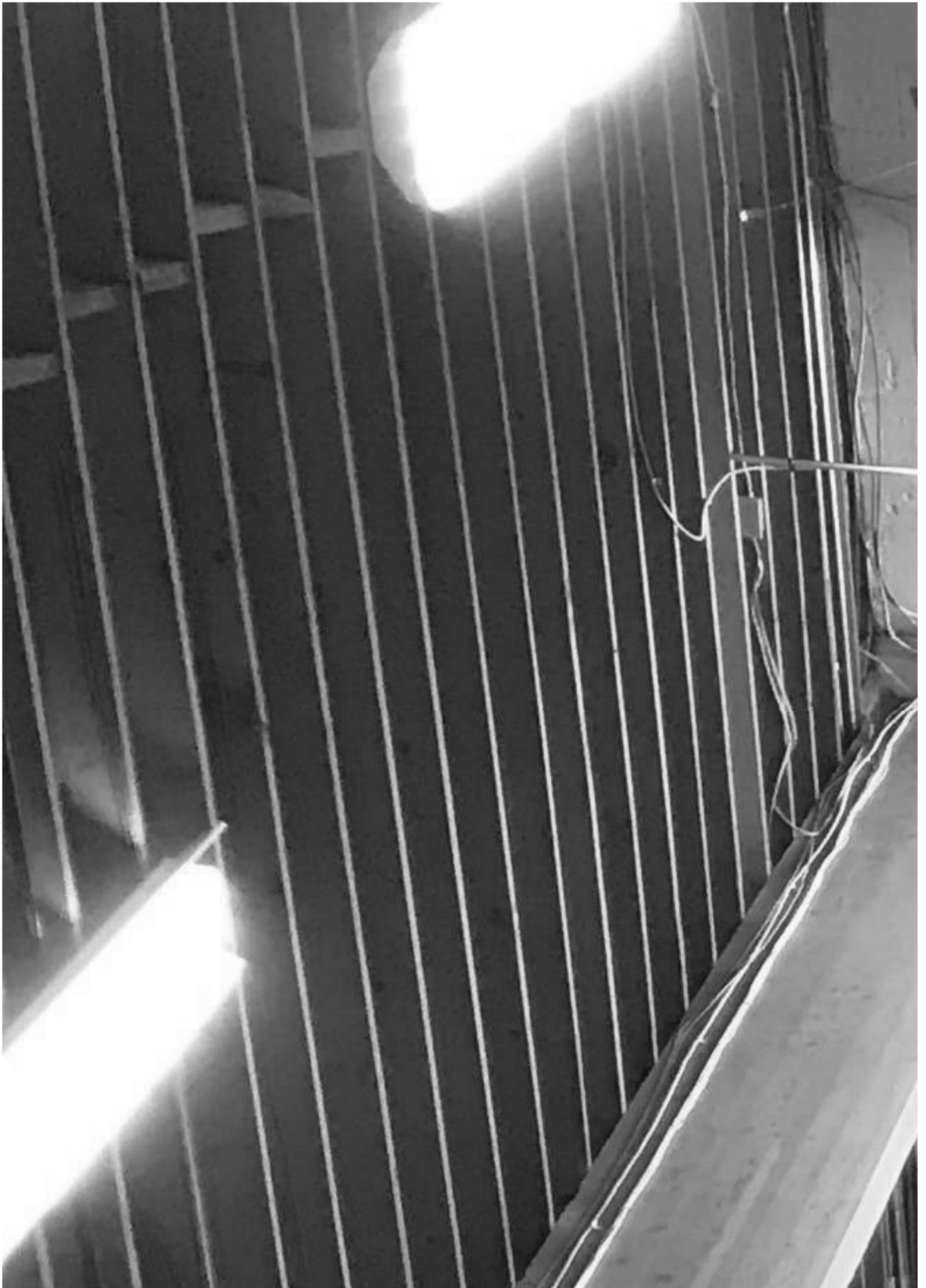

Dear Craig

I wanted to provide you with an update on the progress SHBC has had moving The PAH (Perpetual Affordable Home Ownership) program forward since our call on April 26th.

Municipal Outreach

The PAH program has been gaining much interest and support as we engage funders and potential municipal partners. SHBC has reached out to some of our past municipal partners including Coquitlam, New Westminster, Nelson and Tofino. Through these preliminary conversations, we have received positive feedback from all of them on exploring this housing model further.

City of Vancouver – Potential Pilot

The City of Vancouver sponsored a PAH study that we completed in Q2 2019 which put us in direct contact with Vancouver's Director of planning and senior staff who are all supportive of the model. Following up on this, we met with the majority of City Councilors and late last week I met with Mayor Kennedy Stewart. The councilors we spoke with were uniformly in favour of moving our proposal forward and the Mayor indicated he also favoured this idea as well and would be consulting with senior staff about a proposal for several pilot projects. Based on this information it is a fair assessment to suggest there is significant viability for this new housing model.

Funding

SHBC has been successful in securing project funding from a variety of sponsors:

- **VanCity:** SHBC has secured a modest grant from VanCity to help us in our fundraising efforts;
- **New Market Funds:** New Market Funds has reached out to us to partner in a PAH program focused in more Rural BC communities;
- **BCREF:** The BC Real Estate Foundation has awarded us a matching funding grant for \$300,000;
- **CMHC:** we have just submitted a grant application which has the support of CMHC Chair Derek Ballantyne; and
- **BC Housing:** We had a good meeting last month with Shayne Ramsey and remain hopeful that our funding request for \$350,000 will be supported.

Dear Craig,

SHBC has recently concluded a two year project *Bringing Little Homes to the City*. This project had SHBC present to 27 municipalities across the Province and subsequently partnering with three municipalities - Maple Ridge, Nelson and Vancouver - to support small housing uptake in their communities. The project concluded with the Small Housing Summit which we discussed in our last correspondence.

The project and Summit were very successful and we have renewed interest from our core funders BC Housing, the Real Estate Foundation of BC, CMHC and Vancity for our next extended project - *Small Housing Goes Big*.

While our advisory work will continue through municipal partnerships, much of the next phase of activity will focus with piloting an affordable housing model for infill in single-family neighbourhoods - the Perpetual Affordable Home Ownership (PAH) model. We developed this concept through the work we did with Vancouver as part of the *Bringing Little Homes to the City*.

PAH is very exciting initiative that we believe has far reaching opportunities throughout the province to achieve not only housing affordable targets but meet the needs often defined as the missing middle for most municipalities . We have also mapped out additional emission reduction co-benefits as well as labour capacity strategies.

I had spoken in broad terms about PAH with Jessica Brooke and Doug Page during the conference call you had arranged for staff in late January.

The report is now published on our web site. We have developed a presentation which further details not only the PAH model but the steps we will be undertaking over the course of the next 3 years to support the wider adoption of small housing.

I'd like to schedule sometime for an in-person meeting in April to discuss. While I should be able to accommodate any date that works for your schedule, If you could possible find an opening on April 23, 26 or 29th that would be ideal.

New Social Media Guidelines

Social media plays an expanding role in the everyday lives and work of public service employees. Our social media activity, whether as an individual or in an official capacity, can impact public trust and confidence. Our use of social media in official capacities also impacts the quality and responsiveness of service we provide for citizens.

As employees, we are responsible to ensure our social media activities comply with the Oath of Employment, [Standards of Conduct](#) and other policies and regulations we follow as public service employees.

To help understand these obligations and support you in making informed choices, new personal-use and updated government-use guidelines have been developed.

Personal use

The BC Public Service Agency is launching the new [Social Media Guidelines for BC Public Service Employees](#) to inform your personal use of social media as a public servant. While the guidelines for personal use are new, the expectations they reflect are not. They focus on the principles that will help you make informed choices about your online activity that won't conflict with your commitments to the BC Public Service. They don't prevent you from using social media – they are just intended to help you ensure you're using social media consistent with the Standards of Conduct and other corporate policies.

If you have questions about appropriate professional or personal use of social media, [review the resources available on MyHR](#), and then talk to your supervisor or your ministry ethics advisor.

Government use

Government Communications and Public Engagement has updated the [Guidelines for Government Use of Social Media by B.C. Public Servants](#). The revised guidelines focus on official government use of social media like setting up and

managing social media accounts and engaging in citizen consultations. In addition, the guidelines establish clear processes and best social media practices for supporting key priorities across government.
