On March 12 and 13 we are hosting our provincial meetings where we bring together our local board representatives and staff from across the province to Vancouver. The benefit is the opportunity to touch base with all of our local areas and members at one time as we only convene as a group twice per year in Vancouver. This year we are at the Westin Bayshore.

Minister Robinson previously attended this event in September 2018 and we held a housing supply roundtable with the Minister and Shayne Ramsay. At this event members were sharing their experiences with the development process in their region and some of the challenges to note.

Craig asked me to follow up with you on his behalf.

I believe the project you're referring to is Carrington View at 2200 Majoros Rd. This project is not subsidized housing. Instead, it is a partnership with a rental housing developer where BC Housing is providing low-cost construction financing (i.e. a loan that is paid back). This financing will reduce the project costs for the developer and the savings will be passed on to the people who live there through lower monthly rental rates. The people who will be living in these homes will be paying approximately 30% of their income on rent, which is the common definition of affordability.

In less than two years, we have more than 22,000 homes completed or underway in B.C., including over 1,200 homes in Kelowna and West Kelowna. These are homes for people with low to middle incomes and are built under a range of different funding programs.
