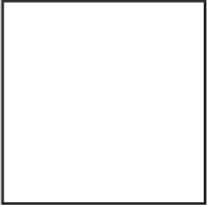

Hi Craig. Trust you are well.

Not sure the whether the Minister has see the attached decision (just came out). It begs the question, does this means every municipality will establish their own RTA? This is very concerning. It strikes us that Minister Robinson (maybe Attorney General Eby) should be making a public statement about this because of the broader implications for Provincial versus municipal jurisdiction.

By way of background, this case was pursued under the guise of renovictions, but really it was about whether municipalities should be allowed to pass their own landlord-tenant law under the guise of business regulation.

The lawyer argued that municipalities lost their ability to do so decades ago when their express powers were repealed and replaced by the Residential Tenancy Act. They argued that the RTA is a complete code and that municipalities lack jurisdiction to create their own landlord-tenant law, and they pointed out the tremendous difficulties that would result if the law varied municipality by municipality. This was all dismissed. The Court essentially found that a municipality's powers to create bylaws are so broad that it includes the ability to legislate in this area.

It's a pretty serious result in our view because it opens the door to municipalities creating their own bylaws of any kind under the guise of business licensing. I think it means that nothing stops a municipality from creating, for example, vacancy control. I know the Minister appreciates how devastating vacancy control would be to our sector. I'm not clear how this decision by the Court benefits tenants, or landlords, if tenancy laws start to vary city by city. It is hard enough for everyone to keep track of a single province wide RTA.

I'd appreciate any immediate comments that the Minister might have and, as I stated, I feel that it is important that Minister Robinson, and possibly the Attorney General, seriously consider making a public statement on the matter to avoid the undermining of Provincial authority over residential tenancies, and potentially well-beyond that.

Our purpose is to explore the status of recent Ministry initiatives addressing housing affordability, and emerging policies in this field. GVAT's focus is on the housing priorities for vulnerable groups in greater Victoria. Among the concerns we might wish to discuss:

- We would like to encourage greater local application of the provincial Rapid Response to Homelessness program, but we wondered if that program was now fully subscribed?
- Policies to support affordable rental housing
- Policies supporting tenants
- Increased variety of housing tenure choices, including co-ops and co-housing

Good morning Craig,

Mira Oreck suggested your name in connection with this issue. Several ways in which the Residential Tenancies Act harms people with fewer resources have recently come to attention. I hope you don't mind me raising them with you.

A friend's daughter has been flooded out of her apartment. She has learned that she must continue to pay rent while she and her partner are displaced. (They can ultimately claim the rent back through some labyrinthine process.) She is able to move to her parents' home, and has resources to continue to pay. Her situation is not a particular difficulty.

However my friend has observed three things:

1. If a tenant has insurance, their insurance can cover the rental payments; however people without resources are less likely to have insurance;
2. Those who can't pay have their lease ended by the landlord for non-payment, even though they aren't getting the benefit of the lease;
3. It is dawning on the landlord in this case that this is a great way to get rid of certain tenants;
- and 4. The landlord is now dragging their feet with repairs.

Surely there is some way to provide for a cessation of residential rents at least up to say \$2,000 a month?

Meanwhile, I am, s.22 starting to ask at the board level about a Canada-wide system of tenant and landlord insurance, which I would love to chat with the right person about at the Province.

Any ideas for working to address these challenges would be very welcome.

Staff are required to take the Oath of Employment during the first three months of their employment. Obligations to loyalty and confidentiality are covered when they sign the *Acknowledgement of Standards of Conduct* as part of their onboarding package sent to them on their first day.

We will schedule an Oath taking session in conjunction with an upcoming face to face session on records management, tentatively scheduled for the morning of Wednesday, February 26 here in Victoria.

We are also considering an EA session for a week in March and can include the Oath/Standards of Conduct training and records management workshop during that time – more to come on this.
