Hi Marielle,

Thanks for your patience. Here is the list of discussion topics for our 9/24, with some background where needed. I would just keep in mind that the audience here is very general. So they might not be brushed up on a lot of these issues and that's why the questions here are fairly basic and broad, to help explain what's happening, what government is doing, etc. We're speaking to lay people (and I'm including myself in this group) that are seeing a lot of things in the news, but can't make sense of what's happening, what's being done in response, what the plan is, etc.

EARLY ELECTION

-Are we going to an early election? (or if it's called by then: Why are we going to an early election?)

MINISTRIES WORKING TOGETHER

-There are three core ministries — The Ministry of Social Development and Poverty Reduction, The Ministry of Mental Health and Addictions, and your file, The Ministry of Municipal Affairs and Housing — that are actively working on issues like the opioids poisoning crisis, homelessness, and addiction, which, albeit related, should not be entirely conflated.

For the lay person (like myself), can you (briefly) explain how this works? i.e. Can you run down the responsibilities over the last three years of your Ministry with regard to homelessness, which includes social

housing that comes with the types of wrap-around services related to the other Ministries tackling poverty, the opioids crisis, and addictions as a whole?

HOTEL PURCHASES

-Can you broadly explain the program that the BC government undertook this summer to purchase hotels and house the homeless? What's the scale (i.e. how many hotels, how many people are being housed)? Did the hotel housing come with "wrap around services" for its residents?

-Andrew Wilkinson said that these hotel purchases are "wreaking havoc on the neighbourhood" referring to Yaletown specifically, while MLA Todd Stone described the purchases in Victoria as "a failure at every level". They're saying that vulnerable people are just being warehoused, small businesses have been facing negative impacts such as theft, property damage, and threats. And the characterization has been that this is a quick fix without ANY wrap-around services.

Can you respond to both BC Liberal concerns and concerns made by small businesses in those areas about these hotel purchases?

-Setting aside the BC Liberals, there are increasing news reports in Vancouver and Victoria about residents feeling unsafe, some being threatened; property crime including break-ins directly related to homeless folks... Allegedly, even former residents of hotels are leaving because they feel unsafe. Can you explain to me what is happening in these areas, what supports are being put in not only to help the vulnerable population but also to ensure safety of other residents, and how your government has dealt with these issues?

BC LIBERAL CLAIMS

-The BC Liberals claim that while the BC NDP promised to build 114,000 units of housing over ten years, only 2,963 units of affordable have been built. In the wake of the revelation that BC only received \$7-million of the federal government's \$1.4 billion in funding for affordable housing, MLA Todd Stone has said "To hear NDP Housing Minister Selina Robinson criticize the federal government for not following through on its housing promises as we watch the homeless crisis worsen in cities throughout the province is especially hypocritical, given the minister has utterly failed to fulfill her own government's promises to British Columbians for the last three years". What's your response to this?

TMH

-On our last episode together (June 2019), you made a very compelling case for Temporary Modular Housing, how it's been successful, and how some of the challenges at certain TMH sites were due to rushed decampments (Nanaimo / Maple Ridge). How are the sites at Nanaimo and Maple Ridge (both sites) looking now a year+ after we spoke?

-How many TMH projects are now up and running (how many people are housed)? How many TMH projects are in the pipeline?

STRATA INSURANCE

-As a condo owner, all I know that is that my strata insurance is going up BY A LOT. Why is this happening and will the BC government intervene?

-How soon will this help me as a condo owner?

LAURIE THRONESS

-How do you feel about Laurie Throness being in the BC Liberal Caucus, and is this personal for you?

PERSONAL

-Even in quasi-virtual Question Periods, I still see that you are a target for jeering and heckling, often being drowned out. Is this just the theatrics of parliamentarianism, or does it go too far sometimes? Do you, personally, feel targeted?

(if we have time)

-I recently learned that 20+ years ago, you were a surrogate mother! What a gift to give one of your friends. There are obviously so many pressing issues right now, but has the BC Government looked at making fertility treatments, egg-freezing, and surrogacy easier in the future? (I covered "infertility"/policy in general in an episode last year). With people having children later in life, LGBTQ-couples, this will become an increasingly important issue for folks?

We created more rental housing than Vancouver has seen in decades. We successfully rolled out the first Empty Homes Tax in North America, which generated tens of millions of dollars to invest in affordable housing, and served as a model for other cities. We were innovative - addressing a housing crisis with temporary modular housing, another model being emulated across the country, helping thousands of families find stability for the first time in their lives.

We also looked after our future generations. We created major public space legacies like the Arbutus Greenway, the closure of Robson Street at the VAG and many more pedestrian-friendly plazas.
