Dear Minister Darcy,

With B.C.'s Family Day approaching, many people are looking forward to spending time with their loved ones and reflecting on the importance of family – something that British Columbians recognize.

I wanted to share the results of a new Insights West survey that shows that **nearly three quarters of British Columbians believe there should be equal access and opportunity for British Columbians facing infertility to build a family regardless of sex, gender, sexual orientation or family status.** Even though infertility is recognized as a disease by the World Health Organization, the treatment comes at a high cost, which is up to the B.C. patients to bear.

Other survey highlights include:

- **Nearly 60 per cent** of women in B.C. have been or know someone who has been affected by infertility'
- **Two-thirds, or 66 per cent** of British Columbians agree that in B.C., cost should not be a barrier to provide assistance to people who have been affected by infertility, and that the Province should support family building for those challenged by infertility; and
- **Three-in-five, or 62 per cent** of British Columbians agree that British Columbia should do the same as other Canadian provinces that have a health care system that covers treatment for infertility (e.g. Ontario, Quebec, Manitoba and New Brunswick).

As a patient advocate for IVF treatment in your constituency who has experienced the hardships of infertility firsthand, I'm encouraged by these findings and urge the Province to act on what British Columbians have identified as an important issue and principle of fairness.

I would very much like to schedule a time to meet with you to share my personal story of hardship and struggle with infertility and why I think it is important that B.C.'s health care system should cover treatment for infertility.
