Re: 'Overdose Risk Assessment and Management Platform', to the Health Canada SUAP

Dear review committee,

I am writing in support of Dr. Michael Krausz and his research team at the University of British Columbia in their application to the Health Canada Substance Use and Addiction Program to develop an 'Online Opioid Overdose Risk Management Platform'. This platform aims to improve access to care for people who inject drugs and their support network and assist in modifying individual behavior to reduce the risk of fatal and non-fatal overdose incidents.

In 2017, the Ministry of Mental Health and Addictions was created to improve the access and quality of mental health and addictions services for all British Columbians, as well as develop an immediate response to the opioid public health emergency. Our priorities are to work in partnership to develop an immediate response to the opioid crisis, create a mental health and addiction strategy to guide the transformation of B.C.'s mental healthcare system focusing on improving access, investing in early prevention and youth

mental health and to consult with internal and external stakeholders to determine the most effective way to deliver quality mental health and addiction services. Overdose is a multifaceted problem and technological interventions such as web-based or app-based approaches can have a significant impact when applied at the population level to reduce the rates of non-fatal and fatal overdoses. This can be achieved through providing vital information on risk awareness and strategies to address risk behaviors. The proposed risk assessment platform can serve as a tool where at-risk individuals are able to navigate through different available resources of the healthcare system based on their individual risk level and be able to make more informed decisions on treatment options. In addition, the proposed co-creation and co-design process will involve individuals most affected by the opioid overdose crisis and allow for active contribution to the design of the solution.

I believe our collaboration with UBC and the development team led by Dr. Krausz will not only assist the ministry in establishing new policies based on the feedback provided through the platform, but will assist in implementation and scale-up of the platform across different areas of BC.
