I just spoke with Colin Gabelman, former AG, who heads the North Island John Howard Society which operates the Foundry Youth Hub there.

He would like me to speak at their AGM in June, which they would open up to the public, date to be confirmed according to my availability. He also wants me to visit the Foundry there, possibly do an official opening cause they never had one, and meet with MH & A staff locally where there are huge concerns about lack of staffing for Tier 3 & 4 MHA services – which he says results in Foundry having to support people they were not designed to support.
