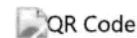

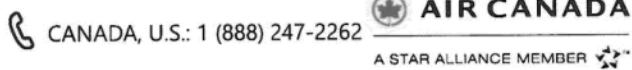

Hi Judy – here are some materials for tomorrow's release of illicit drug overdose stats, including key message document, Q&A, the coroners service reports and their draft news release. A quick summary of tomorrow's numbers to be released is also in the email below.

For your consideration, here also is a draft statement. This would be used to send to media who would like to talk to you but you aren't able to fit an interview in. You have a couple of small windows built into the itinerary tomorrow afternoon when you can do media, but we'd like to have a backup plan in case you can't get to all the requests, if there are a lot. Please let me know if you would like any adjustments to the statement.

Draft Proposed Statement:

- There were 113 suspected drug overdose deaths in August 2017, bringing the total number of deaths so far this year to 1,013.
- The number of deaths in August exceeded the 106 deaths in July. The 2017 numbers have fluctuated up and down, with other months ranging from 118 in February to a high of 150 in April. The highest monthly total to date was in December 2016, with 162 deaths.
- In 2017, individuals aged 19-59 have accounted for 91% of illicit drug overdose deaths. Males accounted for 82% of all suspected illicit drug overdose deaths over the same period.
- More than half the deaths (53%) occurred in people aged 30-49 in 2017 (541 of 1,013).
- There have been 15 deaths in youth aged 18 and under this year.
- The three townships experiencing the highest number of illicit drug overdoses in 2017 to date continue to be Vancouver, Surrey, and Victoria.
- Fraser and Vancouver Coastal Health Authority have had the highest *number* of illicit drug overdose deaths (335 and 306 deaths, respectively) to date in 2017, making up 63% of all illicit drug overdose deaths during this period.
- Vancouver Coastal Health Authority has the highest *rate* of illicit drug overdose deaths (38.9 deaths per 100,000 individuals) and also experienced the largest increase in rate from 2016 (63% increase) among all the health authorities. Overall, the rate of illicit drug overdose deaths in BC increased 53% to 31.6 deaths per 100,000 individuals from the 2016 rate of 20.7 deaths per 100,000 individuals.
- Rates of illicit drug overdose deaths are highest in Vancouver, Okanagan, Fraser East, Central Vancouver Island, and North Vancouver Island Health Services Delivery Areas.
- 88.5% of illicit drug overdose deaths occurred inside (58% private residences, 30.5% other inside locations) and 11% occurred outside in vehicles, sidewalks, streets, parks, etc.
- There were no deaths at supervised consumption or drug overdose prevention sites.
- From January to August 2017, fentanyl was detected in approximately 81% of illicit drug overdose deaths.
- Carfentanil has been detected in 24 suspected illicit drug overdose deaths in June-August 2017. *Note this is subject to change as further toxicology results are received.*

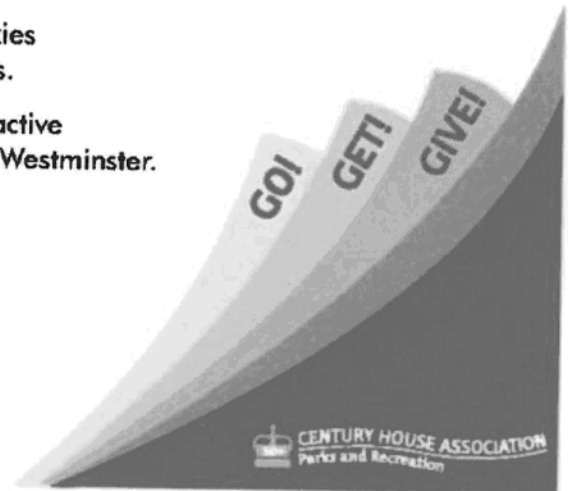
