Hi Norm,

I would imagine our main issues for consideration would be a general concern around recovery for women in the province. The biggest barrier to women and specifically mothers, in seeking recovery from addiction and specifically residential recovery programs is the fear of losing their children/ who will care for their children while they focus on their healing. A woman may want help for herself, but without anyone to look after her kids she will more likely remain in her circumstances until it's either too late or ministry has got involved and the children are removed from her custody at which point she will have more of a barrier to regain custody and this also increases her level of anxiety which negatively impacts overall mental health.

There are only 2 residential recovery programs for women in BC with one in the pipeline I believe (but I do stand to be corrected). I am not talking about private centers which are not always financially viable for many women needing help.

The second issue would be funding. Karis provides recovery focused counseling which includes private/ one on one counseling; group therapies; extended help for families and women with children and we also provide amenities such as shelter; food for babies and the women and many extended opportunities such as help with budgeting, fitness, nutrition etc...

Essentially we are a non-profit organization and by providing all the benefits mentioned above we are supporting the government/ province as these women do not access these services through government channels.

If we were able to obtain funding per bed/ individual and the costs related to these women, even if it were just a percentage or specific number of women per year, that would be an incredible support for our work.

Hi Norm,

I would imagine our main issues for consideration would be a general concern around recovery for women in the province. The biggest barrier to women and specifically mothers, in seeking recovery from addiction and specifically residential recovery programs is the fear of losing their children/who will care for their children while they focus on their healing. A woman may want help for herself, but without anyone to look after her kids she will more likely remain in her circumstances until it's either too late or ministry has got involved and the children are removed from her custody at which point she will have more of a barrier to regain custody and this also increases her level of anxiety which negatively impacts overall mental health.

There are only 2 residential recovery programs for women in BC with one in the pipeline I believe (but I do stand to be corrected). I am not talking about private centers which are not always financially viable for many women needing help.

The second issue would be funding. Karis provides recovery focused counseling which includes private/ one on one counseling; group therapies; extended help for families and women with children and we also provide amenities such as shelter; food for babies and the women and many extended opportunities such as help with budgeting, fitness, nutrition etc...

Essentially we are a non-profit organization and by providing all the benefits mentioned above we are supporting the government/ province as these women do not access these services through government channels.

If we were able to obtain funding per bed/ individual and the costs related to these women, even if it were just a percentage or specific number of women per year, that would be an incredible support for our work.
