A. INTRODUCTION

As analysis nears completion for the analysis team looking at risk factors for death versus survival using the Provincial Overdose Cohort, capacity exists to undertake analysis of additional themes. At the *2018 Annual Overdose Surveillance Network* meeting, there was strong support to characterize subpopulations at risk of overdose as it is becoming clear that people who experience opioid-related drug overdoses represent a heterogeneous group.

Identifying subpopulations among this overall population can help support more customized, targeted services and outreach campaigns to specific groups.

The following provides an overview of a proposed new Provincial Overdose Cohort analysis team. Those wishing to express an interest in participating should contact: Dr. Caren Rose at caren.rose@bccdc.ca with the e-mail subject “Subpopulations Analysis Team” by June 15th.

B. BACKGROUND

The British Columbia (BC) Provincial Overdose Cohort is a set of linked administrative datasets housed at the BCCDC. It features all individuals who have experienced an opioid overdose in B.C. that is detectable using administrative data. Data on individuals' overdose event(s) are linked to prescribing and healthcare use data, both following the overdose event as well as from the preceding five years. This data structure provides a longitudinal picture of individual health histories before, during, and after an overdose.

Previous information produced using the Provincial Overdose Cohort is available in the Results Catalogue at:

Variables in analyses will include, but are not limited to: demographic characteristics, socioeconomic factors, geography, health care utilization (emergency department visits, community physician visits, and hospitalizations), and prescribing data.

C. PURPOSE

Project Purpose:

This project will identify subpopulations among people who overdose using data available in the BC Provincial Overdose Cohort. Some examples of subgroups that have been highlighted as important to study include:
