### **KEY MESSAGES:**

- Currently there is no standard model for the delivery of clinical services in supportive housing.
- Feedback from operators identifies increased health needs of clients in supportive housing and increased need for clinical services.



#### BACKGROUND:

People experiencing homelessness are not a homogenous group and have had different pathways into homelessness. Supportive housing tailors its response to clients' needs and provides a range of on-site, non-clinical supports to ensure housing stability. At present, there is no standard model for the delivery of clinical services for people living in supportive housing funded by BC Housing. Each health authority determines their level of involvement and type of clinical supports to be provided at the housing site, if any at all. The clinical approach varies not only by community but often project by project within the same community.

The lack of consistency in the clinical approach has been heightened during the Rapid Response to Homelessness program when, at times during the community engagement process it has been challenging to quantify the type of clinical services to be delivered.

A working group was convened this summer to discuss health and mental health services provided at some supportive housing sites, specifically to determine what services are being delivered in which health authorities and to determine how to improve consistency and availability of clinical supports and services.

Feedback from non-profit operators of supportive housing has identified a number of areas in which they feel clinical services are lacking and where Health could be more visible or involved. These are discussed in more detail below.

#### DISCUSSION:

### Current Services Delivered by Health

The type of clinical services is primarily decided through dialogue between the non-profit operator, BC Housing and community representatives from the regional health authority. Health authority representatives are actively encouraged to be involved in resident selection for supportive housing, particularly in communities which have a 'Coordinated Access and Assessment' process such as Victoria, Kelowna and Vancouver. Some of the current services delivered by health across BC include:

- Primary care through a nurse or nurse practitioner
- Medication management as part of a med program
- Health case management teams (Intensive Case Management or Assertive Community Treatment) to meet with existing clients to address mental health challenges, and
- Home support services provided on an as needed basis.

### Increased Need for Clinical Services

Non-profit operators of supportive housing report significant increases in the health needs of people being housed. This is especially true in supportive housing sites with higher amounts of support resources, which includes the Rapid Response to Homelessness program (modular units).

Such reports are also reflected in the Vulnerability Assessment Tool data being reviewed by BC Housing, which shows an increase in the numbers of people who are chronically homeless who have moderate to severe mental health and substance use challenges. The complex health needs of the population being housed has been heightened further by the current opioid crisis which adversely impacts people who are homeless.

Additionally, non-profit housing operators report challenges regarding navigating the referral and intake systems for accessing Mental Health and Substance Use services delivered by health authorities and would



value health taking a more visible role at the supportive housing sites. Clinical services could be provided through a model of embedded services such as nursing positions (Johnson Street Community in Victoria) or through dedicated in-reach services.

Clinical services identified by non-profit providers which are currently lacking include:

- On site mental health and substance use workers to provide enhanced access to intake, rapid assessments
- Primary Care, Psychiatrist and Addictions Specialists
- Licensed Practical Nurse/Registered Nurse supports
- Specialist home support services-preferably delivered through the non-profit housing operator to ensure continuity of supports
- Nurse practitioners
- Specialist teams especially Intensive Case Management supports

#### Homelessness Action Plan

In 2017, the Province mandated MAH and SDPR with the development of a Homelessness Action Plan. In November 2018, the policy direction and phasing of the proposed Plan was ratified by Cabinet. Rather than releasing the Homelessness Action Plan as a stand-alone strategy, the Budget 2019 Poverty Reduction Strategy by the Ministry of Social Development and Poverty Reduction included Actions on Homelessness. SPDR is leading the implementation of these actions and MAH retains responsibility for encampment prevention and response. BC Housing remains the operational lead for housing and homelessness.

Actions on homelessness included in the Poverty Reduction Strategy include a provincial rent bank, the creation of a new Office of Homelessness Coordination to work across governments and with stakeholders on targeted interventions, \$10-million in policy enhancements for income assistance clients, a 2020 Provincial homeless count and an additional 200 units of modular supportive housing.

Through the Office of Homelessness Coordination, the Province has provided a \$6 million grant to the Social Planning and Research Council of B.C. for a Homelessness Community Action Grant program.

The Ministry of Municipal Affairs and Housing is developing Encampment Response Guidelines for Ministries to serve as a resource for better coordination, best practices and processes – with the input and collaboration of social and landowner ministries, as well as BC Housing and public health agencies. Ministry staff are available to provide assistance and resources for stakeholders like local governments.

As part of Budget 2019, Treasury Board approved funding for MAH and BC Housing for the first year of some services to be delivered, as approved by cabinet, as part of the Homelessness Action Plan.s.12; s.13 s.12; s.13

s.12; s.13 Capital funding of \$53.486 million in 2019/20 and \$7.286 million in 2021/22 to fund land acquisition for one alternative shelter structure, and to construct 200 modular units was also approved and is included in BC Housing's capital plan.



Of the 200 supportive modular housing units funded in Budget 2019 under HAP, 4 projects (193 units) are under construction or proposed. The projects will be located in Maple Ridge (52 units), Gibsons (40 units), Vancouver (52 units), and Kelowna (49 units).

**ISSUE:** Meeting with Supportive Housing Service Providers

## **BACKGROUND:**

On Thursday October 10<sup>th</sup> at 11:00 am, Minister Selina Robinson, Minister Shane Simpson and Minister Judy Darcy will convene a joint roundtable with 10 non-profit supportive housing service providers. Discussion will focus on better understanding the successes and opportunities for continuing improvements of supportive housing across the province. Executive Directors from the 10 non-profits were encouraged to bring frontline staff member to share their insights and experiences based on their day-to-day working in supportive housing.

Recognizing the urgency of the housing and homelessness crisis, the 2017 Budget Update and Budgets 2018 and 2019 included major commitments to affordable and supportive housing. Through the *Rapid Response to Homelessness* program and *Building BC: Supportive Housing Fund*, the Province is providing funds to build and operate 4,700 supportive housing units. At this time, the Province has delivered 2,000 supportive housing units across B.C., in less than two years.

Supportive housing combines subsidized rental housing with flexible, individualized and voluntary support services for individuals with high needs, and limited experience living independently in stable housing. Some residents with high acuity may stay in supportive housing long term, whereas some residents may start in supportive housing and after a period of stabilization move to other housing options with less support.

Supportive housing is one option for housing the 'hard to house', specifically individuals who are chronically homeless. Generally, supportive housing buildings or units are referred to as 'low-barrier', aligning with the principles of Housing First, this means individuals are not required to stop any drug and/or alcohol use — it is their home.

Supportive housing provides 24/7 on-site staffing and support, which can include non-clinical supports, life skills development, meals and connections to primary health care, mental health or substance use services. BC Housing has evaluated resident outcomes across five new supportive modular housing complexes in B.C. (see attachment BC Housing Supportive Housing Outcome Summary Report 2019)

## **DISCUSSION:**

The intersection of mental health, homelessness and housing has long been established. Due to the intensity and complexity of the housing and homelessness crisis, and of shared issues facing populations experiencing or at risk of experiencing homelessness, the Ministry of Social Development and Poverty Reduction (MSDPR), the Ministry of Municipal Affairs and Housing (MAH), and the Ministry of Mental Health and Addiction (MMHA) are coordinating efforts for a cross-government, collective approach.

Across the province, non-profit housing providers and municipalities have had significant challenges with the acceptability of supportive housing in many neighbourhoods. Many facing public NIMBY — Not In My Backyard, challenges to supportive housing buildings, before development and in some cases after residents have moved in. There are examples of the community accepting the supportive housing complex and residents even after strong NIMBY tensions. BC Housing has developed a *Community Acceptance of Non-Market Housing Toolkit* that provides advice based on experiences of B.C. municipalities and non-profit service providers (see attachment *BC Housing Community Acceptance of Non-Market Housing Toolkit 2019*).

Meeting with non-profit supportive housing service providers will allow MSDPR, MAH and MMHA to learn about successes and challenges to improve planning and coordination for people at risk or experiencing homelessness.
