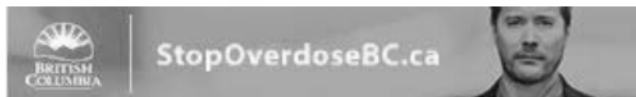
Hi Minister,
