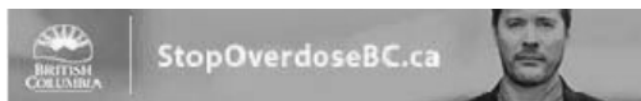

Please let me know what Minister is wanting and I can try to arrange a staff member if required.

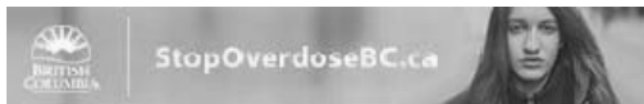

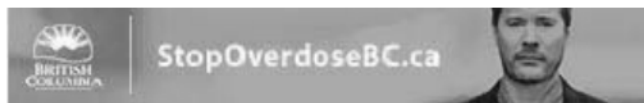

 - **2 of the projects are in your communities of Courtenay and Comox:**
 - ***Indigenous Women's Sharing Society (Courtenay)***
 - Through this grant the Indigenous Women's Sharing Society will offer three different skill building and harm reduction education groups to the community. The groups will consist of a bi-monthly family and

friends support group, a bi-monthly support group for individuals themselves who are struggling with opiate addiction, and a monthly harm reduction education/hip hop night for youth and teens.

- The context of the support groups will include harm reduction education, healthy coping skills training, and Indigenous story-telling and teachings from respected elders in our community and sharing society. This event will be in response to a request made by a community Elder for Harm Reduction from an Indigenous point of view. A nurse will be available who can supply Naloxone kits and training. The day will feature a fully catered lunch with honorariums for the guest speakers. A draw for gift cards will be used as an incentive for evaluations. Cedar brushing will be available for those who desire it and a Spiritual Release box will be available for those who would like to send a message to those who have passed.

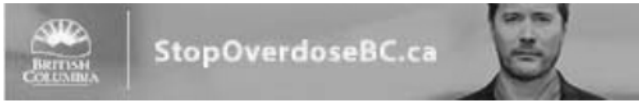
