As you know, SUAP launched an anticipatory call for proposals (CFP) on July 17, 2019. Response to this CFP was overwhelming – by the end of the proposal period at the end of September, Health Canada received 239 proposals representing over \$350 million in potential funding opportunities.

Similarly, an additional 11 proposals from BC were found to have significant merit and are being retained for future funding consideration. This includes the remaining four proposals in stream 2 that received support from the BC Ministries of Health and Mental Health and Addictions.

It is anticipated that SUAP will notify both success and unsuccessful applicants on Thursday, February 20. Subsequently, SUAP will follow up with stream 2 applicants to ensure that the conditions outlined in Minister Darcy's letter of support are addressed.
