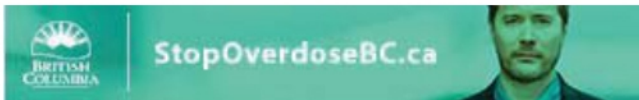

Dear Bobby:

I am resending this letter to Honourable John Horgan and Honourable Judy Darcy as I have had not heard back from them. My understanding is that the NDP Government is requesting suggestions to aid in ending the many deaths in our province from Fentanyl over doses. Prince George is experiencing an increases in death from last year and yet there seems to be no effort to open a treatment centre for women.

Phoenix House has recently leased a cafe and has met with Deans and Chefs from the College of New Caledonia to discuss a partnership between the Culinary Arts program and a place for people to acquire work experience. BC Housing is also interested in the cafe providing work experience.

Phoenix House has an office at Prince George Corrections Institute. The discussion about housing and work also includes women leaving prison. What if we had the Treatment Centre at the Youth Containment Centre, which is across the highway from the prison. Women could transfer from prison to the treatment centre. Graduate from the treatment centre to attend Street Humanities at the College, graduate from Street Humanities (which is for marginalized people to give them a sense of sitting in class and learning). Graduate into Culinary Arts (if they wish or some other course). Culinary Arts will give them opportunities to work in a cafe and interact with citizens. They will cook, serve, waitress, learn what it takes to develop a business, develop a menu, learn to shop, learn to work as a team, and gain real work experience. Phoenix House and AWAC shelter have supportive recovery beds designed for pre-entry into a treatment program and support for when they graduate from a treatment program. BC Housing is developing housing for men and women in Prince George, which the participants will move into when they are able.

We need the treatment centre for women and we need Bowron House for the pregnant addicted women. It is all here, we need funding and support from BC Housing and our government.

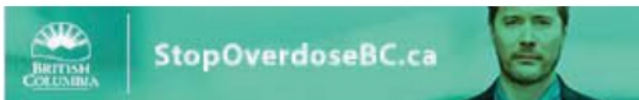

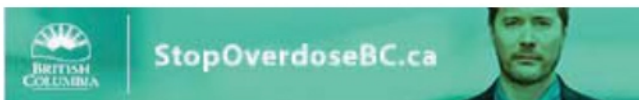
