

# **Encampment Response & Homelessness Prevention - Vancouver**

- The East Hastings and surrounding areas encampment response is the priority homelessness response effort in the City of Vancouver.
- To ensure positive and lasting resolution on E Hastings, partners need to sustain the larger DTES and City-wide homelessness response effort while resolving E Hastings.
- The City of Vancouver homelessness context:
  - 3,800+ people waiting for supportive housing
  - 1,500+ BC Housing supported shelter spaces.
  - 100+ people connected with the East Hastings encampment identified as still requiring housing





# How the East Hastings encampment is different than previous ....

- Not a park: No firm geographic boundaries, unable to fence and restrict access while working through resolution allows new flow into encampment.
- E Hastings is a major arterial with very active public realm.
- Elevated safety risks for encampment residents and tenants in adjacent buildings (fires, access and egress, personal safety, etc.) due to the location and adjacent built form of buildings.
- Risk of delayed response time for emergency services due to obstruction and safety risks for staff.
- Significant impact on neighbourhood residents, local business owners and the public.





# **CAA Process**

- The Community Access and Assessment (CAA) Table meets weekly to review priority referrals affiliated with East Hastings Street.
- Priority for housing allocations is based on vulnerability and informed by meeting the needs of priority populations – Indigenous, women, seniors.
- Shelter holds at four sites have been in place since January so that individuals accepting offers of shelter can retain their bed, if desired.
- CAA is engaging with partners to seek feedback and exploring CAA Best Practices and ways to improve system integration in Vancouver.





Title: Downtown Eastside Decampment

**Purpose:** To inform the Ministers about health supports for Downtown Eastside (DTES) encampment residents amidst the City of Vancouver's (CoV) decampment initiative

**Background:** On July 25, 2022, Vancouver Fire and Rescue Services issued a Fire Order to remove tents and structures along East Hastings Street due to imminent structure and life safety dangers. CoV has developed a phased Hastings Structure Removal plan that commenced on August 9, 2022. This plan was paused until recently, and CoV has resumed activities. While previous decampments had been led by BC Housing, this iteration is unique as it is being led by Vancouver Police Department (VPD).

In September 2022, A Provincial Executive Steering Committee (PESC), led by the Attorney General (Ministry of Housing), was established to provide oversight of the planning and implementation of the encampment response. This committee includes executive representatives from CoV (fire, police, and the city), BC Housing, Ministry of Health (HLTH), Ministry of Social Development and Poverty Reduction (SDPR), Emergency Management BC, Ministry of Public Safety and Solicitor General, Ministry of Mental Health and Addictions (MMHA) and Vancouver Coastal Health Authority (VCH).

VCH Outreach teams regularly connect with DTES encampment residents to provide care and refer to services. Since October, outreach workers have had 2110 interactions; referred 47 to primary care and 17 to substance use services; assisted 18 to access acute care and directly provided 110 people acute care. 85 people have also been referred to Integrated Housing and Outreach Teams (IHOT). Additionally, Mental health nurses have been added to IHOT teams to provide additional support for when decampment enforcement occurs.

On March 24, 2023, the PESC was officially notified of CoV's intent to escalate resolution of the encampment on Hastings sighting increasing fire and safety risk to residents and community. The details on approach and timelines are being managed by the VPD. There was a meeting of all parties i.e., CoV, VPD, and VCH on Thursday, March 30<sup>th</sup> to further refine the operational details for ensuring the required supports are in place on the day of decampment and that individuals who need to access critical health services on Hasting have access to those service. The tentative date for decampment to occur is during the week of April 3 to 7<sup>th</sup>, 2023 (TBC), however this may be further delayed due to concerns that word is out in the encampment of these pending plans.

**Discussion:** There are approximately 117 people currently sheltering outside at the encampment, 70 of whom have expressed a desire for housing. Offers of indoor spaces have been made to most people sheltering outside. As of March 14<sup>th</sup>, the number of structures along East Hastings Street has been reduced from 180 to 79. This number fluctuates slightly daily due to both decampment activities which reduce the number, and new incoming encampment residents which increase the number. and decampment activities progress.

VCH has identified four key areas of focus for contingency planning for ensuring that people receive the health support required and that there is no distribution in people's access to critical health care services are as follows:

# Care for people being decamped:

- IHOT, Car 87/88, mental health clinicians, ambulances, and Emergency Health Services bike squads will be on standby. VCH will provide details as they are able.
- Experience in prior decampments suggests minimal update for health supports during a decampment response. VCH will be present at an operations centre (Mustard Station by the viaduct) to facilitate primary care/mental health supports.
- CoV will have Triage Teams on the ground to address sanitation. They will be
  offering storage bins to encampment residents for up to 30 days.
- BC Housing will be offering same day shelter space or a housing spot for encampment residents.

# Continuity of care to the over 300 housed residents in the area:

- VCH will provide an updated plan following receipt of further details.
- Mitigation plan options pending approach are triaging needs, altering time/day of visits, alternate access points, escorted access, pop up clinics. At this time, there are no projected disruptions to care as VPD will provide escorts for staff.

# Continuity of care to the individuals who access critical mental health and substance use service on Hasting Street:

- There are 10 critical substance use service sites (Appendix A) on Hasting Street, including prescribed safe supply (Vancouver SAFFER), OAT clinics, overdose preventions services and supervised consumption sites. All sites will remain open, and clients will have full access to these services. Decampment will happen in phases starting at Dunlevy Avenue and moving west towards Abbott Street.
- If structures that are being dismantled are located near service entrances, VPD will
  provide escorts to clients and staff to access the service site.
- VCH will provide an updated plan following receipt of further details.

# **Staff Safety Considerations:**

• Increased staffing ratios will be added where required and feasible. Police escorts will also be facilitated as needed.

**Background:** On July 25, 2022, Vancouver Fire and Rescue Services issued a Fire Order to remove tents and structures along East Hastings Street due to imminent structure and life safety dangers. CoV has developed a phased Hastings Structure Removal plan that commenced on August 9, 2022. This plan was paused until recently, and CoV has resumed activities. While previous decampments had been led by BC Housing, this iteration is unique as it is being led by Vancouver Police Department (VPD).

In September 2022, A Provincial Executive Steering Committee (PESC), led by the Attorney General (now Ministry of Housing), was established to provide oversight of the planning and implementation of the encampment response. This committee includes executive representatives from CoV (fire, police, and the city), BC Housing, Ministry of Health (HLTH), Ministry of Social Development and Poverty Reduction (SDPR), Emergency Management BC, Ministry of Public Safety and Solicitor General, Ministry of Mental Health and Addictions (MMHA) and Vancouver Coastal Health Authority (VCH).

VCH Outreach teams regularly connect with DTES encampment residents to provide care and refer to services and have been providing frequency counts on several metrics since October<sup>1</sup>. Since then, outreach workers have had 2110 interactions; referred 47 to primary care and 17 to substance use services; assisted 18 to get acute care and directly provided 110 people acute care. 85 people have also been referred to Integrated Housing and Outreach Teams (IHOT).

On March 24, 2023, the PESC was officially notified of CoV's intent to escalate resolution of the encampment on Hastings sighting increasing fire and safety risk to residents and community. The details on approach and timelines are being operationalized through regular interagency meetings led by CoV, including tri-weekly operational planning meetings led by the CoV, which began on March 27<sup>th</sup>, and includes VCH. Meetings between CoV, VPD, and VCH were held March 30<sup>th</sup>, which have opened communication

The number of structures changes daily, both with new incoming encampment residents, and as decampment activities progress. Seven structures were removed on March 28, however CoV notes "everyone is back" and rebuilding structures.

As details are shared, VCH and the BC Government will be able to adapt their supportive approaches to those affected by the decampment. Contingency planning for critical health care services are as follows:

Care for people being moved:

- IHOT, Car 87/88, mental health clinicians, ambulances, and Emergency Health Services bike squads will be available as per health authority essential services business continuity plans. Level of plan activation is dependent on scale of event. VCH will provide details as they are able.
- Experience in prior decampments suggests minimal update for health supports during a decampment response.
- CoV will have Triage Teams on the ground to address sanitation. They will be offering storage bins to encampment residents for up to 30 days.
- BC Housing will be offering same day shelter space or a housing spot for encampment residents.

Daily critical health care to over 300 housed residents in the area:

### Health Services Impact Post Decampment Operations – VCH Brief Summary

- Overall, we did not see a significant disruption to health care services offered through the 11 store
  front programs or to home based services. The two exceptions were to outreach supports to people
  living in the encampment on Hastings and overdose prevention programs on the first day of the
  police operation.
- Due to the nature of the Decampment operation, VCH was not able to track clients who were displaced.
  - VCH Car87 and the Intensive Housing Outreach Team (IHOT) were on standby near to decampment operation to provide urgent health supports as referred by VPD/CoV during their operation.
  - Standby Health services were available during formal operations and subsequently throughout the long weekend. Overall there were two calls for urgent services between April 5<sup>th</sup> and April 10<sup>th</sup> inclusive.
- 'Storefront' overdose prevention services (OPS) saw reduced traffic on Wed April 5<sup>th</sup>, and closer to normal levels Thurs April 6<sup>th</sup>.
- Outreach teams providing essential services during formal decampment operations included Car87, IHOT, Regional Overdose Outreach Team (OOT), Priority Populations Outreach Team, STOP HIV/AIDS Outreach, and Primary Care outreach services.

Outreach workers have had 2,427 interactions; referred 50 to primary care and 18 to substance use services; assisted 18 to get acute care and directly provided 128 people acute care. 89 people have also been referred to Integrated Housing and Outreach Teams (IHOT). These numbers include one outreach day that occurred mid-decampment initiative, on April 6<sup>th</sup>, which resulted in connections to 85 interactions and 5 instances of wound care. Due to the nature of the decampment operation, VCH was not able to track clients who were displaced.

# **East Hastings Decampment Overview**

**Topic:** Overview of the Province's response to the City of Vancouver and Vancouver Police Department led decampment of East Hastings

# **Key Messaging and Recommended Response:**

- Everyone in the Downtown Eastside deserves a safe, stable and supportive place to call home.
- Over the past several months, the Province has led work with Indigenous, community and government partners to develop and implement a new coordinated response plan to support people in the Downtown Eastside and build on the community's strength and resilience.
- It's focused on helping people get off the streets and into homes to resolve encampments, and on strengthening health, social and cultural supports to make the Downtown Eastside a healthier, safer place for everyone.
- One of the key measures of the response plan is strengthening access and coordination for health, mental-health and substance use services for people in the Downtown Eastside, including through:
  - establishing a new multidisciplinary team that will work to identify the needs of people facing homelessness so they can quickly access health and social services and support transitions to indoor spaces as a pathway to appropriate housing options;
  - expanded addiction treatment options, such as the new Road to Recovery model of addictions care at St. Paul's Hospital; the first 45 beds are expected to open by fall 2023; and
  - expanded mental-health crisis response teams.
- Released on April 3, 2023, Belonging in BC, brings together the wide range of initiatives the Province is developing and implementing to prevent people from becoming homelessness, and for those experiencing homelessness to find a stable housing quickly.
  - Planning and implementation for Phase One and Two of the Belonging in BC Homelessness Plan are underway with a focus on immediate response and serving people with distinct or intersecting needs.

### **CURRENT SITUATION**

- On July 25, 2022, Vancouver Fire and Rescue Services issued a Fire Order to remove tents and structures along East Hastings Street due to fire safety concerns.
- Decampment was initiated by the City of Vancouer in August 2022. This action was paused and a
  provinical East Hastings Encampement Response working group and executive leadership structure
  was implemented.
- Dencampment efforts led by City of Vancouver and Vancouver Police Department commenced on April 5, 2023. The Ministries of Health and Mental Health and Addiction worked with Vancouver

Coastal Health on the development and implementation of a protocol to ensure critical health services were delivered during the Vancouver Police Department (VPD) led decampment activities.

- Since decampment planning commenced in September 2022, VCH Outreach teams have regularly connected with DTES encampment residents to provide care and refer to services and have been providing frequency counts on several metrics.
  - As of April 6, 2023, VCH outreach workers have had 2,427 interactions; referred 50 to primary care and 18 to substance use services; assisted 18 to get acute care and directly provided 128 people acute care. 89 people have also been referred to Integrated Housing and Outreach Teams (IHOT). These numbers include one outreach day that occurred mid-decampment initiative, on April 6th, which resulted in connections to 85 interactions and 5 instances of wound care. Due to the nature of the decampment operation, VCH was not able to track clients who were displaced.
- Since onset of the CoV led decampment, VCH has not experienced a significant disruption to health care services offered through the 11 store front programs or to home-based services:
  - The two exceptions were to outreach supports to people living in the encampment on Hastings and overdose prevention programs on the first day of the police operation. This matter was resolved within five to ten minutes.
  - Essential Home Health/Home Support appointments for people living in buildings on impacted blocks of Hastings were briefly delayed during the first day of decampment but were otherwise delivered without issue through the weekend.
- The Molson OPS Clinic space at Main and Hastings, which provides episodic primary care at a clinic on Hastings twice a week, continued with their regular clinic on April 6th. Volumes were like previous weeks.
- Bookings to bed-based detox services doubled on April 5th and returned to near normal levels April 6th.
- As a mitagtion strategy, OPS site leads deployed street and alley patrols over the long weekend to enhance overdose prevention services.
- Approximately 40 people who were being provided regular outreach servcies on Hastings could not be located on April 6th. As of April 12, 2023 VCH had located 6 these clients. Assertive outreach efforts are ongoing.
- As of April 14, 2023, VCH reported no staff incidents related to the decampment.
- VCH continues to provide end of day updates daily. Cadence and necessity of daily summaries will be evaluated weekly.

On the open letter by staff, this was not brought to my attention on Friday and last contact was around 4ish.

I was aware of a debrief with one of the outreach teams on Thursday whereby staff expressed some distress with the approach, really wishing it would have been more person centered and that they had information on where people went once displaced.




