Given MJW will have been ploughing through mountains of background material and endless briefings with Christine and Darryl on her new Ministry ever since the shuffle, I'd suggest keeping backgrounder briefing material very high level and quickly digestable. A two-pager that positions BCCSU and its mandate within the overall health system - not a BN -- would be about right, with some key outputs referenced that directly connect with and use language from her mandate letter (e.g. POATSP trainees/key research papers/clinical guidelines etc) to bring the conceptual stuff to life. Happy to work with Kevin on this.
