

CHINESE FREEMASONS KELOWNA AND DART COON SOCIETY (the "Recipient") s.22

WHEREAS:

- A. The Province created the **Chinese Historical Wrongs Commemoration Legacy Initiative** to celebrate the positive contribution of Chinese Canadians to B.C.'s history, culture and prosperity; and to contribute to public awareness and appreciation of the historic provincial Apology from the legislative assembly to Chinese Canadians for historical wrongs on May 15, 2014.
- B. The Province has approved funding for the Kelowna Memorial Park Cemetery Commemorative Marker Project (the project) defined in this Agreement and such funding is to be paid by the Province to the Recipient pursuant to the terms of this Agreement.

DEFINITIONS

- 1. In this Agreement and its recitals the following definitions apply:
 - "Agreement" means this Shared Cost Arrangement and any schedules attached hereto;
 - "Project" means the commemoration plaque, posts and any associated design, fabrication or installation described in Schedule A;

2. The Schedules to this Agreement are:

Schedule A Project Description

Schedule B Payment Terms and Conditions

Schedule C Reporting Requirements

Schedule D Communications Protocol

TERM OF AGREEMENT

3. Notwithstanding the actual date of execution of this agreement, the term of this agreement begins on July 15, 2016 and expires on March 31, 2017.

OBLIGATIONS OF THE RECIPIENT

- 4. The Recipient agrees to:
 - (a) use its best efforts to implement the Project and carry out the Project in a diligent and professional manner;
 - (b) ensure that the financial contribution of the Province is to be used solely for the purpose of undertaking and/or completing the Project; and
 - (c) use its best efforts to spend all of the financial contribution no later than November 1, 2016.
- 5. The Recipient will comply with all applicable laws, statutes, regulations, or bylaws of Her Majesty the Queen in Right of Canada, the Province and any local government.
- 6. In accordance with the requirements of the Project, the Recipient agrees to:
 - (a) establish and maintain books of account, invoices, receipts and vouchers for all expenses incurred in a form and content satisfactory to the Province;
 - (b) permit the Province, for contract monitoring and audit purposes, to inspect at all reasonable times, any books of account or records (both printed and electronic, including, but not limited to, hard disk or diskettes), whether complete or not, that are produced, received or otherwise acquired by the Recipient as a result of this Agreement; and
 - (c) maintain all such accounts and records for a period of six years after the term of the Agreement.

- 7. The Recipient is solely responsible for all aspects of the Project, including without limitation, the planning, design, construction, operation, maintenance, worker and public safety, completion and ownership of the Project, and nothing in this Agreement shall be deemed to give the Province interest in, or responsibilities for the Project, unless otherwise provided in this Agreement.
- 8. Upon completion of the Project the Recipient will retain title to and ownership of the assets resulting from the Project and will maintain and operate the assets.
- 9. The Recipient acknowledges that it is not the agent of the Province and will do no act which might be construed as authorizing any contract or permitting any other liability or obligation to be incurred on behalf of the Province.
- 10. The Recipient will obtain prior written approval from the Province for any significant changes to the scope of the Project.
- 11. No sub-contract entered into by the Recipient will relieve the Recipient from any of its obligations under this Agreement or impose upon the Province any obligation or liability arising from any such sub-contract.

OBLIGATIONS OF THE PROVINCE

- 12. Provided the Recipient is in compliance with its obligations under this Agreement, the Province will pay the Recipient the amount and in the manner set out in Schedule B of this Agreement.
- 13. The Province will not have any obligation to make a contribution under section 12 unless the Recipient has complied with the provisions set out in Schedule C.

COMMUNICATIONS

14. The Recipient agrees to follow the terms of the Communications Protocol set out in Schedule D of this Agreement.

INDEMNIFICATION

15. The Recipient will be solely responsible for and shall indemnify and save harmless the Province, and its ministers, officers, servants, employees and agents from and against all losses, claims, liabilities, suits, damages, actions, causes of action, costs and expenses, and demands of any kind ("losses"), or other proceedings by whomsoever brought or prosecuted in any manner based upon, or occasioned by any injury to persons, damage to or loss or destruction of property, economic loss or infringement of rights, caused by or arising directly or indirectly, from:

- the Recipient's performance under this Agreement or the breach of any term or condition of this Agreement by the Recipient, its officers, servants, employees and agents,
- (ii) the on-going operation, maintenance and repair of the commemoration resulting from the Project; and
- (iii) any omission or other willful or negligent act of the Recipient, its officers, servants, employees and agents.

INSURANCE

16. The Recipient will, without limiting its obligations or liabilities herein, provide and maintain insurances with insurers licensed in Canada with coverage of a type, and in amounts, that any similar business, acting reasonably, would procure for a project of the scope, size and exposure of this Project, during the term of this Agreement and for any subsequent ongoing operations and maintenance of the resulting infrastructure.

DEFAULT

- 17. Any of the following events will constitute an Event of Default, whether any such event be voluntary, involuntary or result from the operation of law of any judgment or order of any court or administrative or government body:
 - (a) the Recipient fails to comply with any provision of this Agreement;
 - (b) any representation or warranty made by the Recipient in connection with this Agreement is untrue or incorrect;
 - (c) any information, statement, certificate, report or other document furnished or submitted by or on behalf of the Recipient pursuant to or as a result of this Agreement is untrue or incorrect:
 - (d) the Recipient ceases, in the opinion of the Province, to carry on business as a going concern:
 - (e) a change occurs with respect to one or more of the properties, assets, condition (financial or otherwise), business or operations of the Recipient which, in the opinion of the Province, materially adversely affects the ability of the Recipient to fulfill its obligations under this Agreement;
 - an order is made or a resolution is passed or a petition is filed for the liquidation or winding up of the Recipient;
 - (g) the Recipient becomes insolvent or commits an act of bankruptcy or makes an assignment for the benefit of its creditors or otherwise acknowledges its insolvency;
 - (h) a bankruptcy petition is filed or presented against, or a proposal under the *Bankruptcy* and *Insolvency Act* (Canada) is made, by the Recipient;
 - (i) a receiver or receiver-manager of any property of the Recipient is appointed; or
 - (j) the Recipient permits any sum which is not disputed to be due by it to remain unpaid after legal proceedings have been commenced to enforce payment thereof.

TERMINATION

- 18. Upon the occurrence of any Event of Default and at any time thereafter the Province may, notwithstanding any other provision of the Agreement, at its sole option, elect to do any one or more of the following:
 - (a) terminate this Agreement and in which case the Province's obligation to make any further payment of the money remaining unpaid under this Agreement is also terminated and discharges the Province of all liability to the Recipient under this agreement;
 - (b) require that the Event of Default be remedied within a time period specified by the Province;
 - suspend any installment of payment due to the Recipient by the Province while the Event of Default continues;
 - (d) waive the Event of Default;
 - (e) pursue any other remedy available at law or in equity.
- 19. If the Province terminates this Agreement under section 18(a), then such termination may take place on ninety (30) days' written notice.
- 20. The Province may, at its sole option, terminate the Agreement without cause upon one hundred and twenty (90) days' written notice to the Recipient.

REMEDIES NON-EXCLUSIVE

- 21. The rights, powers and remedies conferred on the Province under this Agreement or any statute or law are not intended to be exclusive and each remedy shall be cumulative and in addition to and not in substitution for every other remedy existing or available to the Province.
- 22. The exercise of any one or more remedies available to the Province will not preclude the simultaneous or later exercise by the Province of any other right, power or remedy.

APPROPRIATION

- 23. Notwithstanding any other provision of this Agreement, the payment of money by the Province to the Recipient under this Agreement is subject to:
 - (a) there being sufficient monies available in an appropriation, as defined in the *Financial Administration Act* to enable the Province, in any fiscal year or part thereof when any payment by the Province to the Recipient falls due under this Agreement, to make that payment; and
 - (b) Treasury Board, as defined in the *Financial Administration Act*, not having controlled or limited expenditure under any appropriation referred to in subsection (a) of this section.

NO FURTHER OBLIGATIONS

24. The Recipient acknowledges that nothing in this Agreement will bind the Province to provide any financing for any addition or improvement to the Project, or any cost overruns of the Project and that no partnership, joint venture or agency will be created or will be deemed to be created by this Agreement or any action of the parties under this Agreement.

JOINT AND SEVERAL OBLIGATIONS

25. In the event the Recipient is comprised of more than one entity, then the covenants and obligations of each of such entities with the others will be both joint as well as several.

AMENDMENTS

26. Unless otherwise specified in this agreement, this Agreement may be amended only by further written Agreement between the parties.

SURVIVAL OF TERMS

27. Sections 6 (b) and (c), 15, and 21, continue in force indefinitely, even after this agreement ends.

- (d) Either party may, from time to time, notify the other by notice in writing of a change of address and following the receipt of such notice, the new address will, for the purposes of section 28 (a) or 28 (b) of this Agreement, be deemed to be the address or facsimile of the party giving such notice.

MISCELLANEOUS

- 29. This Agreement will be governed by and construed in accordance with the laws of the Province of British Columbia.
- 30. The Schedules to this Agreement are an integral part of this Agreement as if set out at length in the body of this Agreement.
- 31. If any provision of this Agreement or the application to any person or circumstance is invalid or unenforceable to any extent, the remainder of this Agreement and the application of such provision to any other person or circumstance will not be affected or impaired thereby and will be enforceable to the extent permitted by law.
- 32. Nothing in this Agreement operates as a consent, permit, approval or authorization by the Province or any ministry or branch thereof to or for anything related to the Project that by statute, the Recipient is required to obtain unless it is expressly stated herein to be such a consent, permit, approval or authorization.
- 33. The Recipient will not, without the prior, written consent of the Province, assign, either directly or indirectly, this Agreement or any right of the Recipient under this Agreement.
- 34. The Recipient will not, during the Term, perform a service for or provide advice to any person, or entity where the performance of such service or the provision of the advice may, in the reasonable opinion of the Province, give rise to a conflict of interest between the obligations of the Recipient to the Province under this Agreement and the obligations of the Recipient to such other person, or entity.
- 35. All records submitted by the Recipient to the Province, including reports, are subject to the access and privacy provisions of the *Freedom of Information and Protection of Privacy Act* ("FIPPA"). All records created pursuant to the Agreement that are in the custody or control of the Province are subject to FIPPA.





This plaque commemorates the Chinese Canadian pioneers, members of the Chinese Freemasons Society, laid to rest at the Kelowna Chinese Cemetery.

From 1850 to 1920, over 80,000 of Chinese have migrated to Canada to work as miners and railway workers. The prominent contribution to Canada was building of the national railway which formed the Confederation of Canada. It was said that for every mile of railway track, one Chinese worker has died working on it in the western section. Many of the Chinese Canadian pioneers could not return to China or reunite with their families, they either died from work or impoverished by the discriminating governmental taxes and fees.

In 1885 the Canadian government had imposed Head Tax on the Chinese immigrant at \$50 a head. The Head Tax was increased to \$500 in 1903. To further restrict the immigration of Chinese, the Canadian government passed the Chinese Immigration Act in 1923 to exclude the Chinese from entering Canada.

For many years, the Chinese Canadian descent had appealed to the federal and the provincial governments of Canada to address their discriminating laws and policies to the Chinese Canadian pioneers. Finally, the federal government in 2006 and the provincial government of British Columbia in 2014 made a full apology to the Chinese Canadian descent for the discriminating laws and policies imposed on them.

On behalf of the Chinese Canadian pioneers, we accept the apologies and hope that this mistake will never happen again. May the souls buried in Kelowna Chinese Cemetery rest in peace.







I have attached a layout for you to look at with the proposed wording. The top one is done in all capitals, and the second one uses upper and lower case lettering.

The dimension of each boulder would be 30" wide by 24" high and 10" thick at the base, tapering up to 4" thick at the top.

The face of the boulder would be unpolished with a rough/natural look on the remainder of the boulder. Each boulder would have deep sand blasting (as shown in the attachment Suggestion for Ministry boulders 1).

The deep blast creates a shadow which makes the lettering very legible. This is how all military grave markers are sandblasted.

The second suggestion for Ministry boulders attachment shows an approximate side view of what the boulder would look like.

The cost for each boulder, including the lettering, would be \$1900.00 plus taxes.

- Both companies have confirmed they will be able to accommodate our budget of \$8,000, including stone, engraving, delivery and install. Timeframe was early to mid-September.





Hi Lauren, can you pls provide guidance for GCPEs input into plaque/stone wording in regard to approvals. Pls drop by for a chat. I'm in all day.

As you know, there will be up to 16 commemorations across the province in *varied* shape, form and exact wording. They will be fabricated and unveiled between September and March 2017 in the different locales.

Cabinet approved the following on July 11 regarding wording.

"The Chinese community, through LIAC, has advised government to develop a Commemorations Plan to establish regional plaques that will be unveiled through March 31, 2017, thus fulfilling the Final Report recommendation. Wording will be either the **longer official Apology wording in its entirety OR the following truncated version**, as follows:

[Truncated Version]

"In Victoria, British Columbia on May 15, 2014 Premier Christy Clark delivered the Legislative Assembly's apology signifying the deepest regret for the hardship and suffering our past provincial governments imposed on Chinese Canadians. The Apology recognized the perseverance, grace, and dignity Chinese Canadians demonstrated throughout our history while enduring discriminatory historical laws."

[Longer Version is attached and refers "only" to the 200 words under Apology heading, not "Legislature Motion" text]

Questions that come up include:

- 1) Hybrid When the longer version is used, what will preface it? I've assumed an excerpt from the truncated version?
- 2) Formatting and capitalization How strict are we?
- 3) Logo attachment.
- 4) Can GCPE assign someone (Shawna?) to advise and receive any required timely advice.

The attached example of Kelowna will help us understand the issues. The Dart Coon Freemasons there have ordered a 40 x 50 large granite rock that will be levelled on one side and will have etched the longer version of the apology. Both the community proponent and the Masonry company have two draft versions (see attachments) used simply to guide them in their stone purchase, knowing it would require govt approval and finalization. The example helps illustrate some of the detailed concerns involved. In other locales, simple bronze plaques will use the

truncated version and will be simpler.

Current Conditions & Uses of Historic Place	The location of Kelowna's Chinatown lay far outside Kelowna's main business center. When Chinatown was first established in the late 1800s, Harvey Avenue, then called Eli Avenue, was a road without any significance until the opening of the Okanagan Lake Bridge in 1958. Today, given the specific design and low quality materials of the buildings, only one building from the former Chinatown still remains - 265/269 Leon Avenue. This single-storey brick building, built in the late 1940s, housed Jung Shoe Repairs and Kwong Sing Laundry, is the only remaining vestige of Kelowna's Chinatown. Another structure is on display at the Okanagan Heritage Museum at 470 Queensway Avenue, Kelowna. This structure is a great representation of the commercial buildings of the period, but itself was never a part of Kelowna's Chinatown. Rather, it is a collection of several artifacts from different buildings that were a part of Chinatown. For example, the steep wooden staircase was once part of the Chinatown "hospital," a small two-storey brick building located between the Masonic Hall and the Dart Coon Club. The current uses of the buildings in Kelowna's former Chinatown include; small automotive dealerships, a few night clubs, the Kelowna Gospel Mission, as well as handful of other small businesses. Although Chinatown no longer exists today, the 2006 Federal census identified approximately 1,236 people of Chinese heritage in Kelowna, or about 1% of the population. Descendants of Chinese pioneers include s.22			
Historical Information about Historic Place	The Chinese were first lured to British Columbia by the Gold Rush of 1858. When the gold petered out, most found work on the British Columbia section of the Canadian-Pacific Railroad (CPR). Most of those who stayed in the interior upon completion of the CPR found work in the agricultural industry. The men generally lived on the farms and orchards where they worked, and only returned to Kelowna's Chinatown in the off-season, when

the population density of Chinatown would increase tremendously. Chinese labour bosses contracted the immigrant labourers to the local employers while also operating rooming houses where the men quartered over the winters, building up debts, which ensured the labour contractors authority over the workers.

It is estimated that in 1909, out of a total population of 1,650 in Kelowna, roughly 250 were of Chinese descent, most of which were men, and only two or three women, and about half-a-dozen children. The predominantly male population consisted mostly of "male-bachelors" – labourers unable to bring their wives to Canada due to the large head tax required. Kelowna's Chinatown remained largely separate from the Occidental Kelowna society and there was very little social mixing between the two ethnic groups. Chinatown was made out to be an opium den where gambling and prostitution were the order of the day. These claims were not only false, they were also damaging to Chinatown itself, which became an increasingly insular society. The one exception was the City Park Café, affectionately known as Quong's. Quong Tape, who died in China in 1938 at the age of 76, founded the City Park Café soon after coming to Kelowna in 1929. His cousin, Jim and another relative, Won (Fats) Quong, operated the Café until it closed in 1964. This two-storey stucco building was the gathering place on Fridays and Saturdays for Kelowna's Caucasian population. The Chinese population in Kelowna peaked in the 1930s, when it reached between 400 and 500. After this, the population went into decline because the men moved to other towns with larger Chinese communities (such as Vancouver and Victoria), accumulated enough money to go back to China, or passed away (as identified in the large Asian section of the Kelowna Memorial Park Cemetery). Because there were so few women, there were virtually no births and internal-racial marriage was very uncommon. By the 1960s only about 60 people remained in Chinatown, and the last business, Kwong Sing Laundry closing its doors in 1978.

The physical character of Kelowna's Chinatown illustrates the social situation of the Chinese population. Chinatown faced inward, as the main street of Chinatown was the alley that ran between Leon Avenue and Harvey Avenue. All the buildings fronting Harvey Avenue were built to front on the alley. This linear organization was very common for Chinatowns throughout British Columbia. The buildings were predominantly two-story wooden structures that had rooming houses on the second floor, while the first floor was commonly used for entrepreneurial ventures, such as cafés, laundries, or general stores. Some of the men had small cubicles in the rooming houses while other shared larger rooms. On the first floor, generally at the back, the owner provided a communal kitchen, where the men individually prepared their meals.

Importance of Historic Place	The site of Kelowna's former Chinatown is significant due to its deep historic association with the Chinese-Canadian community of Kelowna particular, and British Columbia at large. Kelowna's Chinatown is significant as a reminder of the contribution of Chinese-Canadians to the development of the city of Kelowna. Although the last Chinatown busing on this block closed in 1978 and Kelowna's Chinatown is no longer the main business and residential area for the local Chinese community to this place has historical value because the majority of Kelowna's Chine population lived on this block beginning in the late 1800s. 





Dear Chief and Council:

We are writing to inform you of the installation of a commemorative etched stone marker at the Kelowna Memorial Park Cemetery, in the Pioneer Section, commemorating the May 15, 2014 apology from the British Columbia legislative assembly to Chinese Canadians for legislated discrimination enacted by past provincial governments.

The stone marker is a partnership between the Ministry of International Trade Responsible for Asia Pacific Strategy and Multiculturalism and the Chinese Freemasons Kelowna and Dart Coon Society. The stone marker is purely commemorative; does not confer any form of legal protection; and does not register any interest in land. Individual property rights and any asserted aboriginal rights and title will not be impacted by the installation of the commemoration.

The Commemorations Project is one of the legacy initiatives stemming from the Apology for Historical Wrongs against Chinese Canadians. In a segregated section of Kelowna's Memorial Park Cemetery, approximately one hundred Chinese migrant workers are buried. It is likely that some of these workers came to Canada on contracts with the Canadian Pacific Railway (CPR) to help build projects in the Okanagan, such as the Sicamous-South to Vernon rail line and the Kelowna rail wharf. The CPR relied heavily on Chinese workers to build its expansions and public works even after the official completion of the railway in 1885. The Chinese were paid only half the wages of their white counterparts and delegated the most dangerous jobs. It is sometimes estimated that for every mile of railway, at least one Chinese worker died.

Despite needing Chinese labour on the railway, the Canadian government took steps to limit broader Chinese immigration. Starting in 1885, the government instituted a \$50 head tax on Chinese immigrants, which progressively rose to \$500 in 1903. The exorbitant cost of the head tax made it virtually impossible for Chinese workers to bring their wives and children to Canada, as \$500 represented more than two years of wages. Finally, in 1923, the Canadian government passed the Chinese Exclusion Act, which banned all further Chinese immigration to Canada until 1947. As a result, the Chinese workers in the country often died without their families close by, and regional Chinese associations took on the responsibility of looking after their graves.

A number of the Chinese workers buried in the Memorial Park Cemetery were members of the Chee Kung Tong Association, which is now known as the Chinese Freemasons Club. This association served as an important institution for early Chinese-Canadians, as it provided much needed social, emotional, and financial support. In 1911, 15% of Kelowna's population was Chinese; however, this group was marginalized by mainstream society, as is evidenced by the need to segregate the Chinese to a small section of the cemetery. Over the years, people from Kelowna's Chinatown have looked after the graves, honouring the spirits of the Chinese pioneers by lighting candles, burning paper money, and providing food. At first, the graves were marked only by wooden markers, which provided the name and birthplace of the deceased. When these markers became weathered and worn, new concrete headstones were made to replace them in the 1950s. Then, in 2000, the City of Kelowna partnered with community associations to rehabilitate this historic section of the Cemetery. At this time, the headstones were replaced with new granite stones. Because of these efforts, the memory of the early Chinese-Canadians in Kelowna has been preserved, and hope has been kept alive that the racism that marked their lives will never occur again. May they rest in peace.
