ATTENDEE: Mr. Xu Niansha (徐念沙), Chairman of China Poly Group (保利集团董事长)

ISSUE: Minister Wat is invited to attend and speak at several events related to the opening of Poly Culture Group's North American headquarters on November 30th.

BACKGROUND:

- Poly Culture Group Co., Ltd. is a subsidiary of China Poly Group, one of the largest conglomerates in China under the administration of the State-owned Assets Supervision and Administration Commission of the State Council (SASAC). Poly Group has interests in multiple sectors from real estate development and financial asset management to defence technology.
- Poly Culture Group was established in February 2000 by the name of Poly Culture and Arts Co., Ltd. It was restructured and renamed to Poly Culture Group Co., Ltd. in December 2010, and then listed on the Hong Kong Stock Exchange in March 2014. The three main business lines of Poly Culture Group include: Performance & Theatre Management, Art Business & Auction, and Cinema Investment & Mgmt.
- The company is the world's third largest auction house after Sotheby's and Christie's, with auction business related revenues of over USD \$1 billion.
- The company, through its subsidiary Poly Film, conducts business in cinema management and film and TV production. The company owns 70 movie theatres across China and actively produces TV and film content.
- The company was been awarded numerous accolades and awards in China.
 In 2012, it was accredited as one of China's Top 30 Cultural Enterprises.
- Facilitated by Bank of China in Vancouver, Minister Wat had the first meeting with Mr.
 Jiang Yingchun, General Manager of Poly Culture Group in Vancouver in August
 2014 to start the discussion of Poly's business expansion to North America.
- Minister Wat visited Poly Art Museum in Shenzhen during her 2015 Spring Mission.
- At the invitation of General Manager Jiang Yingchun, Premier Clark and Minister Wat met with Poly Group during Premier's Mission to China in Nov. 2015. Premier Clark, Minister Wat and President XU Niansha of Poly Group witnessed the official signing of an MOU between Poly Culture Group and HQVancouver, regarding the establishment of Poly Culture North American in BC.
- The Poly North America Head Office currently has six full-time staff and is operating out of their current address in Richmond.

- A series of high-profile events on November 30th will mark the grand opening of Poly Culture North America, including the opening of an Art Gallery in downtown Vancouver as well as a performance by the China Philharmonic Orchestra at the UBC Chan Centre.
- The performance by the China Philharmonic Orchestra is organized by Poly Culture Group and the Vancouver Symphony Orchestra. The event will be a milestone celebration during the 2015/2016 China-Canada Cultural Exchange Year. The concert will be conducted by Maestro Long Yu, one of the most distinguished Chinese conductors with an established international reputation.
- The China Philharmonic Orchestra was founded in Beijing in May 2000, based on the previous China Broadcasting Symphony Orchestra. It is a division of the State Administration of Radio, Film, and Television (SARFT).

DISCUSSION:

- Poly Group recognized the large population of Chinese people and BC's important role for Canada in terms of trade with China, and BC and Poly would like to seek collaboration in all major business areas so as to strengthen the collaboration between China and BC.
- The opening of Poly Culture's North American Headquarters in Vancouver signals Poly's determination to further expand its presence in the North American market. s.13,s.17,s.21
- The Poly Art Gallery in downtown Vancouver will be operated as a joint venture with an art professional team which has a long-term relationship with Poly. It will be in the business of exhibitions and sales of art products.
- The first artifacts on display at the gallery will include four of the 12 precious bronze animals' heads (tiger, monkey, ox, and pig) originally situated at the water clock fountain at Haiyantang in the Summer Palace in Beijing. This exhibition will be the first time these significant artifacts have left China since Poly Culture acquired the four heads and repatriated them to China after being looted during the Allied Forces attack in 1860.

KEY MESSAGING:

- BC's attractive fiscal climate, business incentives and diversified economy offer excellent investment and partnership opportunities in the media and cultural sector for Poly Culture Group. Vancouver is an ideal destination for film and other creative industry investment.
- The BC Government congratulates Poly Culture on the establishment of their North American headquarters and looks forward to seeing their success in bringing more Chinese cultural industries partnerships to BC.
- Besides the cultural business that Poly Culture is currently focusing on, BC welcomes Poly Group's business interest in other areas and sectors ranging from technology and innovation to financial asset management etc.
- The BC Government and HQ Vancouver are pleased to continue to provide support to Poly's business ventures here in British Columbia.

Mr. Xu Niansha began his career in Chinese Navy after graduating from Guangzhou Navy Commandment College, serving as a navigator and captain. After his military service, he received a Ph.D. in Economics from Peking University and a Ph.D. in Commercial and Civil Law from China University of Politics and Law. He served as CEO of Huahai Real Estate Development Company, then as chairman and CEO of China Ocean Aviation Group Inc. In addition, chairman Xu is a member of the 12th CPPCC (National Committee of the Chinese People's Political Consultative Conference) and its Foreign Affairs Committee. Before taking his position as the chairman of China Poly Group Corporation, he served as vice chairman of China National Machinery Inc.

It intends to leverage the culture industry resources in B.C. and North America and provide outbound support for the development of the Company's three business segments: (i) performance and theatre management, (ii) art business and auction, (iii) cinema investment and management).

BACKGROUND:

China Poly Group is one of the 166 entities under the supervision and administration of the State-owned Assets Supervision and Administration Commission of the State Council (SASAC). Over the past 29 years, Poly Group has established and developed five pillar industries: military and civilian trade and business, real estate development, culture and arts business, investment and exploitation in mineral resource field, civilian explosive materials and blasting service. By 2012, the total assets of the Group have reached RMB 382.9 billion Yuan (over \$60 billion USD).
- Subsidiary Poly Culture Group Co., Ltd. established in February 2000 is China's largest art auctioneer and arts, performance group. Poly Culture is focused on performances and large-scale activities organization and planning, creative design production, theatre management and construction consultation, cultural relics collections, artwork business and auction, cinema circuit and cinema investment operations. It has become one of the leading cultural enterprise groups in China. In 2012, it was accredited as one of China's Top 30 Cultural Enterprises for four years successively.





- Significant businesses divisions of Poly Culture include performance and theatre
 management, museum and artwork auctioning and management, film production and
 distribution and real estate. During initial meetings between BC Trade and Investment
 Office and Poly Culture in 2014, Poly Culture expressed its interests in setting up North
 American HQ in Vancouver and to expand its multiple business areas into the North
 American market.
- In July 24, Poly Culture Group CEO Jiang Yingchun sent an invitation letter to Minister
 Wat to extend an invitation to Premier Clark and Minister Wat to participate in the Poly
 Culture North American head office announcement event and tour the Poly Art Museum
 in Beijing during the upcoming PCC trade mission to China.
