MAV Briefing on CEC Roundtable - Summary

49 members; the largest private sector companies in China. Peter Wang, one member, lives here in BC. (MTW knows Peter).

CEC has indicated they like the outlined roundtable plan – an informal dialogue amongst CEOs. President Ma Weihua, President of the CEC is the head of the CEC delegation.

Time frame – BC CEOs arrive around 9 am. CEC members s.15 will arrive to 5th floor, s.15 and meet MAV at 9:15 am.

Upon arrival there will be a group photo prior to the start of the roundtable at 9:30 am.

Chatham House rules (i.e. not for attribution) – meant to be a closed door dialogue.

3 topics to be discussed with simultaneous interpretation w/ headsets:

1st session - ICT/Digital Media – discussion starter Paul Lee – who will highlight proximity to silicon valley, our tech sector advantages

2nd session - consumer products, e-commerce. – discussion starter Ben Stewart

3rd session - clean tech – discussion starter Paul Austin (Sustainable Development Technology Canada)

APF is preparing a delegate binder for every participant. The binder will contain bios for all delegates from CEC + BC CEOs
