Full Rural Designations for Southern Gulf Islands

#### BACKGROUND

The Chamber is requesting that the Province designate the electoral areas of Salt Spring Island, Southern Gulf Islands and Juan de Fuca in the Capital Regional District (CRD) as rural so they are eligible for all Provincial and Federal rural grant funding programs.

- There is no such designation under either the Community Charter or Local Government Act. Program is cultivated in the Community Charter or Local Government Act. Program is cultivated in the eligibility criteria for each grant program is different and some rural grant programs such as the Investing in Canada Infrastructure Program - Rural and Northern Communities (administered through our Ministry) and the BC Rural Dividend Program (administered through FLNR) already include these electoral areas in their definition of rural and allow them to apply for grant funding.
- The Island Coastal Economic Trust (ICE-T) is governed by a Board of Directors and two Regional Advisory Committees and is governed by the North Island-Coast Development Initiative Trust Act (under the jurisdiction of JTT). A regulation under this Act defines what regions are within the Trust. s.13
- Community Futures is a federal program that provides financing to small and medium businesses, focusing on rural development. There are 34 offices throughout rural BC – the closest to the CRD is Community Futures Cowichan. In BC, funding comes from Western Economic Diversification Canada (under the jurisdiction of the Ministry of Innovation, Science and Economic Development).
- The Minister responded to similar requests from the CRD and Islands Trust last year. s.13
