Dear Minister Osborne,

We, as concerned residents and stakeholders of the Village of Lytton, are signing this letter to request that the Province of British Columbia take an active role in supporting the leadership of our elected Lytton Mayor and Council.

On June 30th a devastating fire destroyed nearly all of our homes, businesses and services. Over the past month, we have had increasing anxiety about the lack of communication and engagement from our Village Mayor and Council.

Below are observations we have made over the past month:

- The Village Office burned in the fire along with the Village's server and backup server, as well as all records and resources.
- Two of three Council members lost their home in the fire.
- Two of three councilors are new to municipal politics.
- Lytton's Chief Administrative Officer was just hired in January 2021.
- We have not had clear communication or direction from the Mayor and Council since the fire.
- They have only contacted one of the five First Nation Bands in the area and have not returned calls from other Bands who have reached out.
- The Village say they have been providing updates on Facebook and the website (www.lytton.ca), however, this information has been very general, sparse and often redundant.
- The Village has stated they have reached out to residents, however, most residents have not been contacted in any formal way.
- On Wednesday, July 28th, the Mayor and Council held a regular council meeting, and nearly 40 community members attended. Information provided did not address our immediate concerns.

The following questions have been asked, but no clear answers have been provided:

- What has been happening in the Village of Lytton since the fire?
- What is the plan for rebuilding?
- When can I get into the Village to see my property?
- What is the Village's short to medium term plan for temporary housing and services?
- Will there be community consultation regarding the model, net-zero community that is being proposed?
- Who is Team Rubicon? What have they been doing in our Village since they have arrived? Have they been on our personal property?

According to the Lytton Village Council meeting on July 28th, a task group will be formed and given power to facilitate the rebuilding of our Village. We believe members of the community should be nominated to form this group and work with council, First Nations, and other support groups to bring about a result that will be acceptable to all.

As the devastating fire is unprecedented in British Columbia, we are concerned that our Mayor and Council do not have the skills, experience and emotional well-being to make decisions and plans around navigating the rebuilding of the Village of Lytton. We are asking the Province to become involved.

This is a call to action for the Province of British Columbia to immediately address our concerns.

Dear sir,

I am writing to you specifically to relate my concerns regarding the response and lack of the Mayor and Council of the Village of Lytton to the catastrophic fire of June 30 which destroyed most of the physical infrastructure (buildings, (water and sewer)etc.) of the village of Lytton and surrounding First Nations which depend heavily on Lytton Village infrastructure for the delivery of health care, supplies, groceries, employment, financial services education, childcare and many other goods and services which relied heavily on the destroyed infrastructure, as well as 80% or more of the residential properties. This event has resulted in an existential threat to the lives of over 3000 people, First Nations and non-First Nations indiscriminately who reside between Boson Bar and Spence's Bridge. Before I proceed further, I would like to describe myself and my involvement in the entire Lytton community over my 38 years(since Oct. 1983) of residency. I am A Professional ForesterRPF9Ret) who was the Woodlands Manager at Lytton Lumber Ltd. for 25 years until 2007- when the mill closed. During my time in the community, I served 7 years as the Chair of the St. Bartholomew's Hospital Society(19885 to 1992), a Councillor of the Village of Lytton(8 years ,1992 to 2000) abd served as the mayor from 2000 to 2008, when I retired and chose not to run again. I have also served as the President of the Royal Canadian Legion Brnch162 . I have kept myself informed of the ongoing issues of the Village since 008.8-22

qualified to comment on the current performance of the Mayor and council and well-informed with community issues even before the fire, and have unfortunately survived the fire and are now biting us on the backside. The three Councils I served with achieved much in 8 years (new sewer treatment, construction of Village Office TNRD library,, new Hospital and assisted living facility), but I maintain our greatest achievement was the Execution of a Community Cooperation agreement in 2007 (Copy attached) with Five First Nation Bands and the Village of Lytton to share infrastructure and work cooperatively for the benefit of all community members. I would argue that this agreement(probably requiring updating) should be the starting point for the planning and execution of the rebuilding of our community. I have personally spoken to dozens of First Nations and non-First Nations community members over the past 35 days and this is exactly what all of them wish to happen when we begin the long task of recovering "normality".

The Mayor and the Council have done everything possible to thwart this initiative and have lost the trust of both First Nation's and non-First Nation's community members by their actions and refusal to allow or answer questions legitimately asked including at Village Council meetings. None of the phone numbers to contact the Mayor or Councillors published on the Village website work and they do not answer emails or respond to requests to return to phone calls or messages left with Village Office On the few occasions when they did return phone calls their enquiries were often dealt with rudely and the Mayor or Councillor hung up to end the conversation. This is not the action of a responsible elected official!!!!

At a disastrous Zoom Council meeting, held in violation of their Procedure Bylaw 569, on July 28th, they refused to allow more than 2 minutes of public statement of questions, yet chose to deal with changing their travel expense procedure and debate which logo they would use on Village correspondence going forward. In my opinion these are hardly issues that are germane to the current issue and are hardly a priority, given the magnitude of the current crisis. When I sent an email requesting, they post the recording of the Council meeting, they refused citing Section 30.1 of the BCFOIPA because Zoom's servers are outside of the country. This is a red herring and patently absurd as no private information was captured other who the 40 people were than in attendance at a public meeting. Mr. Premier, I

cite the slogan for the Washington Post as a rebuttal "Democracy dies in Darkness" which alludes to mushroom farmers practice of growing the mushrooms in dark buildings and feeding their crop"Sh...###&**(padon my French). Well sir, all of the citizens of Lytton are tired of the lack of accountability and useful information being fed to them by all levels of government. And we want immediate action to assist us to start rebuilding our community.

The actions (or lack of)of the Village are actually delaying the beginning of the re-build. In common with 80 % of the Lytton community, s.22 When our insurance adjusters attempted to

attend the site of our former home on this past Wednesday, August 4, 2021, she was required to obtain a permit(I understand this) but were prevented from entering the property and unable to measure foundations and locate critical information needed to proceed to process the claim. They were required to wear haz mat suit,, N95 masks and gloves. While we understand that safety is essential, they sai they have never had to deal with such incompetence in their careers. These are experienced adjusters, who are aware of the risks associated with disasters sites. Anyways, the Village of Lytton would have no liability on my private property. The adjusters are covered by Worksafe BC and our continuing house insurance. Yet the Village continues to maintain the Evacuation Order(EO) and prevents the start or delay the insurance adjustment process and we have no recourse. I have sent emails to the mayor requesting answers to the question of why he persists with the EO and when he expects to lift it. Typically, he has ignored the request for answers and hasnot responded.

Mr Premier, I am aware that you recently received a petition from over 40 individual electors and 12 businesses, requesting that the Province of British Columbia step in to support the Village Mayor and Council. This represents more people than the vote to elect all five people, several of them by acclamation. While you may be tempte to remint h eletors "that elections have consequences", I don't think that simply providing support is sufficient. The entire Council has not demonstrated they consider their duties to bre any more than honourary positions- even before the fire. A good friend(will remain nameless) and fierce political opponent of yours, recently generously defended them by saying "They are probably thinking "this is not what I signed up for when I submitted my nomination paper to which I responded." _____ when you run for a leadership position- you don't get to pick your crisis" Mr. Premier, as our Province's CEO I am sure you know this in spades.

One of the common requests of the public has been the development of a process which includes broad representation and participation rom the community- First Nations and non-First Nations alike. To date, the Village Council has not produced anything of this nature, so in consultation with both First Nations and non- First Nations community members I prepared a proposal to form a Lytton Fire Recovery Task Force proposal which has been sent to every Chief and the Mayor for their considerion. This is by necessity proposed to e a joint initiative of the whole community and is currently being widly shared digitally. I have received nothing but support for the idea of a joint task force so far. Please be aware it is currently in DRAFT format and willmaybe revised as I receive comments. This is the actions the Village Council should have been preparing instead of debating expense accounts and Village logos at the July 28 Council meeting. We can wait no-longer winter is coming and we must make some progress, so we're not I still on the street in December 2021 and January 2022

In closing I would like to state I think there only two available options given the unlikeliness of the Mayor and Council to redeem themselves or improve their performance

Q&A/KMs: Lytton Residents Letter Local Government Support

- 1. What role is EMBC playing in terms of planning for the creation of temporary housing for residents of Lytton to live over the next two years, while the permanent rebuild of Lytton takes place?
 - Emergency Management BC (EMBC) is leading the coordination across all of the provincial agencies, including BC Housing, as well as with outside parties and the federal government, including recovery.
 - EMBC is supporting displaced residents with Emergency Support Services (ESS), including accommodation and food.
 - EMBC is working directly with the leadership of Lytton to identify temporary housing options for residents while the community rebuilds.
- 2. What is the plan? How many units of housing, where located, when available and who will pay costs?
 - The focus over the next few months will be ensuring the residents of Lytton have temporary accommodation and their immediate needs are met.
 - There will also be opportunities for the community to convene with their leadership and define the vision for the rebuild of Lytton.
 - Funding for the rebuild of Lytton will come from various sources, including provincial and federal partners, corporate donations and homeowners' insurance.
 - Last Friday, the Province announced additional immediate supports for all Lytton evacuees.
 - We'll keep listening to the community to determine how we can best support them moving forward through recovery and rebuilding.
- 3. Who else is working with EMBC on these plans? (Is there a committee/organization/other ministries/local governments? Who are its members?)
 - EMBC is coordinating with other provincial ministries and the federal government to provide recovery support to Lytton.
 - This is in accordance with the Interim Provincial Disaster Recovery Framework, which is available
 online: https://www2.gov.bc.ca/assets/gov/public-safety-and-emergency-services/emergency-preparedness-response-recovery/local-government/provincial disaster recovery framework.pdf
 - The Village of Lytton has also engaged the Fraser Basin Council in a scope of work related to recovery, and the Village has engaged other partners to support their Emergency Operations Centre and Resiliency Centres.
- 4. How many residents have been allowed to return to the village to assess damage? Are residents permitted to stay in Lytton or must they leave after a certain number of hours/days? When were they given the green light to return?
 - The Ministry of Environment continues to conduct damage assessments and has not cleared the site for re-entry.
 - An evacuation order was downgraded to an alert for the following areas on July 23rd:
 - Ponderosa Heights
 - Loring Way
 - Lytton Fire Base
 - o Kent Road

- o Highway 1
- We recommend reaching out to the TNRD or the Village of Lytton for more information about resident access to the Village of Lytton, as they are responsible for the decisions around Evacuation Orders and Alerts.

Dear Minister Osborne,

We, as concerned residents and stakeholders of the Village of Lytton, are signing this letter to request that the Province of British Columbia take an active role in supporting the leadership of our elected Lytton Mayor and Council.

On June 30th a devastating fire destroyed nearly all of our homes, businesses and services. Over the past month, we have had increasing anxiety about the lack of communication and engagement from our Village Mayor and Council.

Below are observations we have made over the past month:

- The Village Office burned in the fire along with the Village's server and backup server, as well as all records and resources.
- Two of three Council members lost their home in the fire.
- Two of three councilors are new to municipal politics.
- Lytton's Chief Administrative Officer was just hired in January 2021.
- We have not had clear communication or direction from the Mayor and Council since the fire.
- They have only contacted one of the five First Nation Bands in the area and have not returned calls from other Bands who have reached out.
- The Village say they have been providing updates on Facebook and the website (www.lytton.ca), however, this information has been very general, sparse and often redundant.
- The Village has stated they have reached out to residents, however, most residents have not been contacted in any formal way.
- On Wednesday, July 28th, the Mayor and Council held a regular council meeting, and nearly 40 community members attended. Information provided did not address our immediate concerns.

The following questions have been asked, but no clear answers have been provided:

- What has been happening in the Village of Lytton since the fire?
- What is the plan for rebuilding?
- When can I get into the Village to see my property?
- What is the Village's short to medium term plan for temporary housing and services?
- Will there be community consultation regarding the model, net-zero community that is being proposed?
- Who is Team Rubicon? What have they been doing in our Village since they have arrived? Have they been on our personal property?

According to the Lytton Village Council meeting on July 28th, a task group will be formed and given power to facilitate the rebuilding of our Village. We believe members of the community should be nominated to form this group and work with council, First Nations, and other support groups to bring about a result that will be acceptable to all.

As the devastating fire is unprecedented in British Columbia, we are concerned that our Mayor and Council do not have the skills, experience and emotional well-being to make decisions and plans around navigating the rebuilding of the Village of Lytton. We are asking the Province to become involved.

This is a call to action for the Province of British Columbia to immediately address our concerns.

Thank you for your attention to this matter.

Topic: Lytton Recovery and Rebuilding

Purpose: Overview of current status and next steps for Lytton recovery and rebuilding

BACKGROUND:

The Village of Lytton (Village) has a population of approximately 275 residents with another 1,700 people living in the surrounding rural areas, including nearby Indigenous communities. Approximately 800 members of the Lytton First Nation (LFN) live on reserves immediately adjacent to the village boundary.

On June 30, a fire swept through the village and adjacent LFN reserve, prompting an immediate and sudden evacuation. There have been two deaths due to the fire, which is believed to have been human caused, with speculation that it was the result of rail activity. This has not been confirmed. The fire continues to burn and is in excess of 51,000 hectares.

Damage assessment confirms that approximately 90% of the community was destroyed including the town hall, police station, ambulance station, public library, and most residential buildings. The majority of Village corporate records have been lost to the fire, including those located on the back-up server. Infrastructure impacts to adjacent First Nations reserve lands were minimal, with the LFN Band Office and School suffering smoke damage only. Engineers are assessing the Village's infrastructure such as water and wastewater treatment.

Three hundred insurance claims have been filed to date with a value of \$78 million. Most of these are for residential properties. It is not known how many residents may have been underinsured or uninsured. Disaster Financial Assistance is available for eligible public infrastructure losses.

The Village Council passed a resolution that the community would be rebuilt as a green, firesmart community with net zero carbon emissions. The Village's position is that this vision is subject to the availability of provincial and federal funding. The Ministry of Municipal Affairs (MUNI) and Emergency Management BC (EMBC) have been in regular contact with the Mayor and senior staff since the fire.

CURRENT STATUS AND NEXT STEPS:

EMBC is the lead agency for emergency management, including recovery. The Interim Provincial Disaster Recovery Framework outlines four "sectors" for recovery. These sectors and their lead ministries are as follows: People and Communities (Health), Environment (FLNRORD), Infrastructure (MUNI), and Economy (FLNRORD). The infrastructure sector will also include municipal governance and related issues. Housing may be treated as an additional stand-alone sector for this initiative. Sector leads will be responsible for coordinating the engagement of other ministries and agencies in addition to undertaking sector specific work.

EMBC is currently working with the Village of Lytton to identify recovery needs with a focus on interim housing and re-entry requirements. Much of the focus of activity remains on support for



individuals and is being supported by organizations such as Team Rubicon and the Canadian Red Cross.

EMBC is drafting a recovery plan for provincial support of Lytton and has established a provincial team structured around the recovery sectors defined in the Interim Provincial Disaster Recovery Framework. FLNRORD is taking a lead role in supporting EMBC from a community transition perspective.

Currently, the ADMs of EMBC, FLNRORD, and MUNI are the main points of contact for the Village. The Village has also engaged the Fraser Basin Council (FBC) to provide recovery and rebuilding support on a contractual basis. The full scope of the FBC's role is still under development.

Municipal-specific issues identified, along with current activities/status, are as follows:

- Public Infrastructure BC Housing is proposing an interim housing solution for implementation s.13
- Governance A Ministerial Order to cancel the August 7th by-election was issued on July 30, 2021. MUNI staff continues to engage with Lytton's corporate consultant on processes for recreating bylaws destroyed in the fire (e.g., building, procedure bylaws, etc). Lytton hired Urban Systems last week as a communications consultant (early action includes updated social media, and daily information posts). Work also continues with Local Government Management Association and Union of BC Municipalities to establish and provide support for Lytton staff/mayor and council relations/communications. s.13; s.16

Various coordination activities are underway, both across ministries (e.g., EMBC's ADMs Recovery Committee) and internally (e.g., MUNI staff internal team to coordinate issues management and support for the Village in its recovery and rebuilding). This team is expected to transition to providing sector level coordination as work moves substantially into the recovery phases.

GBA+ OR DIVERSITY AND INCLUSION IMPLICATIONS:

Lytton is a small rural community, and it is believed that many residents are in a financial position that will make it challenging to withstand and recover from this catastrophic event.

What's your response?

Osborne: Thanks so much for the question. There's no doubt it's a really challenging time in Lytton right now. I haven't seen the letter yet, but I can assure you that staff from several different areas of the provincial government, including Municipal Affairs, are in close contact with the leadership in Lytton, working and listening closely to them to understand their needs and ensuring that they have all the supports in place that they need. Thanks for the question.

Reporter: Specifically, what kind of supports do you have in mind? They're saying that at the moment there's really nothing in terms of a fall plan and people are anxious to at least have some temporary housing. What specifically is your ministry doing to work for that goal?

Osborne: So our ministry, through Municipal Affairs, again, working with the leadership in Lytton to understand their needs and the supports that they need to have in place. There are number of different departments within the provincial government that will be working with them, including EMBC, for example, in the different phases of recovery from what's happened in Lytton. So while I can't give you those details today, I can tell you that we're working really closely with them to understand that and hoping to have more to say in the coming days and weeks. Thank you



Hi Okenge, further to the letter from the concerned citizens of Lytton, I wanted to give you more detail on the support that the Fraser Basin Council will be putting into place, funded by the Province. As you may be aware, the Village of Lytton has reached out to the Council for assistance in their recovery; that contact has been encouraged by the PO as well.

The Village and the Council put together an initial Statement of Work which was endorsed by the Mayor and Council this Thursday; that Statement of Work was very broad and included a significant number of activities related to both immediate and longer term recovery; many of those proposed activities are currently being addressed by other parties, including provincial ministries. That Statement of Work also very clearly stated that it was contingent on receiving funding from the Province or other outside sources.

I spoke to David Marshall of the Council this morning, and committed to funding an initial suite of work that is narrower than the broad Statement of Work, and that focused specifically on:

- Supporting the Village's digital infrastructure needs
- Facilitating the Partnership with the Lytton First Nation and the surrounding First Nations who had members residing in the Village
- · Engaging with the residents of Lytton, and establishing communication channels with the residents
- Assessing and cataloguing the existing parties already engaged in Lytton recovery, and the actions already underway
- Based on the above, proposing a revised longer-term Statement of Work for the Council, that would be embedded in a multi-party agreement

David Marshall will be getting back to the Village with this proposal immediately.

If the Village agrees to this course of action, we are prepared to provide the funding asap. I suggest this will address the immediate concerns raised.

Thank you for your letter dated July 30, 2021, regarding the June 30, 2021 fire in the Village of Lytton and subsequent communication from Village Council to residents over the past month.

First, I would like to extend my condolences for the tragic loss of life and my sympathies to you and others in the community who have suffered devastating personal and financial losses as a result of the fire. This is a very difficult and frustrating time for many Village residents as well as Indigenous communities in the area, and I very much appreciate the concerns you have expressed around communication with residents during this stage of the response and recovery efforts.

I strongly assure you that the Province of British Columbia is very engaged with the Village and Lytton area First Nations on a co-ordinated response to this unprecedented disaster. Provincial and federal government staff, including the Ministry of Municipal Affairs and Emergency Management British Columbia (EMBC) are supporting the Village Council as they face the challenges of governing and planning for rebuilding Lytton following this catastrophic event. Communication can be a challenge for any order of government during and following a disaster event. I know you, and many others, appreciate the magnitude of the task facing Council and Village staff—having also suffered personal losses—and that they are working to find effective ways to continue decision-making and communication during this very challenging time.

In terms of specific support being provided to the Village, I have been in contact with the Mayor to offer support, and my staff have been actively engaged with Lytton staff. For example, the Assistant Deputy Minister of the Local Government Division, Tara Faganello, attended the Council meeting on July 28, 2021 to reinforce the importance of good governance priority setting and recognition that the rebuilding will take a significant period of time. She, and other members of my staff, will continue to liaise with and support Lytton staff.

Recognizing the need for additional support, EMBC is also working directly with Council and Village staff to bring in a team of experts from the Fraser Basin Council with a work program that seeks to develop a communications and engagement plan; understand and assess the activities currently being undertaken or planned respecting recovery work; recommend key collaborative actions between the Village, the Lytton First Nation and the provincial government; and create a workplan that includes key principles, roles and timelines in developing a long-term recovery plan.

Disasters require both immediate response and longer-term recovery. These phases are described further below. Although my colleagues at EMBC are the lead co-ordinating agency for the provincial part of the emergency response effort across all provincial agencies, including BC Housing, and with expert outside parties and the federal government, I can provide the following information on behalf of EMBC.

Activities that follow an emergency or disaster are broadly grouped into the categories of "response" and "recovery." Below, I provide an explanation of each, the different stages they include, and information about each that is specific to Lytton. "Response" refers to actions taken to an imminent or occurring emergency or disaster to manage its consequences. At this stage, the focus is on minimizing personal, mental, cultural, and spiritual suffering, and reducing personal injury and property damage.

"Recovery" refers to the actions taken to:

- repair communities affected by a disaster;
- restore conditions to an acceptable level or, when possible, improve them;
- and restore self-sufficiency and increase resilience in individuals, families, organizations, and communities.

Recovery consists of short-term, medium-term, and long-term stages. The timing of the transition between these stages will vary depending on the circumstances. Short-term activities begin as soon as possible following a disaster, generally after life-saving actions are complete. Recovery is community-led, complex, and can take years to complete. It requires a collaborative effort from many partners to build resilience.

Recovery activities are initiated as quickly as possible, generally after risk to life-safety is reduced and life-saving activities, such as search and rescue, are nearing completion. In some cases, recovery activities may be conducted at the same time as response activities.

In Lytton's case, response is still ongoing and is focused on emergency support services as well as preparing for safe citizen re-entry to the community. Because of ongoing safety concerns due to potential health and environmental hazards, it will take time for re-entry and for the transition to active recovery will take time. As timelines become clearer, they will be communicated by the Village.

As Lytton transitions to the recovery phase, there will be even more emphasis on planning for the future and rebuilding. It is my understanding that the Village would like to explore rebuilding as a FireSmart, "net zero" carbon emission community. This is a noble goal in light of disaster risk reduction and climate change. It will take some time and will need to incorporate community engagement around the vision for the community. EMBC and BC Housing are exploring interim housing options that will serve the needs of citizens as this longer-term vision is planned and implemented by the Village. I expect the Village will also work to resume essential services and amenities once interim housing is in place.

The province will continue to work with the Village to identify short, medium and long-term recovery objectives based on community needs and assist in identifying funding sources and programs to meet these objectives, as well as the necessary expertise to expedite their delivery.

Council released a <u>Frequently Asked Questions</u> document on August 6, 2021, that contained information about site access, access to property, insurance adjustors, Team Rubicon's work, return to home and supports in place for residents. I also understand that the Village is working to update their website and social media pages daily.
