Good afternoon,

On behalf of my UDI colleagues, please see below for UDI's policy and advocacy updates for Monday, December 10, 2018.

As noted below, we are awaiting the release of the final report and recommendations from the Provincial Rental Housing Task Force. We expect Task Force's report to be released in the coming days and we will provide an update to stakeholders once we have an opportunity to review the recommendations.

ICYMI, UDI recently released a survey of 30 rental builders that found that 12,631 rental homes which are currently planned for communities across B.C., will be at significant risk if further restrictive rental policies are imposed. This number represents nearly two-thirds of the 19,972 rental homes that respondents reported are currently in development. Home builders warned against the introduction of more prohibitive rent controls, including specifically "vacancy control," in which the rent on a unit is strictly regulated by government. Dear Jean Swanson:

Your email to the Minister of Municipal Affairs and Housing has been shared with me. As a provincial election has been called, I am pleased to respond on behalf of the Minister, and I apologize for the delay.

Due to the provincial election, the Minister is unable to respond to your concerns about vacancy control in Vancouver's single-room occupancy (SRO) hotels. However, I can provide some information about the Ministry of Municipal Affairs and Housing's work to support vulnerably housed people in Vancouver.

As you will be aware, the ministry and the City of Vancouver are partnering to expedite the development of 98 temporary modular supportive homes at 1580 Vernon Drive, while also working together to build 350 new units of permanent supportive housing throughout the city. This investment builds on the more than 780 supportive homes that the provincial government has opened over the past two years in partnership with the City of Vancouver, non-profit organizations, and Vancouver Coastal Health.

Throughout the COVID-19 pandemic, the ministry has also been working to acquire hotels and motels, including SRO hotels, to use as permanent housing sites. The recent purchase of the American hotel in the Downtown Eastside, for example, will provide 42 units of affordable housing for people who have been living in supportive housing and want to take the next step toward independent living.

Thank you for your continued advocacy for vulnerably housed people in Vancouver. I assure you that once the election period is complete, and the incoming government has appointed its Cabinet, your correspondence will be shared with the incoming Minister responsible for consideration.

Just wanted to share this.

This work came out of the task force the Mayor setup last March. Already bearing fruit. Next batch of changes coming in September.

Also, in early July we will be voting on a framework for staff to work from as they deal with non-conforming development proposals. For housing there are about 65 that are unable to move and thousands of rental (market/non-market) and social housing units stranded there. Of course, not all of these projects will advance necessarily but they will get their chance to move forward.

Thank you for your telephone call to my office regarding rent controls and your concerns about homelessness in Vancouver's Downtown Eastside. I apologize for the delay in responding.

The Government of British Columbia shares your concerns about the potential loss of single room occupancy (SRO) buildings, and the effects this could have on low-income renters. The Province recognizes that SROs form a critical part of British Columbia's low-income housing stock, and that, for many people, SROs are considered a last resort before homelessness.

The Province has supported people living in SRO housing by purchasing and renovating buildings and tendering long-term contracts with non-profit operators. We have also worked to help people experiencing homelessness by building new supportive housing, and through cross-ministry work at the Office of Homelessness Coordination. In just over two years, government has built over 2,000 supportive housing units, providing safe, secure housing and supports for people experiencing homelessness across the province. In Vancouver alone, we have opened more than 720 supportive homes in the last two years, with more under construction, while also investing in thousands of affordable rental homes for a wide range of incomes, including a significant number of shelter-rate units.

You will also likely be aware that the Residential Tenancy Branch has issued a new policy guideline (<https://www2.gov.bc.ca/assets/gov/housing-and-tenancy/residential-tenancies/policy-guidelines/gl2b.pdf>) on ending a tenancy to demolish, renovate, or convert a rental unit to a permitted use, which would apply to all landlords who operate market housing. This guideline states that landlords must have all the necessary permits and approvals required by law before issuing a notice to end tenancy for demolition, renovation, or conversion. It also clarifies the tenant's right of first refusal, as well as the significant penalties for landlords who carry out bad faith evictions.

I also appreciate your suggestion about rent control being tied to the unit, not the renter. As you are aware, the Rental Housing Task Force heard from many renters and renter advocates during their province-wide consultation sessions in 2018 who expressed similar concerns. Ultimately, the Task Force determined that rent control tied to the unit would have the unintended consequence of reducing affordable rental stock or reducing investment in needed repairs. Government accepted the Task Force recommendation to maintain rent tied to the renter, not the unit, while lowering the annual allowable rent increase.

The Province understands the need to protect renters, especially those who are the most vulnerable in our society. That is why government has taken significant actions to protect renters, including limiting the annual allowable rent increase to the rate of inflation, closing the fixed-term lease loophole, increasing fines for bad-faith evictions, and increasing enforcement of tenancy laws.

The Province has also taken action to provide additional housing supports to British Columbians at risk of or experiencing homelessness. In fall 2017, government launched the successful Rapid Response to Homelessness Program (<https://www.bchousing.org/projects-partners/Building-BC/RRH-program>) by investing \$291 million to build over 2,000 modular supportive housing units across the province that offer a variety of health-related care and counselling services to assist those with such needs. Building on the success of this program, our Homes for BC plan includes funding for an additional 2,700 units of supportive housing, for a total of 4,700 homes with supports over 10 years. More than 2,000 of these homes are open today, providing a safe and supportive environment for people previously experiencing homelessness, with an additional 800 currently underway.

I appreciate hearing your perspective on these issues, and I will ensure that your concerns are considered as government continues its work to address homelessness and housing affordability.

Thanks for your email. As you suggested, I have outlined below a written summary of Councillor Swanson's concerns:

Re: Vacancy control in SRO hotels in Vancouver

ISSUE: I'm writing to plead with you to enact vacancy control in Vancouver's SRO hotels or to give the city the charter power to do it. The City of Vancouver has been asking for this since 2014.

SRO's are raising rents when tenants leave, reducing the number of units for very low income people: I have heard you talking about how wonderful the modular housing works for people who are homeless. I agree. The problem is, unless we get vacancy control in the SROs, the SROs keep being sold and gentrified and the low rents double and triple as soon as a tenant leaves, is evicted or bought out. For every SRO that this happens to, your government needs to build another modular building or, because the SRO's are the last stop before homelessness, more people become homeless. Several landlords actually have a business model of acquiring the hotels, getting rid of low rent paying tenants, and doubling or tripling the rent for new tenants. This is happening in many SRO hotels and has been well documented by the City and the Carnegie Community Action Project.

SRO vacancy control could make it easier for the government to acquire SROs: SRO hotels are actually advertised for sale on the basis that they are "micro-units" and that rents can easily be raised. Because of this, the value of the hotel increases. With vacancy control in SROs, this value would decrease, and it would be less expensive for the province to buy them to keep them in the public realm, improve management and prevent homelessness.

SRO vacancy control is a cheap way for your government to prevent homelessness from increasing: Right now the Arno, Arlington, Keefer Cabins, Vogue, Brandiz, and Persepolis, are some of the hotels that are in the process of raising rents so that people on welfare and disability won't be able to afford them. Vacancy control would also be the cheapest way your government could preserve this housing for low income folks until we get enough good social housing. Vacancy control is simply a law, and doesn't involve having to buy land, and build and operate buildings. Your government can spend hundreds of millions on hotels and modular (which is good, keep doing it), but homelessness won't be reduced because we are losing affordability in so many SROs. This would be an easy and cheap way to stop some of the increase in homelessness that everyone in the city is experiencing, especially the folks who have no home.

Implementing SRO vacancy control would be relatively easy: The city actually has a list of all the SROs so it would be easy to determine which ones the vacancy control would apply to. We could simply take a picture of the rent roll every year with the business license application. If we publicize that rents can't increase in between tenants, then tenants would probably be more than happy to help enforce a vacancy control law.

We are at our wits end about homelessness: City councilors are being bombarded by people who are homeless, their supporters, and by Business Improvement Associations and housed people who want more policing and more housing to deal with homelessness. Homeless people have about half the life expectancy as other people, and we and they are in the middle of a pandemic and need housing more than ever. As a city we don't have the tools to deal with this. As the province, you do have the tools. Vacancy control is one of those tools that would help a lot. Please let me know what you think of this reasoning. I would be happy to take you or someone from your staff on a tour of the gentrifying hotels to see first hand what is happening. Take care. Jean
