Background

 The Climate Action Secretariat (CAS), through its Climate Investment Branch, purchases and retires carbon offsets on behalf of all BC public service organizations to meet their legislated carbon neutral commitment.

CLIFF: 291596

- To add rigour and transparency to offset transactions, offsets purchased are registered and listed by the Province on a publicly accessible third-party environmental registry.
- Presently, the Markit Environmental Registry is the third-party provider of carbon offset registry services to the Province.
- The Markit Environmental Registry was originally publicly selected by the former provincial Crown Corporation, Pacific Carbon Trust, through Notice of Intent #PCT 2392, dated May 13, 2011.
- The contract was transferred to the Ministry of Environment on July 1, 2014 to coincide with the transition of the Pacific Carbon Trust to the Ministry of Environment.

Change in Legislation

- The legislative authority to issue carbon offsets will change from the *Greenhouse Gas Reduction Targets Act* (GGRTA) to the *Greenhouse Gas Industrial Reporting and Control Act* (GGIRCA) as of December 31 2015.
- Through regulation, GGIRCA will require the registry to offer different functionality.
- Given the short timeframes until GGIRCA will be in force, the Climate Action Secretariat decided to continue using the Markit Environmental Registry as the interim registry solution.
- The Climate Action Secretariat, through the Corporate Services for the Natural Resource Sector Information Management Branch, posted a public Notice of Intent (NOI #IMB20234) on August 27, 2015 to inform the market the Province intends to contract with Markit as an interim registry solution for two years for no more than \$360,000.
- The Canadian Standards Association (CSA) contested this NOI.
- Staff discussed CSA's objection with CSA and explained the process under way to run a
 competitive process, and the need for an interim solution. Staff are developing a Request
 for Information as a first step this winter.
