I'm an Environmental Coordinator at the City of Abbotsford. One of our Works Inspectors was on site at s.22 where the property owners have removed vegetation (trees and shrubs) adjacent to a watercourse that is part of the Page Creek system. They have also dug a large channel connected to this watercourse (essentially lengthening the channel). A large portion of the channel now has exposed dirt along the banks. The property owners have also dumped a lot of fill that is a mix of soil and construction debris. The City Works Inspector is working with the property owner to remove the material and re-stabilize the site but we have no legal capability to request the owner to re-vegetate given this is ALR.



They typically operate on a seasonal basis between June to September/October. However, their lift station pumps were not maintained after last season so they are currently unable to discharge large amounts of wastewater to the sanitary sewer. Instead, we understand that all process wastewater is currently being discharged to the Fraser River. This business apparently has a permit to allow them to discharge to the river, but they have to meet the discharge limit of 45 mg/L for BOD and TSS. Historical data from 2014 shows that their average BOD and TSS in their wastewater discharged to the sanitary sewer was 763 mg/L and 307 mg/L respectively for July. This business is currently in full operations! Our concern is that they are discharging wastewater to the river that is above their permit level. We felt that we (the City of Abbotsford and the District of Mission) had a responsibility to report this potential act of pollution.
