On Saturday, March 07, 2015 I was hunting snow geese s.15,s.22 s.15.s.22 when I saw someone throwing geese into the river s.15.s.22 It was somewhere between 7:00 and 8:00 a.m. I watched as a truck pulled up to the dyke from which no one got out for a while. The truck was a full size \$.22 s.22 It had a canopy with roof racks and a hunting blind was tied to the racks. Then the driver backed up to a flood box area and got out of the vehicle. When the driver got out I observed a s.22 s.22 I recognized him as Dale Vidulich. He let out two labs one black and one yellow. He then took Canada geese from the back of his truck and began to throw them into the river.
