2017-05-30 1633 hrs, CO HAMLYN receives the first of many HWCR's regarding possibly abandoned cubs at this location. CO HAMLYN contacted the COM - COM stated that two very small cubs are at the location and no sow is in sight. The cubs are close to the road and the COM is worried they will be hit. CO HAMLYN advised the COM to leave the cubs alone - not to approach or feed them and CO's will come to the location and access. (CH) 1645 hrs - update # 1 received. CO HAMLYN calls COM and advised the COM to leave the cubs alone - not to approach or feed them and CO's will come to the location and access. (CH) 1653 hrs - CO HAMLYN receives HWCR 17-4324 (regarding the same cubs). CO HAMLYN called the COM and left a VM. (CH) 1700 hrs, CO HAMLYN and HARRIS 10-23. Two "football sized" COY present at the site. One vehicle present - CO HAMLYN explained to the vehicle that the more people who hang around the scene the less likely the sow will return. CO HAMLYN also explained that it is normal for sows to leave their young alone for several hours or even 24-36 hours while they take care of business that the cubs are not able to do yet. The driver of the vehicle stated that she understood and left the area. CO's observed the cubs for approx. 30 mins. Cubs moved into the bushes and CO's departed. Cubs seemed to be staying around the 50 km/hr sign close to the road. One cub appeared lethargic and skinnier than the other. (CH) 1750 hrs, CO HAMLYN returned to the site and the cubs were back on the road. CO HAMLYN chased the cubs into the bush. One of the cubs ran away immediately and climbed a tree. The smaller lethargic cub took a few steps and laid on the ground. CO HAMLYN eventually made the cub move into the bush as well. CO HAMLYN looked around the immediate area - no sign of the sow. (CH)

2017-05-31 0900 hrs, CO HAMLYN receives update #2 that the cubs are still present. CO HAMNLYN attends the scene and observed the same cubs in the same location - still no sow present. Two vehicles are also on scene - One truck and one van. CO HAMLYN spoke to the occupants of the van who stated that they are worried for the cubs. CO HAMLYN explained that the cubs are being monitored and we are giving the sow time to return. CO HAMLYN explained that is is normal behaviour and that if the sow is still alive she picked a poor location to leave her cubs. The occupants of the van then stated to CO HAMLYN that they fed one of the cubs chocolate because it looked hungery. CO HAMLYN told the occupants that is the worst thing that they could have done. The van then took off. (CH)

0939 hrs, CO HAMLYN sent an email to Chris ADDISON (regional wildlife manager), Mike BRIDGER (wildlife biologist) and Sgt. Shawn BRINSKY advising of the cubs and requesting guidance. (CH) 0942 hrs, CO HAMLYN called ADDISON and explained the situation - ADDISON stated that he would meet with his team and come up with a course of action. (CH) 0956 hrs, CO's depart scene 1200 hrs, CO's return to the location - smaller lethargic cub is laying on the shoulder of the road. CO HARRIS approached the cub and it lifted its head and then laid it back on the ground. CO HAMLYN sent an email to ADDISON, BRIDGER and BRINSKY stating that CO HAMLYN has decided to dispatch the smaller cub as it is not doing very well, but will wait for direction on what to do with the second healthier looking cub. (CH) 1400 hrs, Sgt. BRINSKY calls CO HAMLYN and informs CO HAMYLN that SGT BRINSKY met with Director ADDISON, Biologist BRIDGER, and Insp Struthers explains the outcome of the meeting. Both cubs are skinny, have possibly been handled by people and were possibly fed by people. Also in consideration i the fact that the cubs have been likely orphaned for over 36 hours, dehydrated, malnourished and will have many more hours of such even if rehabilitation was an viable option. Location of Fort creates even greater challenges. CO's advised to catch and euthanize both cubs. (CH)

1450 hrs, CO's attend scene and easily catch the smaller cub and place it in a dog crate. CO's search the area for the second cub and find a dead sow approximately 30 meters in the bush laying with its belly exposed. Judging by the smell, hair slippage and insects the sow has been dead for at least 3-4 days - taking the 30 degree weather into consideration. CO's find the second cub approx. 20 meters up a tree close to the sow carcass. CO HAMLYN dispatches the cub in the tree with .22 cal rifle. CO HAMLYN utilized the tree truck as a back drop and fired towards the forest where no residences are. CO HAMLYN struck the cub under the chin - no exit wound.
