Corporate Transition Briefing Note

Prepared in Response to 2017 Confidence and Supply Agreement between the BC Green Caucus and the BC New Democrat Caucus

Issue: Address failures in the professional reliance model in BC so that British Columbians' faith in resource development can be restored (pg. 6, S3, 2l).

Ministry: Environment and Forests, Lands and Natural Resource Operations

Background Information:

Professional reliance (PR) is the specific requirement to use a qualified professional (QP), meaning the use of a person registered with a legally established self-governing body that holds members accountable to known work standards and independently responsible for their actions. Use of QPs is a long standing practice within a number of statutes including Forest and Range Practices Act, Environmental Management Act, Land Act and Water Sustainability Act. The primary benefits of the PR model are: the shifting of costs from the taxpayer onto project proponents, the ability to require specific expertise that government staff may not have, and faster and more durable decisions.

Currently, 27 natural resource sector (NRS) regulatory regimes rely on QPs to provide information to government decision-makers and in certain situations QPs are delegated the authority and associated responsibilities to make statutory decisions on government's behalf.

Since 2013, the Environmental Appeal Board, Forest Practices Board, Office of the Auditor General and Office of the Ombudsperson have investigated how well the PR model provides independent, objective advice to government regulators. While acknowledging the overall value of the PR model these investigations highlight the need for adequate oversight of QPs both by government and licensing and regulatory bodies. Specific concerns include inadequate work (competency), need for improved guidance, and better follow-up and monitoring (accountability).

Since 2013, government has actioned many of the recommendations from these investigations. For example, the government recently completed an audit looking specifically at the use of QPs in BC's mining and municipal wastewater sectors in order to determine if they are in compliance with current regulatory requirements. There are other examples of changes government has implemented to the use of professional reliance in the forestry sector related to monitoring, guidance, and how to further leverage the model in response to issues identified. Recently, government has requested licensing and regulatory bodies to look into actions of their members (e.g. the Province contacted APEGBC regarding Active Earth's undisclosed financial interests in the South Island Aggregates contaminated soil facility which has resulted in the current investigation).

ISSUE:

Determining the extent to which:

- 1. A public sector organization collectively understands the concept of "knowledgeable owner" (KO); and,
- 2. An public sector organization may wish to formally recognize/promote the concept and actively pursue being a KO in its critical business areas.

BACKGROUND:

The Corporate Human Resource Plan of the Provincial Government cites several significant workforce challenges facing the public service – i.e., by 2015 it is projected that 45% of managers and 35% of bargaining unit staff will retire. Further, by 2011, exits from the provincial workforce will outnumber entrants. The goals of the Corporate Human Resource Plan include building internal capacity, improving competitiveness, and managing for results. Specific strategies focus on limiting the use of external consultants in order to create meaningful training and promotional opportunities for staff; expediting learning and knowledge transfer through job shadowing; and, creating greater awareness within ministries of particular job skills and areas of expertise recognized to be at risk due to anticipated attrition.

All ministries are expected to "develop and maintain specific internal expertise in key streams." ¹ This relates to the concept of ministries each being a "knowledgeable owner" (KO) in their business areas. Meeting this expectation will be challenging due to the implications of several events and trends over recent years, including but not limited to:

- workforce changes resulting from two rounds of "voluntary departures" from government, the increasing rate of "baby boomer" retirements, and intergenerational differences between the career expectations of "boomers" and those in Generations "X" and "Y"; and,
- implications of the 2002 Core Review, which resulted in many changes to what government focuses on and how it conducts its business.

DISCUSSION:

The most straightforward way to explain the concept of "Knowledgeable Owner" is this – Mike Holmes' award winning home renovation disaster show "Holmes on Homes" would not be on television but for the tendency of well-intentioned, but uninformed, homeowners to entrust their cash and greatest asset (their home) to "professional" contractors on whom they blindly rely. In this admittedly simplistic example, Mike Holmes has made it his career to find and fix inadequate work in the home construction and renovation industry. He explains his mission is to prevent or expose inadequate work and help homeowners make informed decisions. He can only do this as he is a qualified, skilled, and experienced knowledgeable owner in all areas of building construction and renovation. Based on his training, skill level, experience and expertise he is qualified to review and expertly assess the work of his "professional peers", and to know when to bring in other qualified professionals to assist him.

The KO concept is explored here in detail, *using the Ministry of Forests and Range (MFR) as an example.* Since its establishment in 1912 as the Forests Branch, MFR has been the main agency responsible for the stewardship of 47 million hectares of provincial forest land and fire protection services for 84 million hectares. The ministry's role also includes maintaining a policy and regulatory framework that creates competitive forest and range industries. Being a knowledgeable owner is important for MFR in all its core program areas such as Silviculture, Inventory, Research, Tenure Administration, Protection, Compliance & Enforcement etc. *Although the concept of KO is highly relevant and applicable throughout MFR in all its critical business areas, the ministry's Engineering Program is used here simply as an illustrative example.*

MFR Engineering Program History

As an integral function of the ministry, engineering has had a long and successful history of contributing to the achievement of Forest Service goals and objectives. In the early 1950s, the Engineering Program had "own forces" capability – i.e., its own heavy equipment and engineering crews for capital-intensive forest road and bridge construction. The in-house capability of the BC Forest Service at that time was often praised for its professionalism, effectiveness (i.e., what we now refer to as "knowledgeable owner"), and for its esprit de corps. Internal expertise was readily available to ensure appropriate engineering design solutions were developed, as well as the knowledge needed to assess competitive bids on contracted work. During this period, Forest Rangers in the districts interacted with the public as the ministry's expert, the local authority and manager in-charge.

In the 1980s, the Engineering Program lost its Branch status with government decentralization and the advent of Section 88 (which gave all responsibility for road and bridge building to forest companies for their forest development operations). This is when the Forest Service began a process of shifting its engineering program focus away from the physical activities associated with FS road and bridge planning, construction, maintenance and deactivation, toward an oversight and contract management role. In 2002 came the Core Review, and a move away from a prescriptive Code of Forest Practices to results-based legislation, giving even more responsibility to forest companies and professionals. With these shifts, and despite ever greater reliance being placed on Forest Service professionals and technologists to ensure that sound forest engineering practices are carried out to protect the environment and public safety, the districts' function has been reduced to primarily a monitoring role.

For a period of time, this new focus offered substantial cost savings to government as the ministry was able to substantially reduce its workforce and sell its construction equipment and materials inventory. It no longer needed to bear the costs associated with owning/maintaining heavy equipment and paying the annual salary of equipment operators, survey and design crews, and support staff. Instead, MFR was able to hire the necessary manpower and equipment on an as-needed contract basis. The remaining technical and professional engineering staff, who possessed proven knowledge, expertise and technical competency in all phases of road and bridge construction, became contract managers and project advisors. Over the next several years, due to their technical proficiency and expertise, they were able to assure MFR managers, financial auditors, politicians and the public that MFR was receiving

appropriate value for money, and that the ministry was not assuming inordinate risk to human life or the environment through its engineering activities (or lack thereof).

Current Situation

However, over the ensuing years, many of those experienced, skilled staff moved away from engineering and into other MFR management positions, and/or have retired. The issue now facing MFR is that, more often than not, staff promoted or hired to replace those technical experts do not and will not have nearly the same "hands on" learning opportunities as their predecessors had in the past. As a result, MFR is at risk of not receiving the same value for money via the contracting out process, and/or may be assuming a much greater risk to human life or the environment through the ministry's current engineering activities. Any staff lacking the appropriate competencies and experience may not have enough knowledge/expertise to assess risk or value for money or, even worse, they may not know when, where, and how to request appropriate help or secure the appropriate expertise (i.e., simply expressed, they don't know what they don't know).

A few illustrative examples of areas of concern/risk in forest sector engineering due to not being a KO include:

- To ensure value for money, professionals² require the knowledge, including practical skills and experience, to carry out/review Engineering Cost Estimates (ECEs), including knowledge of heavy equipment productivity, and appropriateness of bridge construction techniques/design etc.
- Concerns regarding "project durability" and being confident that the most practical and effective design prescription is adapted from the outset.
- MFR unknowingly incurring unacceptable environmental, legal, and professional risk through adoption of an incorrect planning, design/construction solution, legislative regime, business practice, or via actions of their contractors.
- Professionals² not having the required knowledge, including practical skills and experience, to comprehend their own, or others', professional limitations.

The issue of professional reliance and professional responsibility, as related to all forestry professionals and occupational health and safety in the BC forest industry, was the subject of a presentation made at MFR's 2008 Provincial Engineering Meeting by Jeff Waatainen, Barrister and Solicitor with Westhaven Forestry Law. Key points from this presentation included:

- A "professional" has specialized education, knowledge, training and experience.
- A "professional" possesses specialized knowledge that is unknown to the average person.
- Through legislation, society recognizes various groups of persons who possess specialized knowledge, and bestows "professional status" upon them.

² Note: "professionals" includes Professional Engineers, P. Eng, *and* professional Engineering/Forest Technologists.

- In exchange for their agreement to exercise their knowledge and expertise responsibly, i.e., in accordance with the public good – the public grants special authority upon professionals within their field of knowledge and expertise.
- The public then presumes professional ability and responsibility respecting these professionals, i.e., they presume they can rely on them ("professional reliance").
- Society as a whole is reliant upon professionals to ensure that complex projects are undertaken in accordance with approved plans and regulatory requirements.
- Both the planning and implementing of complex endeavours require professional expertise.

In the context of "practice of engineering and engineering technology," the key principles for MFR to be a knowledgeable owner were outlined in a document entitled "The Expectations that Affect the Management of Public Forest and Range Lands in British Columbia: Looking Outside the Legislation (Reader, 2006).

In this work, Mme. Reader noted that: "In the forest and range management context, it is important to remember that **professional reliance does not mean "blind reliance."** [emphasis added]. Reliance on resource management professionals is justified only if these professionals have demonstrated that their advice is reliable." (p. 221).

This means that an "owner" (e.g., MFR Engineering Program staff) cannot assume the advice it receives is adequate, acceptable and can be relied upon by virtue of being provided by a professional. As a professional's work can only truly be scrutinized by a peer professional, it follows that an owner has to have a requisite level of expertise inhouse to provide that professional evaluation. As much as professional reliance depends on knowledgeable and experienced people to provide advice, it also requires that owner must be knowledgeable to know when the advice is appropriate.

Therefore, for the Ministry of Forests & Range to be a knowledgeable owner in terms of engineering and engineering services, it must:

- understand what constitutes the "practice of engineering" and "practice of engineering technology" and the critical linkage to operational practices;
- be capable of internal implementation of engineering practice with competent understanding of "practice of engineering" and "practice of engineering technology" through the project conceptualization/construction continuum;
- be aware of the limitations inherent in applying engineering judgment that is fully within the context of "the practice of engineering" and "practice of engineering technology";
- be familiar with the liabilities and risks associated with its road network (e.g. industrial user and public safety, environmental, financial, etc.);
- be aware of need for continual professional training to maintain professional competence and value of succession development (e.g. EIT program and mentoring to develop internal capacity and carry on the cultural strengths of our organization);
- be aware of the necessity to undertake research and development in applied science (engineering) to provide the necessary support to engineering decision making when current applicable understanding is unavailable or unsuitable;

- be aware when to seek specialist advice, know what specialist is required and their requisite qualifications, know what to ask for, know how to contract such expertise, and be able to evaluate the delivered product;
- be fully knowledgeable and conversant in issues associated with risk analysis, risk assessment; risk control; and risk acceptability;
- be fully aware of value for money (funding constraints vs. engineering risk); and,
- be recognized as a "knowledgeable owner" by internal staff, stakeholders, clients, etc.

Mme. Reader's analysis and recommendations to MFR are further supported by the work in this area undertaken by the Ministry of Transportation (MOT). MOT is a predominantly engineering-oriented organization which has re-embraced the importance of being a knowledgeable owner through articulating a set of key principles outlined in the section below.

MOT's purpose in developing these principles was to ensure they meet their statutory requirements as an "owner." They committed themselves to applying engineering judgment and assessing acceptable risk, including strategically determining who does the work, by assessing the current value versus the future value (i.e., contractor vs. EIT – investment in the future), and to carrying on the cultural strengths of their organization.

To MOT, being a knowledgeable owner involves the ability and capacity to do the following:

- Apply engineering judgment.
- Apply business judgment.
- Understand the owner's interests over and above technical requirements including:
 - Value for money (available budget);
 - Risk tolerance;
 - Non technical considerations (community, economic, etc.); and,
 - Legislative requirements/protection non-delegable duties.
- Understand government administrative process.
- Attract and retain technical in-house expertise in core engineering program areas.
- Ensure linkage between engineering and operation of the highway system.
- Ensure engineering continuity through different phases of the project.
- Commit to research and development responsibility, being on the forefront of industry knowledge.

Many MFR Engineering Community of Practice members support the KO concept and believe MOT is on the appropriate track, and that MFR as a whole has not had the opportunity to understand, acknowledge and endorse the concept of knowledgeable owner. They believe this has serious implications for the entire ministry, let alone the future relevance of MFR's Engineering Program. There are many benefits to being a KO, including the ability to:

 Retain and attract employees to an organization that promotes being the best and offers desirable career paths and recognition;

- Determine the appropriate solution for projects in the short and long term, adequately considering risk, safety and economics (value for money);
- Solicit, understand and validate appropriate expertise (internal and external); and,
- Become a high performing organization that is respected by clients, colleagues, and partners.

NEXT STEPS

Should an organization choose to formally adopt and actively pursue a "Knowledgeable Owner" culture, potential next steps would be to undertake the following:

- Brief your leadership on the KO concept and seek leadership endorsement to pursue the following steps:
- Assign a "KO Sponsor" to champion and lead the formation of a steering committee and task team(s) with appropriate cross-program representation to pursue the following activities (to be laid out in a Terms of Reference);
- Develop KO definitions for each key business area (e.g., see page 4 KO definition for an Engineering example);
- Investigate and assess the current state respecting program staff expertise and experience (i.e., knowledgeable ownership and technical competencies) in the organization's key business areas;
- Target key business areas identified as "at risk" and determine to what extent those risks exist, and design/implement appropriate KO mitigation;
- Develop recommended plans of action to ensure staff have the requisite knowledge, skills and abilities (KSA) to meet required competencies (technical and behavioural) of their position, and to actively support ongoing learning, development and KSA training;
- Investigate and identify short, medium and longer term opportunities to carry out selected projects in key business areas with the organization's own staff (as opposed to contracted resources) in order to build required in-house expertise and competencies via hands-on experience; and,
- Develop appropriate KO performance measures to be embedded into personnel performance plans and the organization's business plan.

Introduction

District managers for the Ministry of Forests, Lands and Natural Resource Operations (FLNR) are the government decision-makers who are "closest to the ground." These are the government officials who review and approve resource development on public land.

In recent years, the Forest Practices Board has seen situations arise where forestry development was putting local environmental and community values at risk, yet district managers could do little to affect the development and protect the public interest. The Board has also encountered situations where conflicts between resource-users could have been avoided if district managers had the authority to intervene to ensure operations would meet local management objectives and respect tenured interests.

These situations have led the Board to conclude that there is a need for district managers to have authority over operational decision-making by giving them conditional discretion over the issuance of cutting permits and road permits. This discretion, which district managers currently do not have, would only be used in specific and limited circumstances. It would strengthen the district manager's role in safeguarding the public interest when dealing with matters such as logging on steep slopes, cumulative effects management, visual quality, conservation of species at risk or conflicts between tenure holders.

In an increasingly complex economic and ecological operating environment, district managers will need this authority in the future to ensure that decisions consider landscape-level conditions, including cumulative effects.

This special report is intended to draw attention to an important issue identified by the Board, to encourage discussion and to suggest a possible solution. The report is based on previously published Board reports, supplemented by interviews with district managers.

Background

British Columbia's forest practices legislation—the Forest and Range Practices Act (FRPA)—is designed to give forest licensees flexibility to manage, within a framework of government objectives and results-based practice requirements. Government has established objectives for a variety of forest values such as ungulate winter range and old growth. These objectives place restrictions on logging in certain locations, but licensees are free to operate elsewhere, as long as they comply with FRPA and the Forest Planning and Practices Regulation. It is licensees and their professionals who make the final decisions about how to balance resource values and minimize risks.¹

If a problem occurs, government officials are restricted to dealing with it after the fact, yet situations can arise at the operational level where it is essential to be able to prevent problems before they occur, rather than respond after they have occurred. An ability for government officials to intervene in some circumstances is consistent with results-based legislation, which cannot be expected to anticipate every contingency at an operational level.

The only planning document that requires approval by government officials is the forest stewardship plan. Yet these plans only set the legal parameters for practices broadly over vast areas. They do not

contain specific information about what licensees are planning to do. Within the current legislative framework, normally the first opportunity for government officials to see what and where logging and road-building are proposed is when licensees apply for a cutting permit or road permit. However, government officials have very limited authority to intervene at this stage to protect the public interest.

Forest licences and tree farm licences make it clear that, as long as certain simple administrative requirements have been met, district managers have no discretion to refuse to issue a cutting permit or road permit, even if they have significant concerns about the proposed activity.¹

In the Board's experience, the current system works reasonably well, most of the time. Licensees and their professionals, for the most part, are diligent when planning activities. District managers are often able to establish expectations and act as facilitators. In the course of preparing this report, we spoke with several district managers who confirmed this.

Nonetheless, there are situations where district managers need legal authority to back up their efforts. In the Board's observation, many members of the public are surprised to learn that district managers do not already have this authority. Wholesale change is not needed but incremental improvement is. This is part of full implementation of FRPA and will be increasingly necessary in the future.

Discussion

The Board has encountered numerous situations that illustrate the need for district managers to be able to intervene. These include situations of:

- significant risk to public health or safety;
- significant risk to forest resources or values this includes situations where there is a lack of coordination of activities among licensees operating on the same ground; and
- conflict between forest licensees and non-forestry tenured users, such as guide outfitters, ranchers and tourism operators.

Illustrations From Previous Board Work

In <u>Haida Gwaii Visual Quality Objectives</u>, for example, the Board investigated a complaint concerning visual quality and logging on Haida Gwaii. Even though FLNR staff and a municipality raised concerns about the likely visual impact of planned logging on Haida Gwaii, the licensee would not discuss its visual impact assessment and insisted on getting its cutting permit. The district manager had no choice but to issue the permit. The logging went ahead and the Board found that it did not meet the legally-required visual quality objective, contrary to FRPA. In spite of the valid concerns raised before harvesting took place, the district manager was required to issue the cutting permit as submitted. If he had the authority to delay issuing the permit, pending clarification of the concerns, it is likely that the problem could have been resolved through discussion among professionals.

¹ Administrative requirements include submission of appraisal information and a map. Where the district manager has concerns about the impact on aboriginal rights, the manager may impose conditions or refuse to issue a cutting permit.

In <u>Meadow Creek Cedar Ltd. Forest Practices and Government Enforcement</u>, a licensee decided not to implement plans, prescriptions and recommendations made by its professional foresters and professional engineers. This resulted in unsound forest practices that put forest resources at unnecessary risk. The Board report noted that the government is a trustee of public lands and needs to take action when harm (environmental or otherwise) may occur. Failure to do so undermines public confidence in FRPA. Again, if the district manager had the authority to withhold cutting permits or road permits, many of the problems might have been avoided. In acknowledging the government response to the Board's recommendations, the Board Chair stated the following:

... the Board is concerned that legislation and government policy does not afford a district manager sufficient ability to proactively address situations where an imminent risk to the environment or a forest resource is apparent ... government, as the trustee of public lands, needs to assess forest practices and be prepared to take action when harm to the environment or a forest resource is likely to occur, rather than as a reaction to an event.

Other examples from previous Board work are set out below. In these examples, if the district manager had been able to intervene, it is likely that public confidence would have been enhanced, risk to public safety or the environment would have been scrutinized by a government official, agreed plans or guidelines would have been followed, chief forester guidance would have been followed, or disputes between tenured users of Crown land could have been resolved more fairly.

- <u>Timber Harvesting and Potential Impacts to the Duhamel Creek Alluvial Fan</u> At Duhamel Creek, residents were concerned about the potential for a catastrophic landslide due to proposed logging. Although the Board concluded that the licensee had carried out appropriate assessments, the inability of the district manager to intervene weakened public confidence in the process at the time.
- <u>Laird Creek Landslide</u> At Laird Creek, residents were concerned about a proposal by the BCTS program to *log on steep slopes with a history of landslides*. A few years after the logging and road-building took place, a landslide occurred, disrupting the residents' drinking water supply for a week. The slide was caused by a change in subsurface drainage caused by road construction, combined with an unusually high snowpack and a rapid spring snowmelt. The Board report noted that, even with sound technical practices, risks taken by one resource user can harm another. Giving district managers the ability to intervene in cases of this nature would help to ensure that the public interest is being adequately addressed.
- Hydrologic Assessments Completed in the Tranquille Community Watershed Risks to public safety, private property and infrastructure were identified in a 2009 watershed risk analysis, making it important to assess the cumulative risks of proposed logging activities. Yet, as of May, 2013, the effects of proposed development were considered in isolation by each of several forest licensees operating in the drainage. Giving district managers the ability to be proactive and refuse a cutting permit or road permit would help to facilitate coordinated effort among licensees.

Forest Practices Board FPB/SR/52 3

 <u>Logging and Lakeshore Management near Vanderhoof</u> – A lack of process for dealing with conflict between a forest licensee and a group of wilderness resort businesses concerning logging in lakeshore management areas led to an erosion of trust. The Board report noted that:

FRPA gives considerable advantage to forest licensees which, unless there is generous goodwill, could lead to decisions unfavourable to the interests of other businesses. No legislation can avoid such inequity unless it is also set up to deal with conflict between the bona fide users of Crown land operating on the same landscape. FRPA contains no such mechanism.

- Goshawk Foraging Habitat on Haida Gwaii There was no mechanism to protect a newlydiscovered northern goshawk nest on Haida Gwaii, when a licensee applied for a cutting permit that would impact foraging habitat near the nest.ⁱⁱⁱ
- <u>Davidson Creek Access Management</u> There was no mechanism to implement an access
 management planiv when a licensed guide outfitter was concerned that a forest licensee was not
 seasonally-blocking motorized access to a road system. The guide outfitter feared losing a key
 business opportunity guiding hunters by horse in a non-motorized area. If the district
 manager had authority to refuse a cutting permit or road permit in such situations, negotiated
 access management plans could be given their intended effect.
- <u>Aspen Logging Grazing Conflict in the Dawson Creek TSA</u> There was no mechanism to
 implement guidelines when logging of aspen in the Dawson Creek area led to reduced
 opportunities for cattle grazing, due to dense regeneration. As with the previous example, if
 the district manager had authority to refuse a cutting permit or road permit in such situations,
 negotiated guidelines could be given their intended effect.
- <u>Timber Harvesting in Beetle-Affected Areas: Is it meeting government's expectations?</u> There was no mechanism to enforce the chief forester's partition of the allowable annual cut, limiting the amount of non-pine harvest. Individual licensees acted independently and their combined actions resulted in overcutting of non-pine, further threatening the future timber supply. Where there is a lack of coordination among licensees that could compromise government objectives, district managers need the authority to refuse a cutting permit or road permit.
- <u>Biodiversity Conservation during Salvage Logging in the Central Interior of BC</u> In areas of large-scale salvage of timber damaged by mountain pine beetle, there was no response to the chief forester's landscape-level guidance to conduct cooperative planning for biodiversity and the desired 'conservation uplift' was not achieved. As with the previous example, where there is a lack of coordination among licensees that could compromise government objectives, district managers need the authority to refuse a cutting permit or road permit.
- <u>Salvage Logging and Water Flows at Cooper Creek</u> A complaint investigation about salvage logging upstream from a ranch, found that a lack of coordination between forest licensees increased the likelihood of flooding on the ranch.
- <u>Pine Beetle Salvage Logging and Water Flows near Williams Lake, BC</u>; <u>Logging and Winter Streamflow in Twinflower Creek</u> Two reports about the cumulative effects of salvage logging, climate change and mountain pine beetle highlighted the Board's concern about

cumulative effects. The Board noted again the *inequity in the decision making authority of one* tenure holder over another and said that a system of objectives and regulation coupled with respectful, mediated solution-seeking would be more equitable for the people involved, and more effective for stewardship of the many tenured interests that the province has vested on the landscape.

One way to provide such a mediation mechanism would be through district managers, who would need the authority to refuse cutting permits or road permits. Mediation would only be applied in certain circumstances and must be time limited.

 <u>Eagle Creek Pine Salvage</u> – The impact of mine tailings and salvage harvesting left downstream water users at risk, but no single government agency was responsible for managing the combined effect.

These examples, in the Board's view, illustrate the need for improvements in the policy and regulatory framework.

Looking to the Future

It is important to look forward, as well, to the increasingly challenging environment for natural resource officials. As noted in the FLNR Service Plan (February 2015), the Ministry operates in a complex economic and ecological operating environment. The Service Plan notes the challenges of multiple interests and overlapping demands, along with the influence of factors such as habitat fragmentation, invasive species, climate change, wildfires, floods, landslides and debris flows, droughts, and pest outbreaks. Solidifying the integrated delivery of natural resource management through the one-land manager model and designing new approaches and tools to better manage the cumulative effects of multiple activities are identified as key ministry priorities.

One of the Ministry's strategies to achieve sustainable natural resource management through effective policy, legislation and external relationships is to:

Improve the ability to make durable decisions on the land base that consider landscape-level conditions, climate change, and cumulative effects on key environmental, social and economic values, including historic and archaeologically significant places.

In the Board's view, this can only be achieved by giving conditional discretion to district managers, as representatives of the public interest, to actually make decisions.

Possible Solutions

As the landowner (subject to First Nations interests) and the representative of the public interest in the management of Crown forest land, government needs to reserve to itself, in FRPA, the right to act when necessary to protect the public interest. In the Board's view, there is a gap in implementation of FRPA in that this has not yet been achieved. Of course, government officials will need to exercise caution and the authority to intervene should only be exercised under certain conditions and in clear cases where there is a pressing public interest.

Forest Practices Board FPB/SR/52 5

It is the Board's view that district managers need the authority to delay issuing—or refuse to issue—a cutting permit or road permit, where necessary. This authority would be triggered if the district manager believes:

- there is clearly significant risk to public health or safety;
- there is clearly significant risk to forest resources or values;
- there is likely to be a contravention of legislation; or
- the interests of another tenure holder have not been adequately addressed (if that tenure holder requests district manager intervention).

The necessary authority could possibly be granted under existing legislation, as discussed below, and should be seen as part of full implementation of the results-based legislative framework.

The Board recognizes the challenge of ensuring that district managers are only called on to invoke this authority in cases where it is truly needed. It should be possible, through regulation and policy, to make sure this is the case. The greatest benefit of such authority would be in strengthening the ability of district managers to actively facilitate discussion, cooperation and solutions to potential problems during the planning phase, before permits are issued.

BC Timber Sales (BCTS) Program

Consideration should also be given to providing district managers with authority in relation to the BCTS program, the operations of which give rise to similar concerns. Nineteen per cent of the provincial allowable annual cut is allocated to the BCTS program. In this program, harvesting is done under timber sale licences issued by timber sales managers. BCTS and its licensees do not need to obtain cutting permits in order to harvest timber, so the solution suggested above would not work for the BCTS program. However, it should be possible to put in place a policy framework to allow the district manager to intervene if needed, without the necessity of legislation.

Implementing Section 81.1 of the Forest Act

Section 81.1 of the *Forest Act* requires district managers to refuse to issue a cutting permit or road permit if the minister determines that the issuance "would compromise government objectives as specified by regulation." There is currently no regulation implementing section 81.1. A regulation could be introduced authorizing district managers to be proactive in the circumstances listed above. The regulation could, for example, specify that government objectives, for the purpose of the *Forest Act* section 81.1, include avoiding significant risk to public health or safety, avoiding significant risk to forest resources or values, preventing contravention of legislation and achieving fair resolution of disputes between tenure holders.

The Board is not suggesting a change in the routine process of issuing permits. Rather, the suggestion is that the district manager would have authority to intervene where necessary. The circumstances where this authority would be exercised should be defined in a general sense in regulations and guided by policy.

FRPA Section 77

In addition, it would be desirable to expand the reach of intervention orders under FRPA section 77 and the *Administrative Orders and Remedies Regulation*, section 6. Section 77 authorizes, the minister,² subject to regulation, to order a person to stop an activity that the minister believes will result in a contravention of forest legislation and will or probably will cause a catastrophic impact on public health or safety, an adverse impact on the environment or a failure to achieve a free growing stand.

Section 77 currently has only limited usefulness for the purposes of this report because it only applies if activities "will" contravene legislation, and "will or probably will" cause a "catastrophic impact" on public health or safety. Consideration should be given to amending section 77 to remove the requirement for the minister to believe that the act or omission "will result in a contravention." After all, if the minister believes something will probably cause a catastrophic impact on public health or safety, the minister should be able to take preventive action.

Amending Licence Documents

Finally, the obligation of district managers to issue cutting permits if certain administrative requirements have been met is set out in licence documents. One way to provide greater discretion to district managers would be to amend licence documents to provide for such discretion.

Conclusion

Sometimes there is a public interest that only government can address. District managers are the public's representatives on the ground. They are aware of issues that individual licensees may not be aware of and they can look "down the road" to emerging issues that may not yet be impacting the land.

In the view of the Forest Practices Board, improvement is needed in the policy and legislative framework to reduce risk to public safety and important resource values and to improve public confidence in forest management on Crown land. The Board recommends giving conditional discretion to district managers to act in the public interest. District managers will need this authority in future to help them manage in an increasingly complex environment.

The benefits of doing so include:

- reduced risks to public health and safety;
- increased public confidence in forest management;
- a level playing field for licensees operating on Crown land;
- better management of cumulative effects; and
- reduced economic costs resulting from landslides, excessive sedimentation and overharvesting.

² This authority has been delegated to district managers and regional executive directors.

The Board believes the best option would be to introduce a regulation to implement *Forest Act* section 81.1. As long as this proposed district manager authority is used judiciously and within parameters that can be established by policy, it would not increase industry costs or red tape. The mere existence of this authority would help district managers to facilitate resolutions to issues without the necessity of invoking the authority. This proposal is consistent with a results based regime in which professional reliance plays a significant role, in that it recognizes that there are many situations where results have not been defined or where professional reliance does not adequately address the situation.

Recommendation

In accordance with section 131(3) of the *Forest and Range Practices Act*, the Board recommends that government introduce a regulation to implement *Forest Act* section 81.1. The regulation should authorize district managers to refuse a cutting permit or road permit if the minister determines that any of the following applies:

- there is clearly significant risk to public health or safety;
- there is clearly significant risk to forest resources or values;
- there is likely to be a contravention of legislation; or
- the interests of another tenure holder have not been adequately addressed (if that tenure holder requests district manager intervention).

In accordance with section 132 of FRPA, the Board requests a response to this recommendation by March 31, 2016.

Jennifer kindly provided me with her synopsis of both the NR Board's and the Minister's comments on the forthcoming professional reliance review.

It would appear that the Minister's direction envisions a review which is potentially significantly more broad than that which was outlined in the materials presented to the NR Board. In addition to assessing

whether or not the various professional associations are meeting their mandates to ensure that their members protect the public interest, it seems to also involve an assessment of

- the various operational statutes (under different Ministries) to determine the nature and context of the various decisions which involve qualified professionals, and
- whether or not the current use of qualified professionals (as practiced under those statutes) is effectively protecting the public interest.

This would suggest that perhaps the Minister has an interest in looking at the context of the decisions to be made (i.e. the nature, timing, scope etc. of the statutory decision itself) which involve qualified professionals, rather than strictly focusing on whether or not the respective professional associations are ensuring that their members are performing appropriately within that context.

Having not been present at the discussions with the Minister or at the NR Board, it is easy to mistakenly read in inferences which were not, in fact, intended. Please feel free to correct me on the intended scope of the review.

Dear Minister Heyman,

As we indicated to your office earlier this month, the Association of Professional Engineers and Geoscientists of BC (APEGBC) had the opportunity to meet with MLA Sonia Furstenau on August 16 to discuss the professional reliance model and the recent investigation we conducted on Active Earth Engineering related to a contaminated soil facility near Shawnigan Lake. We look forward to the opportunity to meet with you on this and other matters on which we collaborate with your ministry.

We had a wide ranging discussion on the professional reliance model and I believe that we concurred on a number of points including:

- 1. There are challenges and opportunities for change with the professional reliance model in BC as it currently stands.
- 2. Public trust in government, professionals and their regulators has been eroded due to incidents like the contaminated soil facility near Shawnigan Lake.
- 3. APEGBC as a professional regulator could provide valuable input into discussions on enhancing the professional reliance model and would appreciate the opportunity to do so.
- 4. We want to work with the BC Government to improve the professional reliance model by better government/professional regulations and professional practices/standards to regain public trust.

MLA Furstenau had many questions and comments regarding the investigation conducted by APEGBC into the contaminated soil facility near Shawnigan Lake. Under section 46 of the Engineers and Geoscientists Act there is a requirement to keep information related to investigations confidential unless they proceed to a disciplinary hearing which limits the amount of information that can be shared. APEGBC sought the agreement of the members involved in the investigation to make public the outcome of the investigation due to the enhanced public interest in the file. We have also advised all complainants of specific details related to their complaint as direct by the Engineers and Geoscientists Act. It is understood that MLA Furstenau would have like to have seen a different outcome in this matter.

I should note that as of August 23, 2017, APEGBC has rebranded as Engineers and Geoscientists BC to better reflect our role as a progressive regulator that works in the public interest. As per the Engineers and Geoscientists Act, our legal name continues to be the Association of Professional Engineers and Geoscientists of BC.

Again, we are most interested in working with government to continue to improve the professional reliance model so it best serves the people of BC.

The short answer is that the FRPA model relies on a wide range of QPs, each to a different degree. FRPA is designed to complement the various acts that establish the self-regulating professions, most notably for the professions that have the right to practice (foresters, engineers). FRPA implies the need for a member of the ABCFP or APEGBC to carry out various functions (e.g., to sign an FSP), but it is also assumed that forest tenure holders with utilize the members of a wide range of professional bodies in managing the FRPA values.

Thanks for the opportunity to review this version. Tom McReynolds has updated me on the work over the last couple of weeks and I've reviewed this version in FLNRO with key folks on our Exec team, many of whom participated in the recent discussion at the NRS ADMs and NRB and have commented on the different iterations.

I see this work has evolved quite a bit over the last couple weeks. Overall, FLNRO supports the general approach, but there is concern that this version could be interpreted as being broader in scope. In the last TOR, the work was clearly staged. But in this one, it looks to us that changes to the current legislative regime may be brought into scope.

I've made some suggestions in the document (particularly with component 2 and 3) to manage this potential risk of scope creep to keep it in line with what we understood the objectives, based upon board direction. If direction has changed and this is no longer the intended scope, we will need a conversation to ensure that legislative review component is clearly spelled out and FLNRO is engaged in leading appropriate pieces for forestry with advice and direction from MDD.

2017 Confidence and Supply Agreement between the BC Green Caucus and the BC New Democrat Caucus

This agreement between the BC Green Caucus and the BC New Democrat Caucus is effective ______, 2017, for four years, or until the next fixed date election as set by the *BC Constitution Act*.

Section 1 – Foundation of Relationship

This agreement establishes the basis for which the BC Green Caucus will provide confidence in a BC New Democrat Government. It is not intended to lay out the full program of a New Democrat Government, nor is it intended to presume BC Green support for initiatives not found within this agreement.

Both the BC New Democrats and the BC Greens campaigned for a government that put people at the centre of their decision-making. Our policy proposals included many points of agreement, including:

- 1. Making democracy work for people
- 2. Creating jobs, acting on climate change, and building a sustainable economy that works for everyone
- 3. Fixing the services people count on
- 4. Making life more affordable for people

This agreement sets out a new relationship between the two parties, founded on the principle of "good faith and no surprises".

Both parties agree that the legislature works best when all MLAs are able to put forward good ideas – and come together – to support those that advance the public good.

Subject to the terms of this agreement, we undertake that:

- 1. Should the Lieutenant Governor invite the Leader of the BC New Democrats to form a new government, this agreement will continue until the next scheduled election.
- 2. The Leader of the New Democrats will not request a dissolution of the Legislature during the term of this agreement, except following the defeat of a motion of confidence.
- 3. The BC Green MLAs will neither move, nor vote non-confidence during the term of this agreement, so long as the principle of good faith and no surprises has been observed.
- 4. Both parties will ensure that they have all their elected members at all sittings of the House as reasonable, and will vote in favour of the government on confidence motions.
- 5. While individual bills, including budget bills, will not be treated or designated as matters

- of confidence, the overall budgetary policy of the Government, including moving to the committee of supply, will be treated as matters of confidence.
- 6. BC Green support for policy and legislation which does not relate to confidence or supply is not subject to this agreement and will be decided on an issue by issue basis.

This agreement establishes a dispute resolution process (see Appendix A).

Both caucuses recognize that, in order to promote greater stability, the government must be able to negotiate with the three BC Green Party MLAs as a single, recognized caucus. Similarly, to be a credible partner and fulfill the responsibilities that will be required of them, the BC Green MLAs require access to legislative tools that are only available to recognized political parties and sufficient support staff.

A foundational piece of this relationship is that both caucuses support the adoption of the UN Declaration on the Rights of Indigenous Peoples, the Truth and Reconciliation Commission callsto-action and the Tsilhqot'in Supreme Court decision. We will ensure the new government reviews policies, programs and legislation to determine how to bring the principles of the Declaration into action in BC.

This agreement shall only be amended by mutual consent.

Section 2 – Consultation Arrangements

Consultation will occur in a timely fashion to ensure BC Green Caucus views can be incorporated into final decision-making. Formal consultation will be managed between the Premier's Office and the BC Green Caucus office. Regular meetings will also be established between the Premier and the BC Green Party Leader.

1. Overall Consultation

The BC New Democrat Government will consult the BC Green Party Caucus on:

- Broad outline of the government's legislative programme;
- Legislation to be introduced in the House;
- Major policy issues;
- Broad budget parameters;
- Events/policy changes with provincial or budgetary implications.

To ensure that the BC Green Party Caucus is informed about the policy agenda of the government, the BC New Democrat Government agrees to provide access to key documents and officials.

Both parties agree to establish a process to manage and coordinate the external communication of policy initiatives covered in this agreement, ensuring the principle of good faith and no surprises is maintained through communications.

2. Budget

The BC New Democrat Government will ensure the BC Green Caucus is afforded meaningful consultation on provincial budget priorities in advance of being finalized.

3. Confidentiality

Where briefings or other consultations have been provided to the BC Green caucus in respect to legislation, policy or budgetary matters, all discussions shall be confidential unless otherwise agreed, subject to the provisions of the *Freedom of Information and Protection of Privacy Act*.

Section 3 – Policy Initiatives

A BC New Democrat Government agrees to advance the following legislative and policy initiatives identified as a condition of support by the BC Green Caucus. These objectives are not an exhaustive list of the policy initiatives the BC New Democrat Government or BC Green Caucus will advance, but are areas where we agree on shared values and outcomes for the people of British Columbia.

1. Making democracy work for people

- a. The Legislature shall be recalled within one month of the swearing in of a BC New Democrat Government.
- **b.** Proportional Representation
 - i. Both the BC New Democrat Government and the BC Green Caucus are committed to proportional representation. Legislation will be introduced in the 1st sitting of the next session of the BC Legislative Assembly with a BC New Democrat Government establishing that:
 - (1) A referendum on proportional representation will take place in the fall of 2018, concurrent with the next municipal election; and
 - (2) The form of proportional representation approved in the referendum will be enacted for the next provincial election.
 - ii. The parties agree that they will work together in good faith to consult British Columbians to determine the form of proportional representation that will be put to a referendum.
- **iii.** The parties agree to both campaign actively in support of the agreed-upon form of proportional representation.

c. Electoral Finance

- i. The parties agree that legislation will be introduced in the 1st sitting of the next session of the BC Legislative Assembly with a BC New Democrat Government to:
 - (1) Ban corporate and union donations and contributions from non-residents of British Columbia;
 - (2) Place limits on individual contributions;
 - (3) Accept loans only from banks or recognized financial institutions;
 - (4) Eliminate any other means by which individuals or entities may wield undue influence over government; and
 - (5) Conduct a review of campaign finance and the Elections Act.

d. Lobbying Reform

- i. The parties agree that legislation will be introduced in the 1st sitting of the next session of the BC Legislative Assembly with a BC New Democrat Government to:
 - (1) Institute a multi-year prohibition on lobbying for former Senior Public Office Holders;
 - (2) Increase penalties for violations of the Lobbyists Registration Act;
 - (3) Initiate a comprehensive review of the *Lobbyists Registration Act*, including the Office of the Registrar of Lobbyists' mandate, to ensure our democratic institutions and the interests of British Columbians are adequately protected from the influence of special interests.
- **e.** Respect the integrity and independence of a professional public service.
- f. Ensure more public input into decision-making by making more effective use of committees of the legislature and allowing MLAs an opportunity to have input on policy decisions.
- g. The parties agree that legislation will be introduced in the 1st sitting of the next session of the BC Legislative Assembly with a BC New Democrat Government to shift the formula for the fixed election date from May, to a date in the fall of 2021, and every 4 years after that to provide a more transparent budget process and the passage of a budget prior to an election.
- **h.** Require Spring and Fall sittings of the legislature every year.

2. Jobs, climate and a sustainable economy that works for everyone

a. Climate Action

- i. Implement an increase of the carbon tax by \$5 per tonne per year, beginning April 1, 2018 and expand the tax to fugitive emissions and to slash-pile burning.
- ii. Deliver rebate cheques to ensure a majority of British Columbians are better off

- financially than under the current carbon tax formula.
- iii. Implement a climate action strategy to meet our targets.
- **b.** Immediately refer the Site C dam construction project to the BC Utilities Commission on the question of economic viability and consequences to British Columbians in the context of the current supply and demand conditions prevailing in the BC market.
- **c.** Immediately employ every tool available to the new government to stop the expansion of the Kinder Morgan pipeline, the seven-fold increase in tanker traffic on our coast, and the transportation of raw bitumen through our province.
- **d.** Improve fairness for workers, ensure balance in workplaces, and improve measures to protect the safety of workers at work so that everyone goes home safely and that workers and families are protected in cases of death or injury.
- e. Immediately establish an at-arm's-length Fair Wages Commission that will be tasked with establishing a pathway to a minimum wage of at least \$15 per hour and overseeing regular rate reviews. The commission will bring forward recommendations regarding strategies to address the discrepancy between minimum wages and livable wages. The commission will make its first report on a new minimum wage within 90 days of its first meeting.
- **f.** Act immediately to improve transit and transportation infrastructure in cooperation with the Mayors' Council and the federal government to reduce emissions, create jobs and get people home faster.
- **g.** Work with the Mayors' Council consultation process to find a more fair and equitable way of funding transit for the long term.
- **h.** Invest over four years to support co-op, apprenticeship and work experience programs for high-school and undergraduate students.
- i. Establish an Emerging Economy Task Force (EETF) to address the changing nature of business over the next 10 to 25 years. The EETF will be charged with developing "madein-BC" solutions that keep our government, our policies and our thinking on the cutting edge. The task force will report to the government within one year of the 1st sitting of the next session of the BC Legislative Assembly with a BC New Democrat Government.
 - i. The mandate and funding of the EETF will be jointly established by representatives of both the BC Green Caucus and the BC New Democrat Government.
- j. Establish an Innovation Commission to support innovation and business development in the technology sector, and appoint an Innovation Commissioner with a mandate to be an advocate and ambassador on behalf of the BC technology sector in Ottawa and abroad.

- i. The mandate and funding of the Innovation Commission will be jointly established by representatives of both the BC Green Caucus and the BC New Democrat Government.
- **ii.** The Innovation Commission will be created in the 1st provincial budget tabled by the BC New Democratic Government.
- **k.** Reinvigorate our forest sector to improve both environmental standards and jobs for local communities.
- Revitalize the Environmental Assessment process in BC and review and address failures in the professional reliance model in BC so that British Columbians' faith in resource development can be restored.
- **m.** Build needed hospitals, schools and other infrastructure that reduce emissions and increase energy efficiency throughout BC.

3. Fixing the Services People Count on

- a. Promote and protect the public healthcare system.
- **b.** Increase the emphasis on preventative health initiatives and services.
- c. In the first provincial budget tabled by the BC New Democratic Government, develop a proposal to implement an essential drugs program, designed to reduce the costs of prescription drugs and ensure the cost of drugs is not a barrier to health management.
- **d.** Provide seniors with the right care at the right time to improve health and reduce costs in hospitals.
 - i. Invest in home care to enable seniors and other people who need assistance to stay in their own homes.
 - **ii.** Ensure the staffing of public and private care homes meets government guidelines, and provide additional funding to address staffing levels in public facilities.
- iii. Ensure that clear, measurable and enforceable staffing standards for residential care facilities are implemented. Standards will be supported by monitoring and enforcement to ensure they are being met, and there will be annual public reporting.
- **e.** Expand the use of team-based health care to ensure that people have better access to the type of care they need, including access to services from physiotherapists, nurse practitioners, midwives, dieticians, pharmacists and other health professionals.
- f. Respond to the crisis in mental health and addictions with a dedicated Minister

responsible for developing and implementing a Mental Health and Addiction Strategy and a Youth Mental Health Strategy.

- i. Ensure that the Ministry has sufficient funding to provide frontline services, including funding for early intervention, youth mental health initiatives, supervised injection sites, and community-based centres for mental health and rehabilitation.
- **ii.** Develop an immediate response to the fentanyl crisis based on successful programs that invest in treatment-on-demand, drug substitution, early-warning monitoring systems, and coordinated response.
- **g.** Recognize that education is about lifelong learning and make post-secondary education more accessible and affordable.
 - i. Restore funding to Adult Basic Education and English language learning.
 - **ii.** Implement an agreed upon approach to improving access and reducing the cost of post-secondary education for students.
- **iii.** Allocate funding for in-service skills training for workers in small and medium-sized enterprises, and for retraining for those displaced by automation or changing markets.
- **h.** Fast track enhancement to K-12 education funding to restore faith in public schools after a decade and a half of a government that shortchanged a generation of students.
 - i. Priorities for funding include early intervention and Healthy Starts programs.
 - **ii.** Review the funding model for the K-12 education system with a view to ensuring equitable access for students.
- i. Invest in childcare and early childhood education to improve quality, expand spaces, increase affordability and ensure childcare is accessible for all families, with a focus on early childhood education.
- **j.** Enhance and improve child protection services to ensure that all children grow up in safe and nurturing environments.
 - i. Invest in child protection to hire additional social workers and staff to support social workers, and to implement incentives to attract social workers to rural and underserved regions.
- **k.** Tighten the rules that protect good landlords and tenants and ensure the resources necessary exist to resolve disputes fairly and in a timely way.

4. Making life more affordable

- a. Design and implement a province-wide poverty reduction strategy that includes addressing the real causes of homelessness, including affordable accommodation, support for mental health and addictions and income security.
 - i. One aspect of the poverty reduction strategy is to design and implement a basic

income pilot to test whether giving people a basic income is an effective way to reduce poverty, improve health, housing and employment.

- (1) This pilot should be funded in the first provincial budget tabled by the BC New Democratic Government.
- **b.** Develop a genuine progress indicator for British Columbia covering a range of indicators.
 - i. The indicators will be developed in consultation with business and industry, communities, not-for-profit organizations and individuals.
- c. Eliminate regressive MSP premiums.
- **d.** Make housing more affordable by increasing supply of affordable housing and take action to deal with the speculation and fraud that is driving up prices.

APPENDIX A - Consultation and Dispute Resolution between the BC Green Caucus and the BC New Democrat Government

This agreement is governed by the principle of good faith and no surprises found within the "2017 Confidence and Supply Agreement between the BC Green Caucus and the BC New Democrat Caucus". In practice, this requires both parties to work together in good faith to:

- 1. Consult on policy initiatives detailed within the "2017 Confidence and Supply Agreement between the BC Green Caucus and the BC New Democrat Caucus" and other policy initiatives agreed upon by both parties. Consultation will:
 - a. Occur before final policy decisions have been made to ensure that the BC Green Caucus can contribute to the policy development process;
 - Notice of forthcoming issues requiring consultation is given through the Consultation Committee (see below for details regarding the Consultation Committee).
 - b. Commence with adequate time for the BC Green Caucus to review the necessary information and canvass the caucus for positions, taking into consideration the financial and human resource limitations of the BC Green office.
 - c. Include consultation on senior Order-in-Council (OIC) appointments.
- 2. Guarantee that the BC New Democrat Government will gauge support from the BC Green Caucus for proposed legislative action through the Consultation Committee before legislation is introduced.
- 3. Ensure that the BC Green Caucus is informed about the policy agenda of the government. The BC New Democrat Government agrees to provide access to:
 - a. Deputy minister and ministry staff briefings;
 - b. Executive summaries and full briefings on key issues as requested by the BC Green Caucus, and 30-60-90 briefing notes;
 - c. Adequate background documents and support information used in the preparation of initiatives;
 - d. Other resources as necessary to enable informed participation by the BC Green Caucus;

The BC Green Caucus and BC New Democrat Government establish three levels to consultation/dispute resolution under the broader "2017 Confidence and Supply Agreement between the BC Green Caucus and the BC New Democrat Caucus".

- Where an issue is identified for consultation by the BC Green Caucus, a member of the BC Green Caucus will be identified to the BC New Democrat Government as the point person on the issue. Consultation on the issue occurs directly between the Minister and the BC Green Caucus point person.
- A Consultation Committee will be established to consider any issues needing consultation, including parliamentary aspects that have not been dealt with in consultations between the Minister and the BC Green Caucus point person. This committee will meet regularly and will have 3 members from each party, including at least one member of caucus.
- 3. Regular meetings between the Premier and the Leader of the BC Green Party will take place and can dispense of any remaining issues.

In addition to the process laid out above, the following access is provided to the BC Green Caucus:

Representatives from the BC Green Caucus and the BC New Democrat Government will meet frequently to establish the formal and informal methods through which consultation takes place. Both parties acknowledge that consultation will form the basis of ensuring that good relationships can be built, that the principle of good faith and no surprises can be followed, and that a strong, stable and effective minority government can exist.

Hello Caelie,

The following information is compiled from our colleagues at FLNR:

FRPA and the associated regulations don't explicitly grant too much discretion to professions. However, by omission, FRPA and the regulations provide district managers with insufficient authority to compel licensee coordination, manage conflicts and prevent contraventions. This gap may provide licensees and the professions they engage with too much latitude.

- In a 2015 report, the Forest Practices Board identified examples from past investigations
 where (in the Board's view) forest operations were putting environmental and
 community values at risk, yet district managers had limited authority to directly
 influence (prevent or stop) those operations.
- For example, the Board indicates that district managers lack a mandate or authority to:
 - Compel licensees to coordinate their operational planning at the landscape level to enable effective planning for (a) cumulative hydrological risks, and (b) biodiversity, wildlife and other landscape-level objectives;
 - 2. **Mediate conflicts** between forest licensees and other tenured users or stakeholders over proposed harvesting and road building; and,
 - 3. **Prevent contraventions** from occurring *prior to* harvesting or road building.
- The Board notes that the current system works reasonably well most of the time, as licensees and their professionals are generally diligent when planning operations and district managers are often able to establish expectations of licensees and facilitate resolution of conflicts.

• The Board notes that an important underlying issue is the inability of the district manager to anticipate and prevent unintended outcomes (such as cumulative effects, conflicts, or risks to the environment or public safety) at the forest stewardship planning stage. When Forest Stewardship Plans (FSPs) contain vague unenforceable content, this further weakens the district manager's ability to influence forest operations at the CP/RP stage or to take enforcement action during operations.

Dear Minister Heyman,

As we indicated to your office earlier this month, the Association of Professional Engineers and Geoscientists of BC (APEGBC) had the opportunity to meet with MLA Sonia Furstenau on August 16 to discuss the professional reliance model and the recent investigation we conducted on Active Earth Engineering related to a contaminated soil facility near Shawnigan Lake. We look forward to the opportunity to meet with you on this and other matters on which we collaborate with your ministry.

We had a wide ranging discussion on the professional reliance model and I believe that we concurred on a number of points including:

- 1. There are challenges and opportunities for change with the professional reliance model in BC as it currently stands.
- 2. Public trust in government, professionals and their regulators has been eroded due to incidents like the contaminated soil facility near Shawnigan Lake.
- 3. APEGBC as a professional regulator could provide valuable input into discussions on enhancing the professional reliance model and would appreciate the opportunity to do so.
- 4. We want to work with the BC Government to improve the professional reliance model by better government/professional regulations and professional practices/standards to regain public trust.

MLA Furstenau had many questions and comments regarding the investigation conducted by APEGBC into the contaminated soil facility near Shawnigan Lake. Under section 46 of the Engineers and Geoscientists Act there is a requirement to keep information related to investigations confidential unless they proceed to a disciplinary hearing which limits the amount of information that can be shared. APEGBC sought the agreement of the members involved in the investigation to make public the outcome of the investigation due to the enhanced public interest in the file. We have also advised all complainants of specific details related to their complaint as direct by the Engineers and Geoscientists Act. It is understood that MLA Furstenau would have like to have seen a different outcome in this matter.

I should note that as of August 23, 2017, APEGBC has rebranded as Engineers and Geoscientists BC to better reflect our role as a progressive regulator that works in the public interest. As per the Engineers and Geoscientists Act, our legal name continues to be the Association of Professional Engineers and Geoscientists of BC.

Again, we are most interested in working with government to continue to improve the professional reliance model so it best serves the people of BC.

Minister Heyman,

This is an urgent request for a meeting in person regarding imminent danger to a community's only and precarious water supply. A community water planning process needs to happen before harvesting of any kind takes place.

I am one of 6 members of the Ymir Watershed Action Team (YWAT): tasked with the protection of our community by ensuring that our only viable and historically precarious water source is not negatively impacted by any kind of development. Our community supports responsible logging: 30% of our adult population works in the forestry industry.

Currently, we are doing everything we can to halt the current "Quartz Operating Plan" proposed by BCTS. The BCTS plan involves carving 5.6km of new road, crossing tributaries to our supply creek 45 times, on its way to 36 Hectares of cut-block logging on the highest-water-yielding North-facing aspect of our watershed (the darkest, wettest side). The damage to the existing canopy will result in increased water evaporation, faster snow-melt, and new dry open areas primed to accelerate forest fire travel. **Our watershed can not support this type of development.**

The Ymir (Quartz) Community Watershed is a tiny 600 Hectare surface-collection-only, low-elevation, horseshoe-shaped bowl that supplies our community of 400 with our only drinking, household, and fire hydrant water. Our watershed has no lake, pond, or high-elevation snowmelt to supply it: all of our water comes exclusively from the sky. Studies and exploration in the early 2000's found no other viable sources of water for the community. All other sources have been contaminated beyond treatment by early mining practices. The Ymir (Quartz) Watershed is all we have, and the supply gets LOW during hot and dry summer months (see attached photos comparing May 2017 and August 2017 flows).

YWAT has been involved in earnest and diplomatic "consultations" with BCTS since May. To date BCTS representatives have been polite, informative and completely unwilling to alter the "Quartz Operating Plan" despite YWAT repeatedly emphasizing the severity of the situation. It has become obvious that "duty to consult stakeholders" has become an ineffective process that more closely resembles "duty to inform stakeholders".

YWAT has offered BCTS a counter-proposal involving the use of existing roads on an adjacent ridge to access and log a fire-break all around the outside of our community watershed: creating jobs, acquiring timber and protecting the communities only water source. The counter-proposal was dismissed as "not practicable". Despite this setback, YWAT is still willing to engage in a collaborative planning effort with BCTS and the Ktunaxa Lower Kootenay Band **if all our voices** are able to influence the trajectory of subsequent proposals. We are solution-oriented and are confident there is a way forward.

YWAT has been busy forming a growing coalition of supporters for the community of Ymir's position. To date we have the support of the **Ktunaxa Lower Kootenay Band Council**, Unanimous support from **all Area Directors of the Regional District of the Central Kootenay**, support from local **MLA NDP Michelle Mungall** (now MEM), **Kim Chalesworth**, and the combined voices of **over 5000 referral process letters** decrying the "Quartz Operating Plan". We have been active on local radio (and 1 regional radio CBC spot), in the local newspaper, and online. We have our first interview on Vancouver Coop radio this Thursday. We have been sending Ministers letters and emails before and since the change of Provincial Government.

All stakeholders except BCTS are screaming "no" to the "Quartz Operating Plan", but BCTS is not listening: during meetings between YWAT and BCTS reps, the sub-text from BCTS is always "we hold the timber rights so we are going to carry out our plan regardless". **This is unacceptable.**

Stakeholders need to reacquire the ability to change the trajectory of proposals for development projects that may pose a danger to them. In our case, there needs to be meaningful collaboration between BCTS, the community, and the Ktunaxa Lower Kootenay Band: as it stands, the current "consultation" process requires nothing more than lip service by BCTS, and is a completely ineffective way to protect BC communities.

BCTS's attempt to push through its "Quartz Operating Plan" based on an inadequate 6 page(!) preliminary hydrological assessment by long term contractee (since 2005) Streamworks Consulting is a clear example of BC's professional reliance gone wrong. The "report" had no mention of our community's historic water supply issues, our collection pond limitations, nor the fact that there are NO other viable water sources available to us.

Representatives from the community of Ymir and the Ktunaxa Lower Kootenay Band Council are willing to come to Victoria to meet with you in person.

Minister Heyman,

We are writing to you on behalf of the Community to voice our great concern with the impending damage to our watershed and resulting loss of our only supply of clean, safe drinking, household and fire hydrant water for homes and businesses in the area.

BCTS has targeted our Community's only water source in the form of the "Quartz Operating Plan" they released to us June 25th, 2017. The document outlines plans for 5.6km of road building that crosses tributaries to our supply creek 45 times, and 36 hectares of cut-block logging in the heart of the highest water-yielding North aspect of our watershed. As 100% of our water supply comes from surface-collection, any additional sun exposure within our watershed will result in decreased supply during hot and dry months – when we need our water most.

BCTS cites a 6 page document produced by long-term contractee Streamworks Consulting (since 2005) as evidentiary for moving ahead with their "Quartz Operating Plan" (attached). The document does not include any reference to the historic water supply issues in our watershed, the collection pond limitations (Quartz is a "Fish-Bearing Stream"), or the fact that there is no other viable water source available to the community.

The past government's "professional reliance" system is certainly in question here.

Due to months of earnest and diplomatic emails and meetings with representatives at BCTS since late April of this year, they now aware of all of the Quartz Community Watershed's challenges, but still refuse to alter their "Quartz Operating Plan".

The Community of Ymir supports responsible logging, as 30-40% of our working population is directly supported by the logging industry in some capacity, and 100% of our population is indirectly supported by portions of logging revenues flowing back into the community in the form of occasional provincial government funding/granting.

The Community of Ymir does not support bad decision-making.

BCTS decision to jeopardize the only and precarious water source available to our community is a bad decision. One that seems more motivated by bad business ethics than preserving human rights to water.

The Community of Ymir and the Ymir Watershed Action Team have offered BCTS a solution-oriented counter-proposal to extend some existing roads outside the Quartz Community Watershed in order to log a wide fire-break around the outside of the watershed's perimeter: creating jobs, revenue, and fire protection for our most valuable resource – our water. The proposal was quickly dismissed by BCTS.

The Community has been building a growing coalition of supporters since April including: unanimous RDCK Area Director support, NDP MLA Michelle Mungall, Green Party member Kim Charlesworth, the Ktunaxa Lower Kootenay Band Council (Ymir, BC falls within their Traditional Territory), and the voices of over 5000 referral process letters against the "Quartz Operating Plan".

Please be a Minister who choses to intervene, and help us protect our Community from the residual effects of the Liberals' political-calculations-before-principles era of resource management in BC.



The Ministry of Environment and Climate Change Strategy is responsible for the protection, management and conservation of B.C.'s water, land, air and living resources and for setting strategic direction for government's climate change agenda. Its expertise in policy, science, research and analysis are central to supporting all its responsibilities. Ministry legislation, regulations, and public outreach activities ensure a sustainable and prosperous environment for British Columbians.

Key Ministry functions include:

- Leading action on climate change
- Regulating discharges to the environment
- Proactively responding to environmental risks
- Conserving B.C.'s biodiversity including ecosystems, native species and natural habitats
- Managing the province's parks and protected areas
- Developing legislation, regulations and policies based on sound scientific knowledge and expertise
- Environmental monitoring, data management and reporting
- Monitoring and enforcing compliance with environmental laws and regulations

The Ministry strives to ensure that all British Columbians will continue to benefit from the effective and prudent management of natural resources, allowing future generations to enjoy a safe and healthy environment.

Purpose of the Environmental Assessment Office

The Environmental Assessment Office (EAO) neutrally administers the environmental assessment (EA) process as defined in the *Environmental Assessment Act*, which requires proposed major projects be assessed for potentially significant adverse environmental, social, economic, health and heritage effects. The EAO seeks to meaningfully engage the public and Aboriginal groups in the EA process and is responsible for overseeing compliance and enforcement of reviewable projects throughout the life of the project. Additional information regarding the EA process can be found on the <u>EAO</u> website.

Ministry Goals, Objectives and Performance Measures

The Ministry of Environment and Climate Change Strategy, and the Environmental Assessment Office's goals are to help government achieve the following three commitments to British Columbians:

- The first commitment is to make life more affordable. British Columbians are counting on government to make their lives easier by containing costs and service fees.
- The second commitment is to deliver the services that people count on. Government services touch the lives of British Columbians every day, and there is so much more that we can and must do to provide these services where and when people need them. Additionally, in many cases, critical programs and services are delivered by Crown Corporations, and our Ministry will work with Board Chairs to improve levels of service to citizens.

The third commitment is to build a strong, sustainable, innovative economy that works for
everyone. Our government believes that all ministries and public sector organizations have a
role to play in supporting broad-based economic growth, developing poverty reduction
strategies, and helping create good-paying jobs in every region of the province.

Integrating with these priorities is government's commitment to true, lasting reconciliation with First Nations in British Columbia, as we move towards fully adopting and implementing the United Nations Declaration on the Rights of Indigenous Peoples and the Calls to Action of the Truth and Reconciliation Commission.

Beyond our work in supporting these commitments, the Minister of Environment and Climate Change Strategy has been tasked in the mandate letter to achieve the following specific objectives and performance targets:

- Renew the Climate Leadership Team within the first 100 days of receiving our mandate;
- Implement a comprehensive climate-action strategy that provides a pathway for B.C. to
 prosper economically while meeting carbon pollution reduction targets, including setting a
 new legislated 2030 reduction target and establishing separate sectoral reduction targets and
 plans;
- Work with the Minister of Finance to implement an increase of the carbon tax by \$5 per tonne
 per year, beginning April 1, 2018 to meet the federal government's carbon-pricing mandate.
 Take measures to expand the carbon tax to fugitive emissions and to slash-pile burning;
- Revitalize the Environmental Assessment process and review the professional reliance model
 to ensure the legal rights of First Nations are respected, and the public's expectation of a
 strong, transparent process is met;
- Employ every tool available to defend B.C.'s interests in the face of the expansion of the Kinder Morgan pipeline, and the threat of a seven-fold increase in tanker traffic on our coast; and
- Enact an endangered species law and harmonize other laws to ensure they are all working towards the goal of protecting our beautiful province.

Our Ministry and Office will continue to develop specific objectives and performance measures for inclusion in our 2018/19 Service Plan, which will be released with *Budget 2018*.
