Please find an embargoed copy of the materials for today's Climate Solutions and Clean Growth Advisory Council (CSCG) announcement at noon today.

The structure of this committee is different than the previous Climate Leadership Team - we are asking this group to help set strategic priority and review and comment on government draft policy rather than drafting specific recommendations for government to implement. Instead of a single big climate plan, we are looking to have a staggered set of actions over time. In addition, we are asking the CSCG to publicly report on government's progress towards our climate goals every two years beginning next year.

You will see that not every sector is represented on the membership list – besides of the size that would be required to enable that, the CSCG is consultative rather than recommendation-based and our commitment is to consult with the experts on each policy piece to ensure our recommendations are thoughtful and fulsome.

You may also note that the name includes reference to clean growth and the committee is co-chaired by Marcia Smith (Teck) and Merran Smith (Clean Energy Canada). This is an important signal that climate growth will be supported in the context of economic growth.

# Climate Solutions and Clean Growth Advisory Council

## Terms of Reference

October 19, 2017

### Mandate

1. The Climate Solutions and Clean Growth Advisory Council is a consultative advisory group with a mandate to:
  - i. Provide advice to government on actions and policies that can contribute to carbon pollution reductions and optimize opportunities for sustainable economic development and job creation.
  - ii. Provide advice and feedback to the Climate Action Secretariat on how to enhance potential benefits and mitigate potential impacts of government's climate policies to ensure sustained economic prosperity and social equity.
  - iii. Provide advice on implementing the recommendations of the 2015 Climate Leadership Team.
2. The Climate Solutions and Clean Growth Advisory Council is a permanent body that:
  - i. Reports to the Minister of Environment and Climate Change Strategy.
  - ii. Has appointments that last two years and are renewable.
  - iii. The Minister of Environment and Climate Change Strategy has discretion to appoint new members, and there will be no provision for alternate members.
3. The Climate Solutions and Clean Growth Advisory Council will:
  - i. Meet quarterly for discussions to provide feedback and advice and may meet more often if deemed necessary by the chair(s) or at the request of the Minister of Environment and Climate Change Strategy or the Climate Action Secretariat.
  - ii. Strive for consensus in their feedback and advice to government.

- iii. Agree the information and ideas discussed at the meeting can be shared outside the committee but individual attribution of specific ideas and opinions will be kept confidential.

4. As part of its mandate, the Climate Solutions and Clean Growth Advisory Council will review and publicly report after one year and every two years after that, government's progress towards meeting legislated carbon pollution reduction targets and maximizing job and economic opportunities.

### Climate Solutions and Clean Growth Advisory Council Members

5. The Climate Solutions and Clean Growth Advisory Council will consist of members representing broad aspects of B.C. society with varied areas of expertise.
6. The members will bring their knowledge, perspective and experience and will take an evidence-based approach to discussions.
7. The current members are listed in Appendix "A".

### Logistical Support

8. Meeting support will be provided by the Climate Action Secretariat.
9. The Climate Action Secretariat will act as the point of coordination for information from across government.

Judith Sayers is a member of the Hupacasath First Nation, President of the Nuuchahnulth Tribal Council and a strategic adviser. She also serves on Clean Energy BC's Board of Directors and is an adjunct professor for the Schools of Environmental Studies and Business at UVIC. As Chief of the Hupacasath First Nation for 14 years and Chief Negotiator for 15 years, Judith focused on restoring and rehabilitating Hupacasath territory. Judith has a business and law degree, an honorary Doctor of Laws from Queen's University, and a long career practicing law in Alberta and B.C. She is the recipient of human rights and leadership awards, and was inducted into the Aboriginal Business Hall of Fame.



*Sybil Seitzinger, Executive Director, Pacific Institute for Climate Solutions, University of Victoria*



Dr. Sybil Seitzinger is the executive director of the Pacific Institute for Climate Solutions and a professor in the School of Environmental Studies at UVIC. The Ktunaxa Nation Council's commitment to environmental stewardship includes the installation of a 119 panel solar array and a public electric vehicle charging station at its government building.

Jill Tipping became the President and CEO of BC Tech Association in 2017. She was previously VP Operations and CFO with Schneider Electric Solar, a global supplier of solar power solutions. #### **Background:**

- As per the mandate letter, the Climate Solutions and Clean Growth Advisory Council was established within the Minister's first 100 days in office on October 20th, 2017.
- The Climate Solutions and Clean Growth Advisory Council is a consultative advisory group with a mandate to:
  1. Provide advice to government on actions and policies that can contribute to carbon pollution reductions and optimize opportunities for sustainable economic development and job creation.
  2. Provide advice and feedback to the Climate Action Secretariat on how to enhance potential benefits and mitigate potential impacts of government's climate policies to ensure sustained economic prosperity and social equity.
  3. Provide advice on implementing the recommendations of the 2015 Climate Leadership Team.
- The Climate Solutions and Clean Growth Advisory Council is a permanent body that:
  1. Reports to the Minister of Environment and Climate Change Strategy.
  2. Has appointments that last two years and are renewable.
  3. The Minister of Environment and Climate Change Strategy has discretion to appoint new members, and there will be no provision for alternate members.
- The Climate Solutions and Clean Growth Advisory Council will:

1. Meet quarterly for discussions to provide feedback and advice and may meet more often if deemed necessary by the chair(s) or at the request of the Minister of Environment and Climate Change Strategy or the Climate Action Secretariat.
  2. Strive for consensus in their feedback and advice to government.
  3. Agree the information and ideas discussed at the meeting can be shared outside the committee but individual attribution of specific ideas and opinions will be kept confidential.
- As part of its mandate, the Climate Solutions and Clean Growth Advisory Council will review and publicly report after one year and every two years after that, government's progress towards meeting legislated carbon pollution reduction targets and maximizing job and economic opportunities.
  - B.C. is also working with sub-national jurisdictions through the Pacific Coast Collaborative, the International Alliance to Combat Ocean Acidification and the Regions Adapt initiative to better understand the impacts of climate change on the region, including ocean acidification, community resilience and disaster risk reduction.
  - Reports by the Intergovernmental Panel on Climate Change, U.S. Global Change Research Program and Natural Resources Canada emphasize that climate change is already impacting North America.
  - The reports also emphasize that additional impacts to our natural environment, economic prosperity and the health of British Columbians are inevitable – even with aggressive efforts to reduce greenhouse gas emissions. Further action on adaptation will be required to manage these risks.

This is why we're going to renew the Climate Leadership Team, so we can get our province on track to meet real climate goals. Our new team will include a broad range of members from First Nations, labour, industry, environmentalists, academics, and local government. Their advice will be instrumental in shaping our comprehensive climate-action strategy going forward and meeting both short and long term targets

When it comes to reducing our climate footprint it's often the little things that count. Some of those steps are simple and start right at home. They include small changes to be more energy efficient and help reduce harmful carbon pollution, which actually enhance our quality of life.

To incent people to adopt more climate friendly actions our government will gradually phase in the federally-mandated carbon price, beginning next April. But we also need to make sure the increased carbon price isn't an added burden for families, who are already struggling to get ahead. We intend to help British Columbians have the means to make the changes we know are necessary. Hi Caelie, Eveline – as requested by MGH, below is timeline for the climate leadership plan, including the work of the climate leadership team. Below that I've put in the a link to the CLT's final report, and have broken out the actual recommendations.

- April 13, 2015 – Creation of a new climate plan and Climate Leadership Team is foreshadowed, with CLT members expected to be announced in the coming weeks.
  - May 12, 2015 – CLT members are introduced, with the following timeline presented publicly:
    - July 2015 – A draft framework for the Climate Leadership Plan will be produced, with a 30-day public consultation on the resulting discussion paper.
    - October 2015 – The Climate Leadership Team will present its recommendations to government.
    - December 2015 – A draft Climate Leadership Plan will be prepared, and a 30-day public consultation will take place.
    - March 2016 – The final Climate Leadership Plan will be released publicly.
  - July 17, 2015 – Climate Discussion Paper released for a 30 day public comment period.
  - Aug 21, 2015 – Almost 6,000 people completed a survey as part of climate plan public engagement. Detailed submissions will be accepted until Sept 14<sup>th</sup>.
    - Commitment is made for a draft Climate Leadership Plan in December, with a final plan in Spring 2016.

- **Recommendation 6** Expand coverage of the current carbon tax to apply to all greenhouse gas emission sources in B.C. after five years, starting with measurable GHG emissions covered by the current reporting regulation.
- **Recommendation 7** Use the other incremental revenues generated from the increase in the carbon tax to:
  - a) Eliminate PST on all electricity rates;
  - b) Establish mechanisms to facilitate investments in technology and innovation that reduce GHG emissions; and
  - c) Establish mechanisms to provide local governments with funding for projects that will result in demonstrable reductions in GHG emissions. 3 One CLT member is not in a position to support recommendation
- **Recommendation 8** The scheduled annual increases in the carbon tax and the

competitiveness adjustments for emission intensive, trade-exposed sectors should be reviewed by the Province, with the support of a Climate Leadership Team, every five years, or more often where warranted, taking into consideration GHG reductions, economic competitiveness, carbon pricing and regulatory policy in other jurisdictions, and impacts on vulnerable communities.

- **Recommendation 9** The fiscal policies described in these recommendations should be included in the 2016 budget where applicable.
- **Recommendation 10** Create a task force with appropriate expertise (e.g. economics, global markets, clean innovation, environment-economy policy) to research B.C.'s competitive advantages and potential growth areas in a low-carbon economy, both within and across sectors, and to develop recommendations on stimulating these areas
- **Recommendation 11** Amend the Environmental Assessment Act to include the social cost of carbon<sup>4</sup> in the Environmental Assessment process and ensure consistency with the climate action plan and carbon pricing signals.
- **Recommendation 12** Amend the Clean Energy Act to increase the target for clean energy on the integrated grid from 93 per cent to 100 per cent by 2025 (except where fossil fuel capacity is required for back-up or reliability).

  - Commencing in 2016, require that all new public sector buildings increase the use of materials that sequester carbon, and have the capacity of meeting most of their annual energy needs by on-site renewable energy;
  - Revisions to the building code that require new buildings to (i) increase use of materials that sequester carbon and (ii) have the capacity of meeting most of their annual energy needs by onsite renewable energy within 10 years;
  - Programs (such as on-bill financing) that encourage retrofits that reduce GHG emissions and encourage energy efficiency in existing building stock; and
  - Standards that transition the market to high-efficiency electric heating equipment, building components and appliances.

- **Recommendation 22** Create a waste-to-resource strategy that reduces GHG emissions associated with food waste, organic waste, and landfills.

## Terms of Reference

October 19, 2017

### Mandate

1. The Climate Solutions and Clean Growth Advisory Council is a consultative advisory group with a mandate to:
  - i. Provide advice to government on actions and policies that can contribute to carbon pollution reductions and optimize opportunities for sustainable economic development and job creation.
  - ii. Provide advice and feedback to the Climate Action Secretariat on how to enhance potential benefits and mitigate potential impacts of government's climate policies to ensure sustained economic prosperity and social equity.
  - iii. Provide advice on implementing the recommendations of the 2015 Climate Leadership Team.
2. The Climate Solutions and Clean Growth Advisory Council is a permanent body that:
  - i. Reports to the Minister of Environment and Climate Change Strategy.
  - ii. Has appointments that last two years and are renewable.
  - iii. The Minister of Environment and Climate Change Strategy has discretion to appoint new members, and there will be no provision for alternate members.
3. The Climate Solutions and Clean Growth Advisory Council will:
  - i. Meet quarterly for discussions to provide feedback and advice and may meet more often if deemed necessary by the chair(s) or at the request of the Minister of Environment and Climate Change Strategy or the Climate Action Secretariat.
  - ii. Strive for consensus in their feedback and advice to government.

- iii. Agree the information and ideas discussed at the meeting can be shared outside the committee but individual attribution of specific ideas and opinions will be kept confidential.

4. As part of its mandate, the Climate Solutions and Clean Growth Advisory Council will review and publicly report after one year and every two years after that, government's progress towards meeting legislated carbon pollution reduction targets and maximizing job and economic opportunities.

### Climate Solutions and Clean Growth Advisory Council Members

5. The Climate Solutions and Clean Growth Advisory Council will consist of members representing broad aspects of B.C. society with varied areas of expertise.
6. The members will bring their knowledge, perspective and experience and will take an evidence-based approach to discussions.
7. The current members are listed in Appendix "A".

### Logistical Support

8. Meeting support will be provided by the Climate Action Secretariat.
9. The Climate Action Secretariat will act as the point of coordination for information from across government.
