CONDITIONS GOVERNING LOAN OF 14 ARTWORKS

- 1. One person per office (Office Contact) should be appointed to have responsibility for the artworks on loan. The Office Contact will receive regular communication from the Collection Coordinator.
- 2. The Office Contact should maintain, through regular spot checks, the inventory list of artworks, and notify the Collection Coordinator of any discrepancies.
- 3. Artworks are not to be relocated or repaired without the prior authorization of the Collection Coordinator. Artworks are vulnerable to damage from excessive light, heat, equipment and other hazards, and are installed in locations that avoid these conditions.
- 4. The Office Contact will notify the Collection Coordinator of office moves or renovations which may affect the artworks, a minimum of two weeks prior to the projected date of action, so that works may be removed for safety.
- 5. Should loss or damage to artworks occur, the Office Contact must advice the Collection Coordinator immediately, followed by written notice within one week. Details regarding the incident should include date of discovery, name of person who discovered the loss or damage, as well as a description and explanation of the damage.
- 6. Offices will cover the cost of transportation, installation, and removal of artworks by a fine art handler, as arranged through the Collection Coordinator.
- 7. In the event of loss or damage to a work, the client shall be liable for the damage and, therefore, is responsible for the payment of repair and conservation costs or, in the case of theft or irreparable damage, for the replacement value of the work.
