BACKGROUND NOTES

- In October 2003, Canada and B.C. signed a Memorandum of Understanding (MOU) to study the feasibility of establishing three new federal protected areas in B.C. including the potential national park reserve in the South Okanagan-Lower Similkameen.
- The feasibility study began in 2004 and included two rounds of broad public consultations in 2004 and 2006, community forums in 2007 and extensive consultations with affected stakeholders. A socio-economic impact assessment was completed in 2008.
- In 2010, senior officials representing B.C. and Canada agreed that the feasibility study, with the exception of First Nations consultation, was substantially complete, and that the proposed National Park Reserve in the South Okanagan-Lower Similkameen was feasible. However, in January 2011, Cabinet directed that the Province would not proceed with establishment of the national park reserve at this time.

- In December 2012, through capacity funding provided by Parks Canada, the Okanagan Nation released Building a Syilx Vision for Protection: Assessing Feasibility of a Syilx/Parks Canada Protected Area:
 - The report cited several key recommendations, one of which was an action for the Province to re-engage in future discussions of a national park reserve in the South Okanagan.
- o In August 2015, following a series of meetings with local stakeholders and member bands of the Okanagan Nation Alliance, the Ministry of Environment released an Intentions Paper identifying a proposed land protection framework for the South Okanagan for public consultation. The Intentions Paper proposed two concept areas as potential national park reserve sites, and one area as a potential provincial conservancy.
- The public comment period on the Intentions Paper ended on October 31, 2015 and a consultation summary was released in May 2016. Ministry staff reviewed over 3,400 responses to the Intentions Paper.
- On January 27, 2017, the Province issued a news release indicating that it was moving forward on discussions to implement the three concept areas identified in the Intentions Paper, and would continue to work closely with three Okanagan Nation communities (Osoyoos Indian Band, Lower Similkameen Indian Band and the Penticton Indian Band) and seek to re-engage with the Federal Government.

I am writing on behalf of BC Nature, the umbrella organization representing more than 6300 naturalists in 53 clubs in the Province, regarding our wish to see a national park reserve created in the South Okanagan Similkameen. Many individuals and clubs as well as BC Nature itself have written letters of support over the 14 years since the park was initially proposed and have participated in the local efforts to have it established.

I wish to congratulate you on being appointed Minister of the Environment and Climate Change in the BC NDP government. We are encouraged already by actions of your government since taking power on behalf of our natural environment and its wild inhabitants. We urge you to move forward with Parks Canada as quickly as possible to establish a national park reserve in the South Okanagan Similkameen, support for which was part of the NDP's election platform.

Under your leadership, this could be one of the first election promises that come to fruition. Your government has the opportunity to establish a national park reserve that is of international stature, protects and restores endangered species, and provides species with the habitats and conditions they need to adapt to climate change. The park will also have significant economic benefits in the local region.

The Liberal government's 2016 proposal for a combination of national park reserve and provincial conservancy in the South Okanagan Similkameen has a number of serious flaws, one of them being the exclusion of Mount Kobau and the surrounding area from the national park reserve. We urge you to have this area, called Txasqin by the Sylix (Okanagan) people, included in negotiations with Parks Canada. From an ecological viewpoint, this area is critical for the protection and restoration of populations of endangered species inhabiting it and to provide connectivity with areas further north and at higher elevations as species move in response to climate change.

The protection of this grassland-dry interior forests ecosystem is crucial as well for the economic well-being of communities in the surrounding area which depend greatly on tourism. All local and regional tourism organizations, the South Okanagan Chamber of Commerce, and local communities support the inclusion of all three of the former government's proposed areas in a national park reserve. With Mount Kobau included, the national park can be designated a Dark Sky Preserve, providing additional benefits to wildlife and bringing an international audience to an already established internationally-acclaimed astronomy site.

Professional polls of individuals in the South Okanagan Similkameen and resolutions and letters from business organizations, the Okanagan Nation Alliance, and local governments indicate a very high and increasing level of support for the park.

We look forward to your government negotiating with Parks Canada a national park reserve in the South Okanagan Similkameen which you and all who value our unique natural ecosystems and their wild inhabitants can be proud of. It will be an achievement for which future generations will remember your government with gratitude.



There has been several surveys undertaken. The following bullets are from a note in June this year. Keith may have additional survey information as to numbers in support.

- On April 8, 2015, the South Okanagan-Similkameen National Park Network issued a news
 release about a poll which showed support for a national park has increased significantly over
 the past five years by local individuals, as well as activity groups such as hunters and
 snowmobilers.
- The poll, conducted by McAllister Opinion Research in March 2015, found 69% of area residents favour a national park, while 21% oppose. This is up from the last poll in 2010 that found 63% of residents supported the park while 26% opposed.
- This poll also found 79% of ranching and farming households and 67% of households that participated in activities like ATVing and snowmobiling supported a national park proposal.
- The poll consisted of 501 phone interviews from the ridings of Boundary-Similkameen and Penticton, as well as the Regional District of the South Okanagan-Similkameen.
- The release of the intentions paper generated 3,460 responses. The comments varied in detail and presentation and, while some respondents directly followed the seven question format outlined in the intentions paper, the majority of submissions used the release of the intentions paper as a platform to reinforce perspectives on the question of whether the South Okanagan was a suitable candidate for a national park reserve.

Q. What about the proposed conservancy?

A. Parks Canada was not involved in the development of the previous B.C. government's protected areas plan for the South Okanagan, nor involved in its public review. While Parks Canada's preference is to focus on a national park reserve to provide for a more consistent land management regime, the designation of some areas as conservancy lands under BC legislation could be raised in the renewed discussions between all three parties.

Q. What about the community of Willowbrook that was included in previous concept areas for a national park reserve?

A. Parks Canada was not involved in the development of the previous B.C. government's protected areas plan for the South Okanagan, nor involved in its public review. Parks Canada does not include communities within new national park reserves.

Q. What about private lands? Will Parks Canada expropriate?

A. Parks Canada would not expropriate lands for a national parks reserve. Any private lands would be acquired on a willing seller – willing buyer basis.

Q. What about the results from the provincial consultations on their protected areas framework?

A. Parks Canada was not involved in the development of the previous B.C. government's protected areas plan for the South Okanagan, nor involved in its public review.

As we restart discussions, our area of interest will primarily focus on the areas that were the subject of previous consideration. We look forward to working together with the Province of B.C. and the three Southern Communities of the Syilx/Okanagan Nation to consider a national park reserve proposal in the South Okanagan region.



Context/Issue: The reporter writes that since the announcement on Oct. 27 that the federal government is renewing its commitment to a national park reserve in the South Okanagan, there's been a lot of buzz on social media and a lot of misinformation circulating.

He is hoping to do a story correcting some of the misinformation that he's been hearing. He says he is open to email responses or to speaking with someone from Parks Canada.

He is sharing some comments, concerns and misinformation he pulled from a Facebook page opposing the site. He would like Parks Canada to address the following comments and concerns.

We will also suggest an interview if the reporter has any questions regarding the establishment process, etc.

Parks Canada's response

The Government of Canada is committed to preserving and expanding the system of protected areas, including national parks and marine conservation areas, and delivering on Canada's commitment to protect at least 17% of Canada's land and inland waters and 10% of our oceans by 2020 in collaboration with the provinces and territories, Indigenous Peoples, and other key partners. Canada's network of protected areas also play an important role in helping to mitigate the impacts of climate change by protecting and restoring healthy, resilient ecosystems and contributing to the recovery of species at risk.

On October 27, 2017, the Governments of Canada and British Columbia, and representatives of the Syilx/Okanagan Nation, were pleased to announce a renewed commitment to work together to establish a new national park reserve in the South Okanagan.

A new national park reserve in the South Okanagan would protect would protect and represent one of the most southern and endangered natural regions In Canada and enabled this inspiring landscape to be shared with Canadians and visitors from around the world.

It should be noted that no boundaries or park concepts have been considered at this time. As we restart discussions, our area of interest will primarily focus on the areas that were the subject of previous

consideration. We look forward to working together with the Province of B.C. and the Syilx/Okanagan Nation to establish a national park reserve in the South Okanagan region.

The governments of Canada and British Columbia, along with our Indigenous partners, will take the necessary time to ensure that all parties are engaged and that the appropriate consideration and time are allocated. Public consultations and consultations with local Indigenous communities will play a key role in concluding the feasibility assessment. These discussions will also take into consideration the continuation of ranching and recreational activities in the region.

Parks Canada is committed to working together collaboratively with Indigenous Peoples to establish and manage national heritage places. We recognize that the natural and cultural values of these places have sustained Indigenous Peoples for thousands of years.

Please see Parks Canada's response to some of the concerns that have been raised:

1. Area residents will have to pay a fee to access their homes by road or to receive guests

Area residents will not have to pay a fee to access their homes or to receive guests. Parks Canada does not include communities within new national park reserves.

2. Local residents will no longer be able to access the back country because they will either be prohibited or the fees will be priced so high that only the rich can use the park, as is the case in Banff and Jasper.

Local residents will be able to continue to access the backcountry as long as the activities they are planning on doing in the backcountry are permitted under the *Canada National Parks Act* and there are no public safety or resource protection concerns.

Canada's national parks belong to all Canadians. A National parks and national park reserves enable Canadians, including youth and newcomers, to experience the outdoors and learn about our environment.

- Q3. Any land owner who lives within the park boundaries, or even nearby, will lose such property rights as the ability to keep domestic animals, to run a business, to build an addition or to sell their property to anyone other than Parks Canada. They'll be forced to sell to the federal government only and at the price Parks Canada dictates.
- A3. As set out in the *Canada National Parks Act* Section 15 (6), the Government of Canada cannot expropriate private property in order to enlarge or establish a national park or national park reserve. Private lands would only ever be purchased on a willing seller-willing buyer basis, based upon independent property appraisals.

The federal government has no jurisdiction over property rights on privately owned land adjacent to the boundaries of a national park.

- Q4. There will be no cattle grazing and ranches in the area will be shut down.
- A4. Long term relationships with ranchers are critical to the future success of a national park reserve in the South Okanagan-Lower Similkameen.

Throughout the feasibility assessment process for a national park reserve in the South Okanagan, Parks Canada has recognized the importance of building and maintaining strong relationships with ranchers and the local ranching industry. Although commercial livestock grazing is not typically allowed in a national park reserve, Parks Canada is committed to working with ranching families and the local livestock

association to build a model and framework for working together to manage grazing compatible with the national park reserve. This model will seek to provide ranching families with stability and certainty on crown grazing lands, tenures, water, and other resource values within the concept area.

Q5. With no cattle grazing, there will be no check on vegetation growth and this will lead to catastrophic wildfires. The smoke will harm orchard fruit and wine grapes. The fire will threaten neighbouring property.

Parks Canada is a recognized world leader in fire management. Through its national fire management program, Parks Canada is committed to reducing the risk of wildfires and protecting visitors, infrastructure, and natural and cultural resources on the lands it manages.

Fire management plan and a vegetation management plan will be developed. Parks Canada will engage with communities, neighbouring jurisdictions and the public in a dialogue about the objectives and techniques of wildfire control and fire use.

Management strategies are designed to minimise wildfire risk by reducing levels of dead and dry vegetation that act as fuel sources for wildfires. These fire management strategies may include cattle grazing, mechanised fuel reduction and prescribed burning (contained, intentionally lit fires that are only conducted under exacting conditions), in addition to fuel management actions undertaken directly adjacent to neighbouring communities and lands and nearby infrastructure, for example through the "FireSmart" programs that focuses on how individuals and communities can work together to reduce the risk of loss from wildfires in communities across Canada

The safety of the public, our crews, park infrastructure and neighbouring lands is always Parks Canada's number one priority. When wildfires occur and present a risk to people, property, cultural or ecological values, Parks Canada coordinates its efforts with provincial governments, local communities and other participants to respond immediately with focused effort to fully suppress wild fires.

Q6. The volunteer fire department in Willowbrook will be forced to shut down and the federal government will provide any firefighting.

A6. The community of Willowbrook would not be within the national park reserve boundary, and as such the local fire departments will continue to maintain their existing responsibilities. At the same time, Parks Canada has many years of experience in fire management in a wide variety of landscapes, and a national park reserve in the South Okanagan would bring with it Parks Canada's extensive planning and management experience to help manage and reduce the risk of wildfire both in the proposed park and through working with adjacent landowners. Joint planning, public education, active management and training sessions provide an opportunity to both prevent as well as respond to wildfire incidents.

Q7. Without the volunteer fire department, home insurance premiums will triple.

A7. The local fire department will not be affected so home insurance premiums should not be affected.

Q8. This proposal is aimed at giving land to local First Nations. That's why it's a national park RESERVE and not a national park.

A8. The term reserve is being used to recognize that there are unresolved claims of aboriginal rights in the area, In addition, within a national park reserve, Indigenous Peoples can continue to participate in traditional land uses and spiritual activities, and may be involved in cooperative management with Parks Canada.

Q9. People won't be able to transport firearms through the national park.

A9. The law governing transportation of firearms is a federal law that applies in all of the provinces and territories in Canada. That law is the *Storage*, *Display*, *Transportation and Handling of Firearms by Individuals Regulations*. The enabling Act for those Regulations is the *Firearms Act*. The law and act apply inside national parks.

If you are carrying a firearm through a national park to another destination it must be unloaded and securely encased as per current federal law.

12. What is the benefit to B.C. for a national park reserve rather than a provincial park?

- A national park reserve would be managed by Parks Canada.
- The necessary funding would be provided by the federal government to develop, operate and maintain the park.
- A larger area of protection (as national park reserve) enhances wildlife connectivity and survivorship for a range of species.

13. How much will this national park reserve cost B.C. taxpayers?

 Costs to the Province will be limited to the staffing and support costs associated with planning for new national park reserve.

14. There are some privately-owned lands within the proposed national park reserve. How are they affected?

- Private lands will only be considered for future park designations under a willing seller – willing buyer basis; no lands would be expropriated.
- Component areas referenced in the proposal also include large private conservation lands, which are owned and maintained by non-governmental

- organizations. These private conservation lands will not be considered as part of this proposal.
- Government will work with these organizations to seek complementary land management goals with respect to those areas.

15. When is the last time a national park reserve like this was created in British Columbia? How many federal parks will now be in B.C.?

- Canada and British Columbia negotiated a federal-provincial park agreement in 2001 to establish the Gulf Islands National Park Reserve.
- The establishment of the proposed South Okanagan National Park Reserve would signify the 21st location of a federal park, national historic site or marine protected area in B.C. (including seven other national parks or national park reserves).

BACKGROUND NOTES

- In October 2003, Canada and B.C. signed a Memorandum of Understanding (MOU) to study the feasibility of establishing three new federal protected areas in B.C. including the potential national park reserve in the South Okanagan-Lower Similkameen.
- The feasibility study began in 2004 and included two rounds of broad public consultations in 2004 and 2006, community forums in 2007 and extensive consultations with affected stakeholders. A socio-economic impact assessment was completed in 2008.
- o In 2010, senior officials representing B.C. and Canada agreed that the feasibility study, with the exception of First Nations consultation, was substantially complete, and that the proposed National Park Reserve in the South Okanagan-Lower Similkameen was feasible. However, in January 2011, Cabinet directed that the Province would not proceed with establishment of the national park reserve at this time.

- In December 2012, through capacity funding provided by Parks Canada, the Okanagan Nation released Building a Syilx Vision for Protection: Assessing Feasibility of a Syilx/Parks Canada Protected Area:
 - The report cited several key recommendations, one of which was an action for the Province to re-engage in future discussions of a national park reserve in the South Okanagan.
- In August 2015, following a series of meetings with local stakeholders and member bands of the Okanagan Nation Alliance, the Ministry of Environment released an Intentions Paper identifying a proposed land protection framework for the South Okanagan for public consultation. The Intentions Paper proposed two concept areas as potential national park reserve sites, and one area as a potential provincial conservancy.
- The public comment period on the Intentions Paper ended on October 31, 2015 and a consultation summary was released in May 2016. Ministry staff reviewed over 3,400 responses to the Intentions Paper.
- On January 27, 2017, the Province issued a news release indicating that it was moving forward on discussions to implement the three concept areas identified in the Intentions Paper, and would continue to work closely with three Okanagan Nation communities (Osoyoos Indian Band, Lower Similkameen Indian Band and the Penticton Indian Band) and seek to re-engage with the Federal Government.

Parks Canada, British Columbia's Ministry of Environment and Climate Change Strategy, and the three Southern Communities of the Syilx/Okanagan Nation are resuming discussions to protect lands as a national park reserve in the South Okanagan. Planning discussions through this joint partnership will commence immediately.

"A new national park reserve in the South Okanagan would protect one of Canada's iconic natural and cultural landscapes and provide opportunities to share this inspiring place with Canadians and visitors from around the world," said Minister of Environment and Climate Change and Minister responsible for Parks Canada, Catherine McKenna. "By renewing our commitment to work together, we can conserve this incredible landscape for future generations and, in so doing, also honour and recognize the important role of Indigenous People of the region and their traditional use of these lands."

As climate change continues, it is important to take protective measures to safeguard the significant and diverse regions of our country, such as the B.C. interior. The South Okanagan region represents an area of significant ecological, geographic, and cultural importance and offers a wide range of recreation and tourism opportunities. Qs and As

Q. What is today's announcement?

A. Today, the governments of Canada and British Columbia, and representatives of the three Southern Communities of the Syilx/Okanagan Nation, are pleased to announce a renewed relationship to explore developing a new national park reserve in the South Okanagan - Similkameen.

Q. Why is this a significant announcement?

A. Today's announcement represents a critical step in delivering on the Government of Canada's commitment to expanding our network of protected areas and protecting Canada's biodiversity.

This represents a valuable opportunity to move forward together on the journey of reconciliation and for nation-to-nation engagement with the three Southern Communities of the Syilx/Okanagan Nation.

After many years, we are pleased to be working in a tripartite partnership with the Province of BC and representatives of the three Southern Communities of the Syilx/Okanagan Nation to advance this important proposal.

Q. What will the boundaries be? Will the former BC government's proposal that was developed through consultation be adopted?

A. No boundaries or park concepts have been considered at this time. Parks Canada was not involved in the development of the previous B.C. government's protected areas plan for the South Okanagan, nor involved in its public review.

As we restart discussions, our area of interest will primarily focus on the areas that were the subject of previous consideration. We look forward to working together with the Province of B.C. and the three Southern Communities of the Syilx/Okanagan Nation to consider a national park reserve proposal in the South Okanagan region.

Q: Is a new feasibility assessment needed, or will the governments approve the previous version?

A: The Canada-B.C. Steering Committee completed a feasibility assessment report, but it has not been approved by either government.

In addition, the Syilx/Okanagan Nation also completed a Syilx vision for a protected area and associated recommendations in 2012, but dialogue on this has not begun.

Q. What are the next steps?

A. Following completion of the feasibility assessments, the next steps include determination by each party as to whether they find the final proposal feasible, and under what terms and conditions. Once there is agreement, the next step would be the negotiation of the required agreement or agreements.

Q. How long will this take?

A. The creation of a new national park is a complex process and the governments of Canada and British Columbia, along with our Indigenous partners, will take the necessary time to ensure that all parties are engaged and that the appropriate consideration and time is given at each stage.

Q. Will local communities be involved in the next steps?

A. Public consultations, particularly with local Indigenous communities, will play a key role in concluding the feasibility assessment. These discussions will also take into consideration the continuation of ranching and recreational activities in the region.

Q. Why is it important to protect the South Okanagan as a national park reserve?

A. The Okanagan is one of the most ecologically-diverse regions of Canada, and protecting this area would support recovery of over 60 federally listed species at risk.

In addition, Canada's network of protected areas play an important role in helping to mitigate the impacts of climate change by protecting and restoring healthy, resilient ecosystems and contributing to the recovery of species at risk. As climate change continues, it is important to take protective measures to safeguard this significant and diverse region in B.C. interior as a national park reserve.

Q. Would a national park reserve in the South Okanagan make any significant contribution to the Government of Canada's conservation targets of 17 per cent?

A. While the area protected by a new national park reserve in the South Okanagan - Similkameen may seem small on a national scale, even small areas can contribute as part of a larger network of protected and conserved areas. In addition, the South Okanagan - Similkameen is an excellent representation of many qualities of these targets, including protecting representative natural areas and habitat for species at risk, and managing these areas in partnership with Indigenous Peoples.

Q. Is there funding to establish this new national park reserve?

A. The Government of Canada is committed to expanding our system of protected areas and protecting Canada's biodiversity. Canada is committed to conserve at least 17 per cent of our country's land and freshwater and 10 per cent of coastal and marine waters through a network of parks, protected and conserved areas, and other effective areabased conservation measures by 2020.

Previous federal budgets have provided funding for Parks Canada to continue its work to expand our system of national parks and reserves.

Q. Why did Parks Canada walk away from this process more than five years ago?

A: In 2011, the Government of British Columbia indicated that it was not prepared to continue pursuing a national park reserve in the South Okanagan region at that time. Given that it was not possible to move forward without the Province's support, Parks Canada paused work on the proposal.

We are grateful to the various Indigenous organizations and communities, conservation groups, private businesses, and many other tourism and municipal organizations that continue to advocate for a national park reserve in the South Okanagan - Similkameen.

Q. Will a national park reserve allow access for continued helicopter use and training?

During previous discussions on a national park reserve proposal in the South Okanagan
 Similkameen, Parks Canada committed to respecting provincial permits for helicopter access and training within the proposed park. We stand by that commitment.

Q. What about the proposed conservancy?

A. Parks Canada was not involved in the development of the previous B.C. government's protected areas plan for the South Okanagan, nor involved in its public review. While Parks Canada's preference is to focus on a national park reserve to provide for a more consistent land management regime, the designation of some areas as conservancy lands under BC legislation could be raised in the renewed discussions between all three parties.

Q. What about the community of Willowbrook that was included in previous concept areas for a national park reserve?

A. Parks Canada was not involved in the development of the previous B.C. government's protected areas plan for the South Okanagan, nor involved in its public review. Parks Canada does not include communities within new national park reserves.

Q. What about private lands? Will Parks Canada expropriate?

A. Parks Canada would not expropriate lands for a national parks reserve. Any private lands would be acquired on a willing seller – willing buyer basis.

Q. What about the results from the provincial consultations on their protected areas framework?

A. Parks Canada was not involved in the development of the previous B.C. government's protected areas plan for the South Okanagan, nor involved in its public review.

As we restart discussions, our area of interest will primarily focus on the areas that were the subject of previous consideration. We look forward to working together with the Province of B.C. and the three Southern Communities of the Syilx/Okanagan Nation to consider a national park reserve proposal in the South Okanagan region.


