Dear Premier John Horgan, Minister of Environment George Heyman and Andrew Weaver, Leader of the Green Party

With December 1st marking the end of grizzly bear hunting in the Great Bear Rainforest (it should be extended to the whole province), hopefully a new era has dawned in British Columbia, and I thank you for bringing it about. However, another dark cloud looms on the horizon for those who love wildlife. You are planning to use conservation officers to police the new regulations which I guess are being drawn up. They have to be policed by someone and I suppose conservation officers are the logical choice – except that some of these officers I'm told happen to be trophy hunters. As well, the recruitment ad is designed to appeal to the love of killing that some people have. And 500 bears (grizzly and black) being killed as "nuisance bears" is way too many. I would consider this akin in some ways to the way some police officers have been killing young black men in the United States. For this reason, any one applying for the job as "conservation (?) officer" must be thoroughly vetted to make sure s/he is not this kind of person.

The second issue seems to be that there is no real enforcement of the laws against improper food handling, a major factor in wildlife getting into trouble with humans. This includes careless disposal of garbage, failure to pick up fruit from fruit trees, not properly fencing in or otherwise protecting cattle and other livestock – and, in some cases, deliberate feeding. Conservation officers would be making better use of their time monitoring these things and prosecuting violators with hefty fines or even jail time. And proper wildlife etiquette should be taught in schools. Too much attention has been given to dead politicians and not enough to the live things around us, human and non human.

Many of us voted for both your parties in hopes that you would give more attention to wildlife and the environment, as stated in your campaigns. Please do not disappoint.

The best way to protect people from being harmed by wildlife is to protect wildlife from being harmed by people. Please make this a cornerstone of your wildlife policy.

ISSUE: Update on Revitalization

BACKGROUND:

- Government has committed to fully implementing the United Nations Declaration on Rights of Indigenous Peoples (UNDRIP), the recommendations of the Truth and Reconciliation Commission Report (TRC), and the Tsilhqot'in Nation v BC decision of the Supreme Court of Canada.
- In Fall 2017, the Environmental and Land Use Committee (ELUC) endorsed the Minister of Environment and Climate Change Strategy to work collaboratively with Indigenous groups to identify priority Environmental Assessment (EA) Revitalization recommendations to pursue and implement government's commitments.
- The three objectives of EA Revitalization were confirmed to be:
 - Enhance public confidence
 - Pursue reconciliation
 - Protect the environment while supporting sustainable economic growth

DISCUSSION:

- The Environmental Assessment Office (EAO) has been working collaboratively on behalf of the Minister with the First Nations Energy and Mining Council (FNEMC) to develop a process for reaching consensus on recommendations for a revitalized EA process.
- This process would be jointly administered by the EAO and FNEMC, to inform the Minister and the First Nations Leadership Council (FNLC) in making decisions on proposed changes to the EA process.

Proposed Schedule:

- February to April;
 - First Nations engagement – the EAO and FNEMC will host regional workshops, providing an opportunity for all 203 First Nations to participate in EA Revitalization.
 - EA Advisory Committee – the EAO and FNEMC will establish an EA Advisory Committee to advise on the EA Revitalization goals of enhancing public confidence, protecting the environment and supporting economic growth.
 - Other engagements – the EAO will seek input from stakeholders groups, government agencies, local governments and the federal government.
- May: Draft issues paper for public comment, based on engagements.
- June: Public Comment Period – public engagement and submissions on issues paper.
- Summer: Draft “what we heard” document and Intentions Paper on proposed changes to revitalize the EA process;
 - Joint report to Chiefs-Cabinet table on proposed reforms.
 - Presentation at First Nations Gathering on proposed reforms.
 - Development of Request for Legislation.
- Target date for introduction of a new legislative/regulatory framework proposal is Fall 2018.

Dependencies:

- Continued need to align with processes for other Provincial mandate priorities (e.g. land use planning; species at risk legislation and climate action plan).
- Continued need for flexibility in timeline to ensure that all First Nations, local communities and governments and the broader public are provided with an opportunity to meaningfully engage in, and influence the EA.

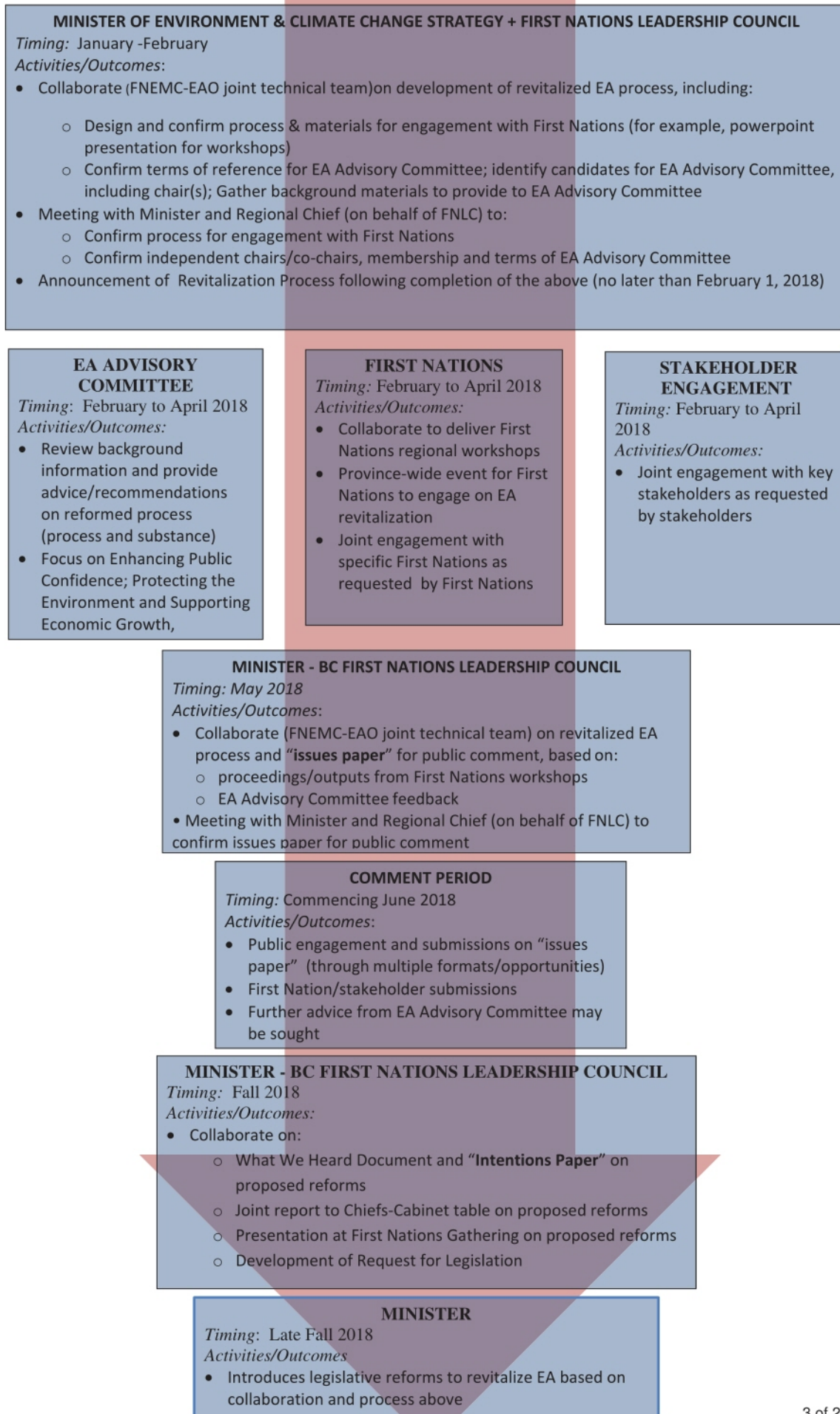

Subject: Scrap-It and Electric Vehicles (EV) meeting with MLAs Adam Olsen and Sonia Furstenau on January 24 at 4:00pm

Issue/Background:

- The purpose of the meeting is to discuss electric vehicle incentives and accessibility of the BC Scrap-It Program to independent EV dealers.
- The Ministry of Energy, Mines & Petroleum Resources (EMPR) is responsible for the Clean Energy Vehicle (CEV) Program and it is intended to accelerate the adoption of CEVs in BC. It is recommended that related inquiries be addressed to Minister Mungall as well.
- Issues raised by MLA Olsen are:
 - The limited availability of the Scrap-It program, making it a barrier for people to make a shift to EV vehicles.
 - The fact that many retailers are not eligible for the program, concentrating the market on just a few dealerships.
- The BC Scrap-It Program is a not-for-profit society, not a provincial program. The original program design (back in 1996) did not involve provincial government funding.
- When the program initially searched for partners that would provide funding the New Car Dealers Association (NCDA) was one of the few entities or associations that chose to be a part of the program.
- Scrap-It also receives financial support from carbon credits allocated to them by a legal agreement between a fuel supplier (Shell) and EMPR. This is a mechanism fuel suppliers can use to comply with BC's Low Carbon Fuel Standard (LCFS) under the Renewable and Low Carbon Fuel Requirements Regulation. However, Scrap-It GHG reductions resulting from their program are low and not necessarily meeting the intentions of the LCFS.
- According to Scrap-It, they can only allocate 1,000 incentives for new cars and only 250 for used cars. There are approximately 125 NCDA dealers that sell used cars.



- The provincially funded CEV program only provides incentives for new cars.

- The independent dealership at MLA Olsen's riding (Motorize) is not eligible for the program as they are not a member of the NCDA.
- The Province is aware of the challenges encouraging the development of the CEV market and is taking action to address them. Challenges include the limited supply of CEVs, current incentive programs being oversubscribed, and the need to encourage more regional supply from dealers to increase sales.
- Both the Pan Canadian Framework (PCF) and the Federal Budget 2017 include commitments with respect to CEV.
- The National ZEV strategy has a scrappage program as an option for consideration.
- The Province is currently working on identifying investment opportunities under the PCF and federal budget that support CEV infrastructure.
- EMPR is also exploring options to have a Provincial fleet initiative to encourage CEV adoption; and along with partners at the Pacific Coast Collaborative (PCC), is analysing the development of investment criteria to inform new EV charging infrastructure decisions.
- In the September 2017 Budget Update the Province committed \$40 million to continue the CEV Program. This funding will support fuelling and charging infrastructure, research, public awareness, and incentive programs for CEVs.

Dear Minister Heyman,

I am writing you today regarding incentives for electric vehicles. Currently British Columbia has the SCRAP-IT program, which is a voluntary early retirement vehicle program that provides incentives to help British Columbians replace higher polluting vehicles with cleaner forms of transportation. This is administered through a not-for-profit society and is only available in a limited quantity at specific dealerships.

For consumers purchasing an electric vehicle can be more cost-effective than maintaining a gas-powered vehicle and have a positive impact on the environment. Many British Columbians would like to switch to an electric vehicle, but find cost to be a barrier. Because of the limited availability of this incentive program, people are not able to make the switch unless they live near one of the dealerships included in the program.

This raises an additional concern regarding dealers. In my riding electric vehicles, both new and used, are available through local, independent retailers. However, these retailers are not eligible for the SCRAP-IT program and are losing business to the larger corporations that are included. This is slowing the growth of electric vehicle owners by keeping the market concentrated on a few dealerships and pushing others out of the market.

I ask that you look at how to make incentives for electric vehicles accessible across the province and applicable at all licensed dealerships under the Vehicle Sales Authority of British Columbia.

ISSUE: Professional Reliance Review briefing with Green Caucus January 31, 2018

BACKGROUND:

The Ministry of Environment and Climate Change Strategy is conducting a review of the professional reliance model in the natural resource sector to ensure the highest professional, technical and ethical standards are being applied to resource management in BC. This review is a priority for government and is contained in the Minister's mandate letter, and in the Confidence and Supply Agreement with the Green Caucus.

The objectives of this review are to make recommendations on:

- Whether professional associations that oversee qualified professionals employ best practices to protect the public interest;
- Whether government oversight of professional associations is adequate, and;
- Conditions governing the involvement of qualified professionals in government's resource management decisions and the appropriate level of government oversight to assure the public and their interests are protected.

DISCUSSION:

This project consists of five components:

1. A compliance audit of professional associations;
2. Appropriateness and effectiveness assessments of natural resource regulatory regimes;
3. Public engagement;
4. A jurisdictional/sectoral scan; and
5. A final report with recommendations.

The compliance audit of the professional associations is looking at the Engineers and Geoscientists of BC, Association of BC Forest Professionals, BC Institute of Agrologists, College of Applied Biology, and the Applied Science Technologists and Technicians of BC. Final compliance audit reports are being developed for each of these associations based on day long interviews, association submissions, and other available information. Reports will be finalized by March 1, 2018.

The appropriateness and effectiveness assessments for 36 natural resource regulatory regimes where qualified professionals are relied upon is intended to evaluate whether there are decisions being made by qualified professionals that should be held within

government, and if there are effective checks and balances to protect the public interest. The project team is currently conducting interviews with staff across the natural resource ministries as part of the assessment process. Assessments for all 36 high priority regulatory regimes will be complete by February 28th, 2018.

Public engagement through the EngageBC portal closed on January 19th, 2018. Submission numbers and results are still being finalized and collated to form a public engagement report, however currently, public engagement included:

- 9,500+ website visits including 500+ views of Minister Heyman's video on professional reliance;
- 2,400+ public surveys completed;
- 100+ stakeholder submissions;
- 300+ citizen submissions.

Several engagement activities are still active include:

- A survey for qualified professionals that remains open until January 27th (1,600 responses to date);
- Ongoing stakeholder interviews (over two dozen completed to date);
- An invitation has been sent to every First Nation in the province to be interviewed by the project team (interviews currently being scheduled).

The Jurisdictional/sectoral scan is currently being conducted to identify best practices in professional reliance models in other jurisdictions and sectors. This scan will be complete by February 28th, 2018.

The final report with recommendations will be informed by the products from the other components of this review (five association compliance audits, appropriateness and effectiveness assessments of natural resource regulatory regimes, public engagement final report, jurisdictional/sector scan). The report will be completed by spring 2018 and submitted to Minister Heyman, and a release to the public.

NEXT STEPS:

- Compliance audit reports for the five professional associations in scope for this review will be complete by March 1, 2018.
- 36 appropriateness and effectiveness assessment will be complete by February 28, 2018.
- A public engagement final report will be complete by February 28, 2018.
- A jurisdictional/sectoral scan will be complete by February 28, 2018.
- A final report with recommendations will be complete by spring 2018.
