I have another question for you. Do you know if there is any funding set aside for BC parks to undertake wildfire management within their parks? I ask because I had a meeting today with a residents association on fire prevention issues in our riding. There are two provincial parks in North Saanich that are apparently hotspots for fire hazards (both with a lot of residential properties around them). The residence association is pursuing funding through the firesmart program with FLNRO for educating their community but obviously it would be a much better approach in our area if BC Parks was working simultaneously to reduce the fire risk within the parks (cleaning up dead undergrowth/forest management).
