Dear Senior Ministerial Assistant Caelie Frampton,

The City of Vancouver wants to be the first Canadian city to significantly reduce the use of plastic-lined coffee cups and foam takeaway containers, but the city's groundbreaking proposal needs the go-ahead from you to charge a fee to make it possible.

Please amend the Vancouver Charter to enable the City of Vancouver to collect a fee on the use of single use coffee cups.

I urge you to carefully consider this decision and how it will impact communities, solid waste management, the environment, and the oceans.

An initiative this size will stop high volumes of plastic waste from one of Canada's busiest coastal cities from going into the ocean and set a nation-wide precedent to curb the global plastic pollution problem.

From giant garbage islands in the Pacific to plastic waste found inside the stomachs of birds, turtles, and other seafaring mammals, it's projected that there'll be more plastic in the ocean than fish by 2050. Disposable cups and takeaway containers are one of the most commonly littered plastic items on Vancouver's streets — costing taxpayers \$2.5 million per year for street and public trash can collection.

We have a huge global plastic pollution problem -- and Vancouver wants to do something about it. Please protect our communities, oceans, and waterways by giving Canada's greenest city the power to enact this plan. Thank you for your time and consideration.
