Hi Caelie/Eveline,

At the meeting with James Steidle last Friday, Jan 26, I understand a question came up where Minister asked for additional information. Below is what was pulled together by EPD.

- We do not allow the spraying of Glyphosate in wetlands unless it is “a Small “non classified wetland” (under 25m<sup>2</sup>) that dry up throughout the year and are not connected to fish bearing water when wet may be oversprayed”.
- The instances that the meeting participant may have presented could be situations of non-compliance or allowed applications as per above.

**How glyphosate use around wetlands in forestry is regulated under the *Integrated Pest Management Act (IPMA)*:**

- IPM Regulation (IPMR) Section 73 requires a Pesticide Free Zone (PFZ) to be maintained around **classified wetlands**, bodies of water and dry streams
  - Wetlands are classified according to the Riparian Management Area Guidebook (<https://www.for.gov.bc.ca/tasb/legsregs/fpc/fpcguide/riparian/Ripar3.htm#link58>)
  - Wetlands that are “not classified wetlands” but hold water may be considered a “body of water” and would still require a PFZ
  - Wetlands that are “Non Classified Wetlands” and are not bodies of water (e.g, dry during portions of the year) do not require a PFZ
- IPMR S.73(3) states that proponents must use a “no-treatment zone” (i.e., buffer) that is sufficient to maintain the PFZ
  - No buffer size is designated as the IPMR is intended to be results-based and there are many factors that influence the size of a successful buffer zone
- In forestry:
  - The PFZ (10 m) may be reduced to (2 m) around wetlands when using glyphosate with selective application methods to if it is not fish-bearing at any time of the year.
  - Small “non classified wetlands” (under 25m<sup>2</sup>) that dry up throughout the year and are not connected to fish bearing water when wet may be oversprayed.
    - The intention was to facilitate aerial spraying on cut blocks that may have some small isolated patches;
    - Industry’s position is that aerial application may not be a feasible treatment method if every small pond, tire rut filled with water or small patch of dry wetland vegetation required a protective buffer zone

> Further to yesterday's meeting with Sonia Fustenau, MLA, I would like provide an update on the status of the rezoning application by Tidal Harmony Holdings Ltd. to rezone a portion of the causeway at Cowichan Bay to permit marine-related manufacturing.  
>  
> This application was initially submitted to the CVRD in August of 2016. The application was subsequently amended and supplemented by the applicant, and was not sufficiently complete to be referred to government agencies and the Area D Advisory Planning Commission (APC) until April of 2017. On April 26, 2017 the application was referred out, and the CVRD has since received referral responses from the APC and the majority of government agency recipients. Following review of the application by the APC, the applicants commissioned an Environmental Management Plan to provide additional information about the environmental condition of the causeway and potential impacts and mitigation measures related to the proposed land use change. The Environmental Management Plan took a number of months to prepare and was received by the CVRD in November of 2017.  
>  
> One of the key agencies that received the application referral was the Cowichan Estuary Environmental Management Plan Committee (CEEMP Committee). This Committee has not yet reviewed or commented on the application. A meeting of the CEEMP Committee was scheduled for mid December, but was cancelled by the Chair

(Ron Diederichs) at the request of one of the CEEMP members (Cowichan Tribes). Our understanding is that a meeting would be re-scheduled for early 2018, but I have not received confirmation of the new meeting date. This application has not proceeded to the CVRD's Electoral Area Services Committee (EASC) because we have been awaiting the CEEMP Committee input on the application. If that input is not forthcoming soon, staff will be obligated to present the application without EASC input.

>

> A second issue that is interfering with the progress of the rezoning application is that the applicants have been unable to obtain authorization from the Province to pursue the zoning amendment. The subject causeway is on filled foreshore for which the Province has issued a Crown Land lease. The CVRD's rezoning procedures require that the land owner (the Province) authorize Tidal Harmony Holdings to pursue the zoning amendment on its behalf. We have been informed by the applicant that they have been unable to obtain written authorization from the Provincial agency that administers the lease (Ministry of Forest, Lands, Natural Resource Operations and Rural Development) for the rezoning application. I have spoken to Annette Bailey at MFNRORD about this matter and she confirmed that the Ministry was not prepared to authorize the application at this time. The rezoning application cannot be considered by the CVRD Board until the Provincial authorization is provided and the CVRD will not be able to continue processing the application if the Province does not authorize Tidal Harmony Holdings to pursue the rezoning.

Hi Aldous,

Staff have provided the following bullet summary to your contaminated well case, pls see below.

- In April 2017, two residential drinking water wells on Pender Island (4201 and 4205 Armadale Road) were found to have been impacted by hydrocarbons (likely gasoline) above levels safe for drinking. Concentrations were most elevated at 4201 Armadale Road.
- From June through August VIHA (Vancouver Island Health Authority) along with the Water stewardship group from FLNR conducted site visits of the two properties and collected water samples from their wells and several neighbouring wells.
- Water sampling results indicate that with the exception of the wells located at 4201 and 4205 Armadale Road, all neighbouring wells sampled by VIHA have non-detectable concentrations of hydrocarbon parameters.
- The most recent sampling by VIHA found that hydrocarbon parameters in well water at 4205 Armadale Rd are now below the Contaminated Sites Regulation drinking water standards and Health Canada drinking water guidelines and so the water is safe to drink.
- At this point, it appears that the only affected property is 4201 Armadale Rd.
- There are no apparent commercial or industrial sources of contamination in the vicinity of 4201 Armadale although a variety of activities carried out historically on a number of the residential properties, including 4201 Armadale, were suggested by local residents as possible sources.
- The aquifer on Pender Island is located in heavily fractured sandstone and shale which is characterized by complex hydrogeology, further complicating the identification of sources.
- The well on 4201 Armadale, and possibly also 4205 Armadale, was constructed without a surface seal, (such seals prevent minor contamination from the surface travelling down the well and into the drinking water). Both wells are below the elevation of Clam Bay road (to the

south) making them vulnerable to contamination from surface runoff from the road. The well on 4201 Armadale appears to be very close to the road allowance.

- The *Drinking Water Protection Act*, administered by the Ministry of Health (and VIHA) provides authorities for the protection of drinking water sources in the province. The Groundwater Protection Regulation under the *Water Sustainability Act*, administered by FLNR also provides authorities for protecting groundwater drinking water sources.
- Authorities to protect human health and the environment under Part 4 of the *Environmental Management Act (EMA)* are based on the polluter pay principal. In the absence of a likely source of contamination (i.e., polluter), land owner(s) can be held responsible for the investigation and remediation of contamination under *EMA*.
- Beyond voluntary compliance, tools within *EMA* for addressing contamination are limited to order powers (imposed on the person(s) responsible) and orphan site provisions.

**Subject:** Pender Island Drinking Water

Hi Aldous,

Great to chat with you today.

Here's some of the information prepared by Ministry staff on the issue of Pender Island drinking water.

- Two residential drinking water wells (4201 and 4205 Armadale Road) are known to have been impacted by hydrocarbons (likely gasoline) based on water quality results.
- The hydrocarbon concentrations are exceeding acceptable limits, and are indicative of high risk conditions at the residences in question, with concentrations at 4201 much higher than 4205 Armadale.
- There is no obvious commercial or industrial source of contamination or responsible person, and cross and downgradient drinking water wells are not showing impacts at this time.
- Homeowners of the properties with affected wells have been without use of their drinking water wells since April of this year and are having to seek water from alternate sources .
- The aquifer at Pender Island is located in heavily fractured sandstone and shale which has not been mapped. This type of subsurface geology makes it very

difficult to determine the source of contamination, since any contamination (such as gasoline) can travel in unpredictable patterns along rock fractures.

- VIHA (Vancouver Island Health Authority) along with the Water stewardship group from FLNR have collected several samples from downgradient and cross-gradient wells and so far only the 2 wells seem to be impacted. Upgradient wells were not sampled. VIHA is returning to the site in the near future to complete sampling of additional wells.
- ENV is awaiting further sampling information before assessing appropriate next steps.

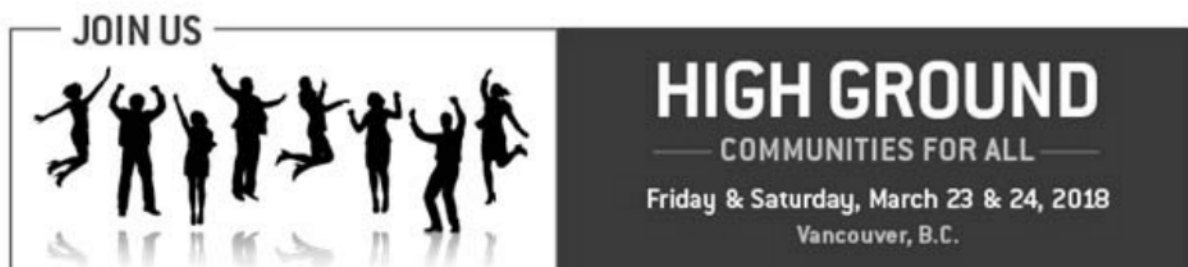

The courts are expected to announce whether or not a private prosecution case brought by Bev Sellars against the Mount Polley Mining Corporation will move forward in the coming days or weeks.

Is the minister available to comment on whether or not the province has any intentions of intervening in the case?

*RESPONSE:*

Provided Statement

The BC Conservation Officer Service, Fisheries and Oceans Canada, and Environment and Climate Change Canada are jointly conducting the investigation into the tailings pond breach at the Mount Polley mine site. To date, evidence has been collected under the provincial Environmental Management Act and the federal Fisheries Act.

While the statute of limitations for the Environmental Management Act may have passed, the investigation continues. BC's Conservation Officer Service will continue to work actively alongside federal agencies on this complex and thorough investigation. The statute of limitations under federal law is five years. Penalties can be far more significant under federal legislation, specifically the Fisheries Act, than under provincial legislation and a choice of charges would have to be made in any event. The Public Prosecution Service of Canada will consider all of the information gathered during the course of this investigation, should charges be recommended under the Fisheries Act or other legislation.

We recognize that the timeline for this investigation is significant. In general, the length of an investigation is dependent upon the complexity of the occurrence and the amount of information that needs to be gathered and considered. Be assured that both levels of government are committed to a thorough investigation within the timeframe of the federal statute of limitations.

The courts are expected to announce whether or not a private prosecution case brought by Bev Sellars against the Mount Polley Mining Corporation will move forward in the coming days or weeks.

Is the minister available to comment on whether or not the province has any intentions of intervening in the case?

*RESPONSE:*

#### Provided Statement

The BC Conservation Officer Service, Fisheries and Oceans Canada, and Environment and Climate Change Canada are jointly conducting the investigation into the tailings pond breach at the Mount Polley mine site. To date, evidence has been collected under the provincial Environmental Management Act and the federal Fisheries Act.

While the statute of limitations for the Environmental Management Act may have passed, the investigation continues. BC's Conservation Officer Service will continue to work actively alongside federal agencies on this complex and thorough investigation. The statute of limitations under federal law is five years. Penalties can be far more significant under federal legislation, specifically the Fisheries Act, than under provincial legislation and a choice of charges would have to be made in any event. The Public Prosecution Service of Canada will consider all of the information gathered during the course of this investigation, should charges be recommended under the Fisheries Act or other legislation.

We recognize that the timeline for this investigation is significant. In general, the length of an investigation is dependent upon the complexity of the occurrence and the amount of information that needs to be gathered and considered. Be assured that both levels of government are committed to a thorough investigation within the timeframe of the federal statute of limitations.

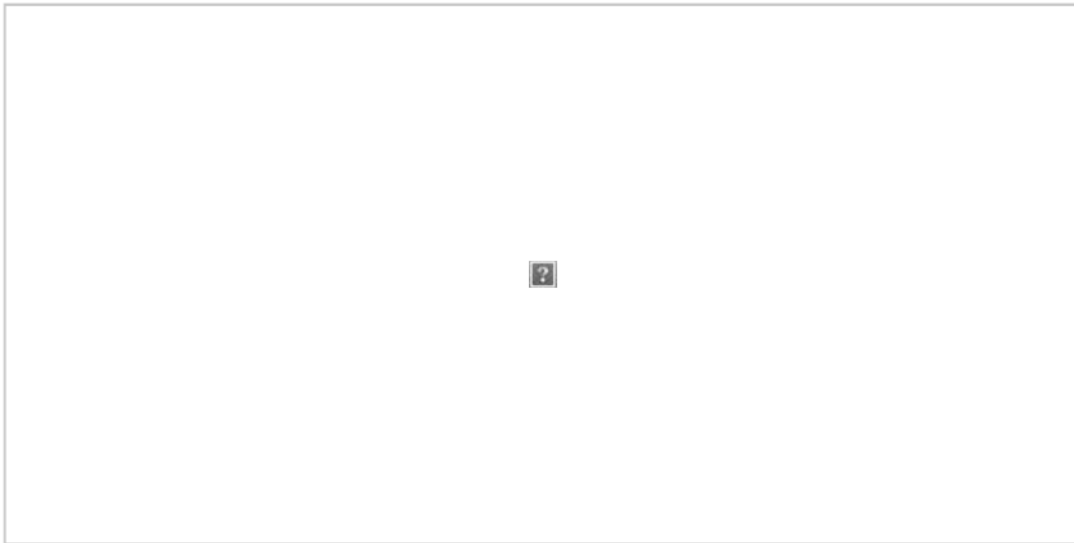

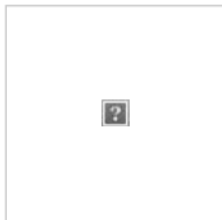
