Hi George,

Really great to see you the other day.

As promised, here is a link to the Transport Canada study I mentioned, about past and current oil product traffic on BC's north coast:

This study outlines how the articulated tug barges, such as the Nathan E Stewart, transit between Washington State and Alaska. Ie there is zero benefit for BC communities, and all the risk.

Of note in the context of the federal Oil Tanker Moratorium Act (currently being reviewed by the Transport Committee):

- Fuel barges for community resupply on B.C.'s north coast (ie for BC coastal communities) have a cargo capacity ranging from 1,600 to 3,200 tons;
- Fuel barges in transit to or from Alaska have a cargo capacity ranging from 6,400 to 8,000 tons;
- Bill C-48 the Oil Tanker Moratorium Act would prohibit vessels carrying more than 12,500 tonnes, and only if the vessels are docking at BC port. Therefore it would not prohibit articulated tug barges such as the Nathan E Stewart.

In our SCBC submission to the federal Transport Committee, we expressed strong support for Bill C-48 while requesting that it be strengthened in 4 key ways:

1. Limit the Ministerial exemption to emergency circumstances only.
2. Include refined oil under the scope of the Bill.
3. Decrease the tonnage threshold from 12,500 to 3,200 tonnes, to enable community fuel supply while prohibiting articulated tug barges such as the Nathan E. Stewart.
4. Expand the geographic scope to prohibit vessels above 3,200 tonnes from transporting crude or refined oil through Hecate Strait, Dixon Entrance and Queen Charlotte Sound, including vessels that are not stopping at BC ports.
