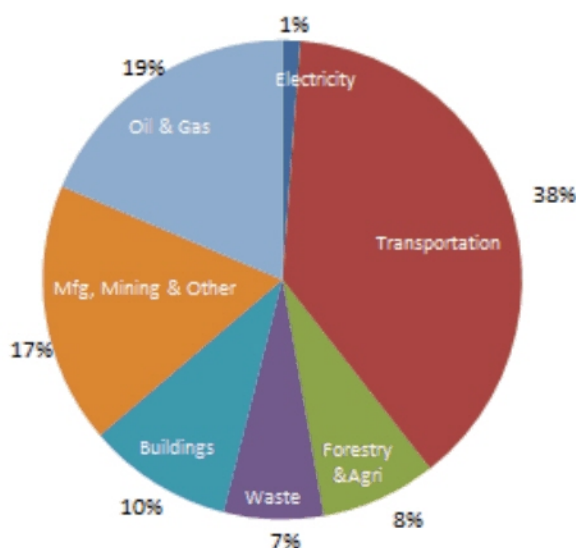

Carbon Pricing & Fiscal Policy

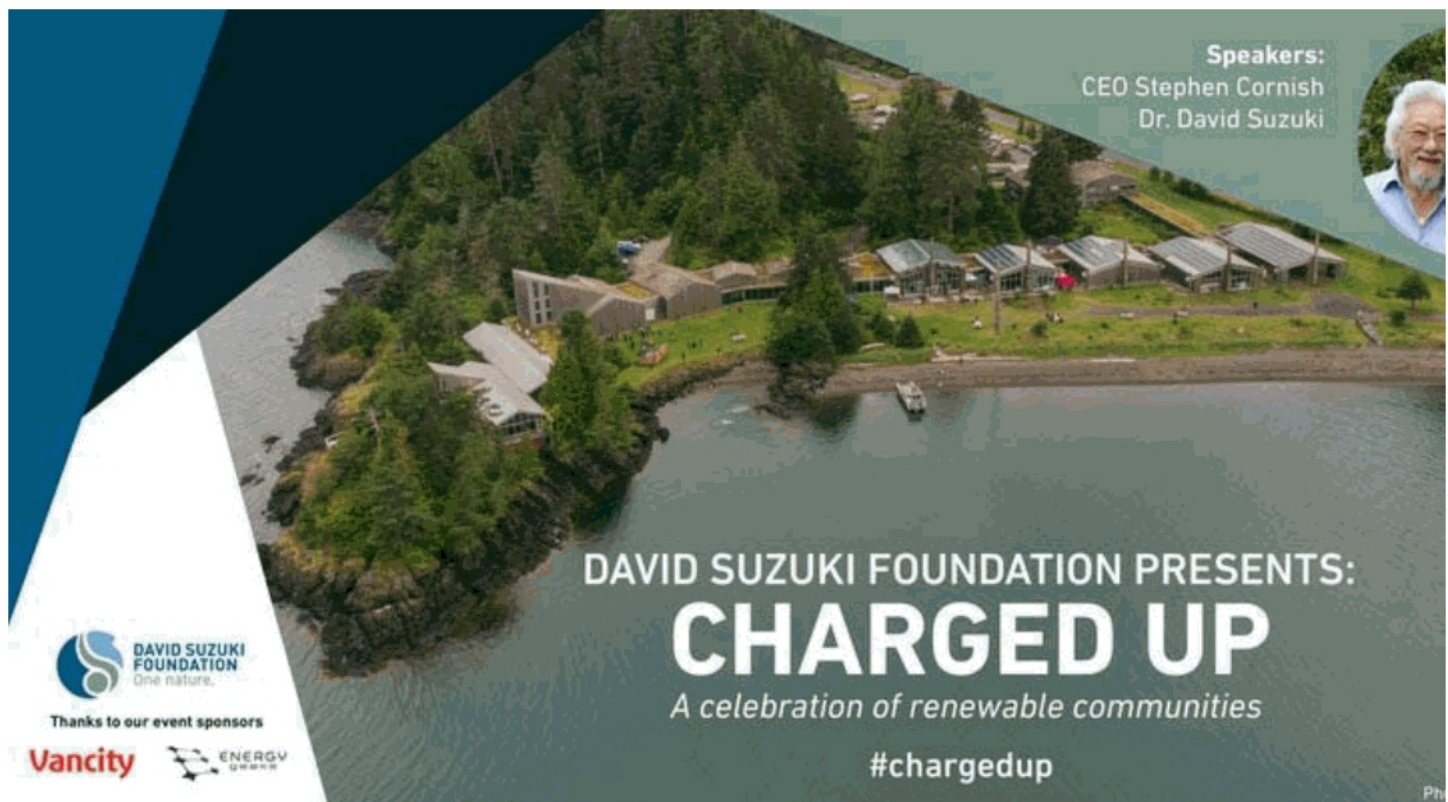
