Great to chat with you as well. No problem going through you on issues that come to our attention.

This one seemed to be a cross-jurisdictional thing with VIHA as well so... wasn't quite sure who to talk to.

Just for your information, we have met with the property owner most affected and they provided us a sample of their water for us — we were left in no doubt as to the seriousness of the situation. I also want to point out that the individual raised numerous concerns with how the testing was done (e.g. from what was observed filtered water was tested, and several neighbours were not tested because they were

not home — apparently no effort was made to contact individuals ahead of time). There seemed to also be a lack of testing on her neighbours' properties as well as a general disinterest in finding possible sources of the contamination (e.g. old industrial sites) or informing the neighbourhood of possible health risks to their water supplies. In essence, it appears a lackluster investigation has been underway to date.

Thank you for letting us know about the Aquifer and please keep us informed of further testing as it unfolds and any next steps the Ministry is intending on taking.

Great to chat with you today.

Here's some of the information prepared by Ministry staff on the issue of Pender Island drinking water.

- ?Two residential drinking water wells \$\frac{\sigma.22}{\text{ are known}}\$ are known to have been impacted by hydrocarbons (likely gasoline) based on water quality results.
- ? The hydrocarbon concentrations are exceeding acceptable limits, and are indicative of high risk conditions at the residences in question, with concentrations at \$.22
- ? There is no obvious commercial or industrial source of contamination or responsible person, and cross and downgradient drinking water wells are not showing impacts at this time.
- ? Homeowners of the properties with affected wells have been without use of their drinking water wells since April of this year and are having to seek water from alternate sources .
- ? The aquifer at Pender Island is located in heavily fractured sandstone and shale which has not been mapped. This type of subsurface geology makes it very difficult to determine the source of contamination, since any contamination (such as gasoline) can travel in unpredictable patterns along rock fractures.
- ? VIHA (Vancouver Island Health Authority) along with the Water stewardship group from FLNR have collected several samples from downgradient and crossgradient wells and so far only the 2 wells seem to be impacted. Upgradient wells were not sampled. VIHA is returning to the site in the near future to complete sampling of additional wells.
- ? ENV is awaiting further sampling information before assessing appropriate next steps.

"Chemically treated wood waste is not an inert waste and should never be burned in open fires or disposed of in Class III landfills" Alberta Government "Creosote-treated wood can leach chemicals that may dissolve in water, move through soil and contaminate groundwater. Creosote can also be taken up by plants and animals and is considered a probable human carcinogen." USA National Pesticide Information. BC MOE information states it must go to a specialized landfill. Upland's pit drains to Cold Creek, the water source for the DFO Quinsam River Hatchery and to the Quinsam River. CREC also has concern that other timbers from the John Hart Project and the Paterson Creek wooden flume (part of the Salmon River Diversion Project) have also gone to the Upland Excavating Ltd's pit. Hi Terri and Leona,

It is BC Hydro's understanding that creosote wood is exempted from hazardous waste. It can go to landfills as long as the landfill is willing to accept and licensed to do so. For some background, back in March, I spoke to the Comox Strathcona Waste Management. I talked to the rep about the potential for the Salmon River project materials from the decommissioning work going to the Upland site and all contaminated materials going to an approved site off of Vancouver Island. I did say our plan was to send the creosote timbers to the Upland site and the rep saw no issues with that - proper material going to the proper locations was our choice. The CVRD landfills can take creosote timbers but they need to be no more than 8' long, plus their disposal fees are more. Ours are longer timber lengths. The Uplands site was deemed better.

We have also been discussing the project during our community liaison committee meetings, with the last two being in February and June of this year. The next one is in October. We can discuss any issues that the committee members would like to discuss. The City and CREC are of course on the committee.

We are currently reviewing where the project will be sending the commercial and industrial material from the site, which is currently being stored in the Salmon River concrete canal.

I am writing to provide you information on an important matter now before the

Environmental Assessment Office relating to two large unlicensed dams in northeast BC.

I have made the attached submission to the EAO's office, but felt it was also important to share it with you as Environment Minister and to offer some background.

Your ministerial assistant asked me to provide this information to you.

The information directly relates to an issue highlighted in your mandate letter, namely, to "revitalize" the Environmental Assessment process.

It also bears on another key government objective outlined in the mandate letters of all Cabinet members - to fully adopt and implement the United Nations Declaration on the Rights of Indigenous Peoples.

On September 21, the public comment period closes on an extraordinary application made to the EAO by Progress Energy.

The company has asked the EAO to exempt two large dams - which the company built in 2012 and 2014 in contravention of the Environmental Assessment Act – from provincial environmental assessments.

The Environmental Assessment Act stipulates that the EAO is supposed to assess all major projects well before projects go ahead, not considerably after the fact.

Such reviews determine whether applicants are granted certificates that allow projects to proceed to development. The reviews can, under the direction of the EAO or you as Minister, be wide in scope and can include other facilities and activities associated with the projects. To grant Progress's exemption request would constitute a grave public disservice. The dams,

built without proper authorizations, should be thoroughly assessed by the EAO. Moreover, the EAO should analyze the projects by looking very broadly at associated facilities and activities, as the legislation allows for.

I hope that the information provided here helps to convince you of that case. The information provided includes:

Relevant background on the Progress dams that situate the dams in their broader context.

A review of deficiencies or concerns raised in the materials submitted by Progress Energy in support of its extraordinary exemption application.

Five recommended courses of action.

The five recommended courses of action are:

Progress's exemption request to the EAO should be denied. The EAO should conduct a review of the dams that fully takes into account whether or not they were built to sufficient engineering standards, especially in light of what the dams are there for.

In assessing the Progress dams, the EAO should determine whether or not the earthen structures are properly built to withstand ground motions from induced earthquakes, given their proximity to fracking operations. If the EAO determines that this is not the case, then the company should either be ordered to dismantle the facilities or re-engineer them to accepted seismic standards. The EAO should also assess whether fracking exclusion zones are warranted around the two dams specifically and other fracking dams more generally.

Under the Environmental Assessment Act environmental assessments can be broadened to include related facilities and activities. Given that at least 57 unlicensed fracking dams have been built to date on Crown lands in northeast BC - half of them Progress Energy dams - a broad environmental assessment is warranted that examines water usage and water demand in natural gas industry fracking operations and that fully considers cumulative environmental impacts.

The EAO should include in its review a broad inquiry into the consultation record regarding the two dams. What were First Nations told was to be built? If First Nations were not informed that the projects were dams, how could they have possibly foreseen that key provincial acts and regulations were at risk of being violated, to say nothing of their Constitutionally-protected and treaty-protected rights?

The EAO should conduct a wide-ranging assessment of the Lily and Town Dams that seeks to answer why regulators allowed the projects to proceed without them first being referred to the EAO. This should include a review of the much broader network of unlicensed dams built throughout northeast BC in recent years to corral water used in natural gas industry fracking operations.

Under the Act, the costs of conducting a thorough assessment can be ordered paid for by project proponent. It is appropriate that the company should cover all such costs. Thank you, in advance for considering this request and for reviewing other submissions to your office on this matter.

As mentioned at the beginning of this letter, the attached document contains more detailed background material and the rationale for a broader environmental assessment of Progress's Lily and Town dams, as submitted to the Environmental Assessment Office.

Mr. Nelless,

I must state that after all this time the response below is not what I was hoping for or expecting. As we discussed in phone conversation some weeks back, there are options open to you in getting compliance with the Order but yet you have refused to take action. I understand the appeal is to be heard in October, what I don't understand is why nothing has been done to enforce the order in the meantime. From my understanding the Order is legally enforceable regardless of when the appeal is to be heard. It will be approximately 6 months since since the Order was issued to the Appeal hearing and then another time period before the Appeal Board makes a decision. If I had not written several emails to your office and the Appeal Board expressing concern over the length of time it was taking to set the Appeal dates, the hearing would probably have been held in February or March of 2018. In the meantime I would still be without water and my kids are returning to school in 3 weeks time! I don't see how anyone can deem this to be acceptable. Regarding the neighbors having chickens, I honestly don't care if the neighbors have chickens, goats, pigs, and more horses (as they told MoE staff and me that

they would). What does concern me is that the having of these animals, as well as the 4 trailer loads of hog fuel, is polluting the ground, surface and well water coming onto my property and has caused extreme hardship and stress for me and my family. This is especially frustrating knowing that if the Abatement Order had been enforced from the beginning, the natural remediation process for my well could have been taking place for months now and the well could be that much closer to being remediated.

As requested of Ms. Glavina in email, has the results of the series of water samples that she took at my property been processed yet and when they do could I get a copy? Thank you.

Hi Brady,

I am forwarding you Dave Tamblyn's source assessment for the new well I had drilled this summer. As you can see, the water quality of the drilled well is in no way comparable to the quality of my old well. There will be a considerable up front cost to developing a treatment system for the new well ( refer to attached well assessment report ) as well as an ongoing financial and maintenance commitment. I have already spent an inordinate amount of time and money in dealing with this pollution issue, my kids will be returning to school in a month and I still do not have potable water. I have long advocated for the start of natural remediation of my old well (refer to Dave Tamblyn's PHE- Engineering Assessment Report ) so I can return to having the water quality I enjoyed before the \$.22 polluted my property. I am presently in the process of installing a metal liner on the ditch I constructed between the s.22 and my properties, as per recommendations in the Northern Health PHE-Engineering Assessment Report. There is nothing more I can do from my end to aid in the natural remediation process of my old well.

From my understanding the site inspection report for the most recent site inspection on the \$.22 property is complete. Why has the 6 March 2017 Pollution Abatement Order imposed on the s.22 not been enforced to date and what specific actions are going to be taken by your office/MoE to enforce the Abatement Order? With the Order not being enforced, the source of pollution is still in place, a large chicken coop has been built and the natural remediation process that is necessary if I am to have potable water on my property has not been able to begin. I believe I have been extremely patient in trying to obtain a satisfactory solution to this issue but this has not yielded significantly favorable results. It is long past time for your office to

act appropriately; enforce the Pollution Abatement Order that is in place/legally enforceable so that I can begin to have potable, safe drinking water for me and my family.

Thank you for your anticipated prompt attention to this matter and I look forward to your response in the near future.

As discussed, I have reviewed the well construction report (driller's log) and initial chemistry analysis for your new well (ID plate #39394). The best news is that I consider your well (screening level) low risk for containing pathogens. However, there are a few concerns with the raw water chemistry, as

you are aware, that make treatment necessary. Parameters of potential concern include iron, manganese, turbidity, pH and arsenic.

Fortunately, the solution doesn't have to be very complicated. I believe a whole-house greensand filter (more generally called oxidation-filtration) will address all of these issues. To be safe, I also recommend sediment pre-filtration using cartridge filter. If cost is a real problem the pre-filtration can be omitted at first, to see if the greensand alleviates the turbidity, but leave room to add it in later if required.

This is certainly not the only system that would work, and you should definitely consider a whole-house water softener with special resin to target iron and manganese, or a point-of-use reverse osmosis filter on your kitchen tap. The attached assessment report discusses all of these. I have written it at a rather nigh level, with rather more technical detail than I normally would for a single family residence, but you have shown an interest in the details of water treatment so I figured it would be appropriate in this case.

There may be innovative products out there that I'm not aware of - I'm a regulator, not a designer. Please discuss all options with an experienced and qualified water treatment designer before making your decision to purchase any equipment.
