I have spoken to Rick Zerr from the Town of Princeton regarding this site.

Based on our discussion, it appears that the demolition activities qualify for an exemption from submitted a site profile form to the ministry. As per the Contaminated Sites Regulation section 4(9), a person is not required to submit a site profile for demolition if the demolition does not involve any disturbance or excavation of soil other than which is incidental to the demolition. It should also be noted that the fuel tanks for the gas station were removed back in the 90's when the station stopped operating. The tank that was removed was an old heating oil tank.

In addition, since the station actually shut down and removed the fuelling facilities prior to the existence of the Contaminated Sites Regulation (ie. before the site profile requirements existed), there is no legal responsibility to submit a site profile for decommissioning at this time.

Spoke to Rick Zerr, CAO for Town of Princeton today regarding this complaint:

- Town of Princeton took control of this site through tax default
- Building was formerly used for auto repair (and prior to that, gas station) and vacated
- Building was deemed unsafe (squatters etc.) and needed to be demolished for public safety reasons
- Prior to demolition, asbestos was removed from piping material
- A heating oil tank was discovered partially under the road and was removed
- The tanks relating to the gas station were removed when the gas station shut down
- If the Town decides to sell the property or redevelop, it will complete a site investigation

Based on the information provided, there is no trigger to submit a site profile for decommissioning as the station shut down prior to April 1, 1997. Also, the CSR section 4(9) exemption for demolition applies; therefore, the Town was not obligated to forward a site profile prior to demolition.

The site profile process will be triggered upon redevelopment of the site. There is no evidence of contamination or high risk conditions at this time. No further action is required in response to this complaint (see email sent to complainant).

Updated January 16, 2018

- Subsequent communication with complainant indicated that the fuel tanks from the gas station were actually removed as part of the demolition of the site.

I have spoken to Rick Zerr from the Town of Princeton regarding this site.

Based on our discussion, it appears that the demolition activities qualify for an exemption from submitted a site profile form to the ministry. As per the Contaminated Sites Regulation section 4(9), a person is not required to submit a site profile for demolition if the demolition does not involve any disturbance or excavation of soil other than which is incidental to the demolition. It should also be noted that the fuel tanks for the gas station were removed back in the 90's when the station stopped operating. The tank that was removed was an old heating oil tank.

In addition, since the station actually shut down and removed the fuelling facilities prior to the existence of the Contaminated Sites Regulation (ie. before the site profile requirements existed), there is no legal responsibility to submit a site profile for decommissioning at this time.

If the Town of Princeton choses to sell or redevelop this property, the site profile process will be triggered if there is an application for rezoning, subdivision, or development permit and thus a site investigation will be required at that time. The City is aware of these requirements and understands the triggers for submitted site profiles.

With regards to your concerns about asbestos, that is regulated under the Hazardous Waste Regulation and outside my area of work. However, Rick Zerr indicated that any asbestos containing materials were removed by a qualified contractor prior to demolition of the building and the Town has records indicating such.

Based on the above, no further action is required by the Town of Princeton at this time.

The Land Remediation Section does not have any records for the two Parcel ID's you provided in your email below. In the case of a gas station, normally when a demolition permit is required from the local government, the provincial site profile process is triggered. We did not receive a site profile from the Town of Princeton in relation to a demolition permit. I will follow up with Rick Zerr at the Town of Princeton to determine if a demolition permit was required for the works described below or if an exemption from submitting a site profile was applicable (see Contaminated Sites Regulation, section 4).

If a site profile was not required for demolition, there is another trigger for submitting a site profile form directly to the ministry – for site decommissioning. The removal of tanks and buildings would constitute site decommissioning. As such, the ministry will send a letter to the current property owner notifying them of their obligations under the *Environmental Management Act* and Contaminated Sites Regulation with respect to the submission of a site profile.
