Hello all! Our office received this letter from Chief Alfred who is currently occupying the Swanson Island Marine Harvest facility. I'm looking to find out which ministry should take the lead on response. I'll paste their 'ask' portion below:

We request the government, in cooperation with Marine Harvest, to draft up the legal documents to turn over the cabins to us in full, relieving the company from any liabilities. We believe they owe us a lot more than a couple of cabins, but we will leave it at that...

We ask that the Government honor their commitment to UNDRIP, in the spirit of reconciliation, and step in and regulate this foreign industry, who are infringing on our aboriginal rights and title. There is a solution to all these issues and we expect the Government to do everything they can to find a reasonable resolution. Any input appreciated! Thank you.
