As stated in earlier emails, BC's Forest Practices Board is committed to the stewardship of our public forest resources and the continuous improvement of forest and range practices in BC. For more than

20 years, we have been serving the public's interest in ensuring sound management of our forest and range lands through our audits, public complaint investigations and reports and recommendations.

The Board has built a credible reputation and is highly valued by the many stakeholders in BC's forest sector. Public and stakeholder surveys have found that the independent watchdog role of the Board is considered very important by the vast majority of stakeholders and the public.

We continuously test the effectiveness of the *Forest and Range Practices Act* (FRPA) and its supporting framework, identifying opportunities for improved performance. We have made many recommendations to forest and range licensees, as well as government, to improve the FRPA legislation and regulations, the supporting framework of professional reliance, compliance and enforcement, and government objectives and land use planning.

Through our work auditing and investigating forest and range practices and the FRPA legislative framework, we have dealt with many issues involving species at risk and we have knowledge and an independent perspective on how well the current legal framework is protecting wildlife values that may be useful to you. We have also done significant work around the concept of professional reliance in the forest sector and there are a number of lessons learned that may be informative as you proceed with reviewing the professional reliance model.

Minister Heyman,

A delegation from the Community of Ymir and Councillor Jared Basil of the Ktunaxa Lower Kootenay Band will visit the BC Legislature in Victoria, BC October 23rd, 2017.

We are sending this second request to your office for a meeting on the same (October 23rd) or following day (October 24th) to discuss the situation in Ymir, BC.

This is a crucial opportunity to learn firsthand of the glaring flaws of the BCTS Quartz Operating Plan and the resultant impacts the proposed development will have on the families and businesses of our community by compromising the already strained water supply.

Our delegation is interested in solutions not confrontation.

**The Community of Ymir has a future water problem right now, even without any development within its Community Watershed.** Look at the attached photos and see how our collection pond spillover (extra water) dwindled throughout this past Summer: a Summer that was preceded by heavy Winter snowfall (141% of average) and non-stop precipitation throughout the Spring.

Under the FRPA, meaningful stakeholder consultation is proving itself dead. All stakeholders except BCTS are in unanimous opposition to the Quartz Operating Plan. BCTS claims to be "listening" but have not entertained any changes to their proposal to date.

**A disaster for all stakeholders can still be avoided.** Please work with us to find a solution. We currently have an appointment with Deputy-Leader Sonia Furstenau on October 23rd at 10:30am. Our presence in Victoria affords an ideal opportunity to meet with other ministers concerning this urgent matter.

The Ymir (Quartz) Community Watershed is a tiny 600 hectare low-elevation watershed that is only supplied by rain and snow, and provides our community of 400 with its **only viable and historically precarious source of drinking, household and fire hydrant water**. The watershed is horseshoe-shaped and has aspects facing South, East and North. All snow feeding supply is melted by late May, so **the community's only water supply during the summer months comes from rain**. The supply creek is largely fed by slow seeps, not streams, and the watershed's shaded and damp North-Facing aspect contributes the vast majority of this water during the hot dry months of summer. The North aspect is currently targeted by BCTS for 5.6km of road-building and 36 hectares of cut-block logging: the resulting loss of summer supply due to increased evaporation (sunny cut-blocks) and flashier run-off (road ditches turn slow seeps into fast flowing streams) would be an embarrassingly public gaffe for FLNRO, BCTS, and the NDP, but **most importantly would put the community's families in danger**.

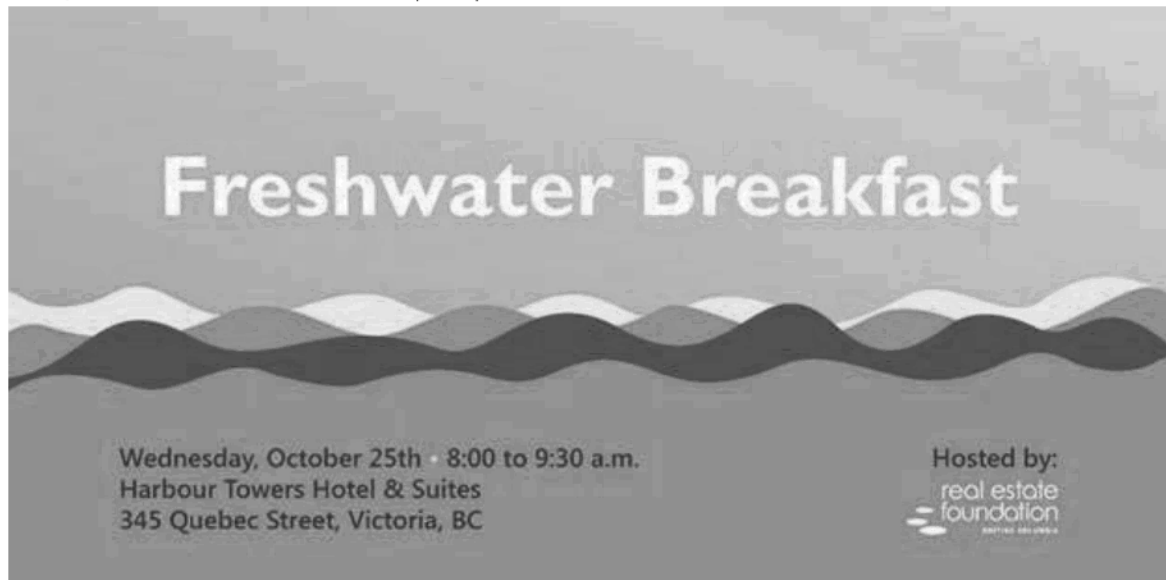

- There are access manholes at the upper and lower ends of the residential properties adjacent the collection line which are likely the source of the complaints (odours).
- Ministry spill response staff and VHA health inspectors have attended the site in the last year and have not observed surfacing sewage.
- Village of Cowichan Lake staff attended the site September 8, 2017, and advised they did not detect any surfacing effluent or odour.

Thanks again for your offers of congratulations and support. I have had a number of productive and helpful discussions with Foundation staff already. It's good to hear from you as always, bombardment or not, despite the difficult nature of the issues raised.

I appreciate your raising concerns regarding the regulation of the grizzly hunt post-November. As I believe you know my colleague Minister Doug Donaldson has responsibility for the Wildlife Act in his ministry and is currently engaged in an extended consultation regarding the regulations we promised to ensure that a meat hunt (which we both believe is rare) is not a surrogate for a trophy hunt.

In opposition I was very involved in policy preparation on the grizzly hunt and consulted with Faisal Moola, Brian Falconer, Chris Genovali, Doug Neasloss, Joe Foy and others at that time. We discussed the reasons why we were proposing the policy in the form we did - specific to a trophy hunt as the campaigns had asked - and which we are now introducing. The consultation underway is meant to ensure our trophy hunt ban works for its intended result and results in a very significant decrease in grizzlies killed. Premier Horgan was clear about this when our policy was first announced.

I know your views have also been communicated to Minister Donaldson. I will not presume the outcome of the consultation, I know that input will be seriously considered. I look forward to discussing the results of the review with my colleague, and of course to continued exchanges with you and others who care deeply about our environment, maintaining biodiversity and taking meaningful action on climate change.

Well, I didn't expect to begin to bombard you with emails this soon into your job, but here it is. I cannot for the life of me understand the power of the outfitters and guides who exploit grizzly hunts. As you well know, grizzlies were primarily plains animals who ranged all the way to Ontario and south to Texas because they fed on bison. As bison were extirpated and grizzlies deliberately killed, small populations were left in remote mountains. But they require a lot of room to move and humans are a very selfish animal claiming most of the land for ourselves. In today's ecologically conscious times, we know top predators like grizzlies play an important role in ecosystems.

Of course, I applaud the ban on trophy hunting of grizzlies but I do not understand why the loophole of allowing food hunting is still there. Who hunts grizzlies for food today? In fact, who ever hunted grizzlies for food in the past? There were far easier sources of meat, especially fish, than grizzlies. It was my hope that this letter wouldn't have been necessary. I am failing to understand why nobody from Ministry of Environment will be presenting on the panel at the public information meetings on selenium in the Kootenay River, this coming week in Montana. And, that we will have no government leaders or their representatives present either.

As per the press release forwarded to your staff, we are expecting U.S. state representatives on the panel. There will be no presenter from Ministry of Environment according to an update I received yesterday. There may be some MoE staff attending the joint meetings in Kalispel with their U.S. counterparts this coming week, but none will be presenting at the public meetings. The only presenter will be Teck (mining) from B.C. The panelists will be providing updated scientific findings/information.

KRN organized a similar event five years ago on the selenium issue, which was well attended, and well received. At that time we had Teck, DFO and Ministry of Environment staff present their findings as part of the panel. Because of KRN's reputation among government agencies, when our board decided to host public meetings again with updated information, we were encouraged/supported by DEQ in the U.S.

As the only Canadian on the transboundary board of Kootenai River Network, I am embarrassed that the province from which this issue is originating, does not deem it necessary to ensure Ministry staff are providing current information on selenium to the public it serves. Last week and this week's calls to your staff, (I appreciate that they were involved in moving offices last week) have not been returned. Letters sent in July after phone calls to yours and the Minister of Energy, Mines & Natural Resources offices (who deferred to your Ministry) were a request for someone from your office(s) to attend. Realizing that the House is sitting, making it necessary for the Cabinet to be present, I was hoping that a Deputy or Assistant

Deputy Minister, or another representative from your office, would be able to attend these meetings in a show of interest/concern to British Columbians attending.

KRN is expecting another good turn out from First Nations, environmental organizations, outdoor enthusiasts and media from B.C. and Montana.

At this late date, it's doubtful that anything will change. This letter is more a registering of my deep disappointment.

Dear Honourable Minister Heyman

Late last week the executive of Kootenai River Network (Montana) held a conference call in order to plan two public meetings (Eureka, Oct. 16 and Kalispel Oct. 17) in order to update the public on the selenium issue that is becoming more heated. I am the only Canadian on this transboundary board, and am the Vice-President.

We held similar events about five years ago and TECK presented as did other experts on fisheries and water.

More recently, there has been a selenium plant failure at TECK and I understand that selenium levels are now also high in the Creston area.

There have been several articles in the Flathead newspaper (which I could forward to you if you wish), and KRN felt it was time to update the public again in order to present facts. DEQ (U.S. Dept. of Environmental Quality) has asked us to take the lead in organizing these two events. The second night in Kalispel will be in conjunction with regularly held fall meetings for various US government agencies.

We are expecting that the Governor and Senator of Montana will be in attendance or at least their representatives as this issue is becoming more heated, and more political.

I can provide more information, but I think it would be important for you to be in attendance as our new Minister of Environment. I am expecting a draft agenda next week sometime and will share that with you.

Also, waiting to hear from TECK regarding who we should be inviting this time. MP Wayne Stetski is asking the Whip to attend these sessions as well, and he will confirm soon. We will also be inviting the appropriate tribal leaders on both sides of the border and promoting this

widely in southeastern BC and Montana.

Three tribes have signed a letter requesting that this matter go to the IJC for a decision. The Ktunaxa have pulled out of the process around this issue due, apparently, to a lack of trust. Ryland Nelson of Wildsight, Elk Valley Branch is aware of the meetings and he provided me with some valuable information. Because he is very close to this issue and I am not (the work of KRN is around creek, stream, river restoration projects and educational outreach), you might want to call him for more information (250) 531-0445.

Writing up a story that says CN is looking into herbicide spraying along their tracks near the Skeena River between Terrace and Prince Rupert.

**Recommendation**

Ministry staff are aware of the herbicide spraying along the rail line between Terrace and Prince Rupert and were onsite this week conducting an inspection following complaints on significant pesticide overspray.

\* The use of herbicides for the management of vegetation or preservation of wood on public or private land used for a railway right of way, yard, or associated facility is clearly prescribed in the Integrated Pest Management Act and Regulation.

\* Under the regulation, spraying on rail lines for under 20 hectares a year can be done under a pesticide user license, in which case the only restriction on what herbicide can be used is whether or not it is approved for use by Health Canada for that purpose (i.e. labelled appropriately).

\* Spraying on rail lines for more than 20 hectares a year requires the confirmation of a Pest Management Plan (PMP), which specifically lists the pesticide active ingredients that can be used. A PMP holder can only use the active ingredients listed in the current plan.

Later this month our Weekend Edition Sunday host Lulu Garcia-Navarro and I will be visiting Vancouver B.C. and parts of northern Washington to discuss some of the issues in the US relationship with Canada. One of the topics is the Trans Mountain Pipeline Expansion in B.C. We're hoping to talk to various stakeholders in the project – members of the B.C. government, representatives from Kinder Morgan, conservation groups and First Nations who have a stake in what happens with the pipeline.

I was hoping we could get 15 minutes of Minister Heyman's time to talk about this issue. The dates we'll be in Vancouver are Tuesday October 17th – Saturday October 21st. (they are willing to travel to Victoria)

Specifically, we're interested in asking him about why the B.C. government opposes the pipeline expansion, how they've been involved with the efforts of First Nations to stop the expansion, how the expansion project illustrates the interplay between the federal and provincial governments (federal in support, province opposed), and how the B.C. government sees Washington State's role in this issue that affects their shared waters.

Additionally - seeking interview on background with ministry staff by phone to stop and clarify if there's something we don't understand. Generally we'd want to ask them about the following:

- What power does the B.C. government have to stop projects like this?
- If the current B.C. government had been in power when the project was initially being reviewed by the National Energy Board, would they have been able to exert more influence in halting it?
- What do they see as the upsides/ downsides to the expansion project (will it create jobs? What is the argument Kinder Morgan is making and how do they answer it?)
- Are changes are being made to the way that projects like this seek approval from First Nations? (where are we in that process if so?)
- What conversations have they had with the Washington State

government about this project since it affects their waters too?  
- What power does Washington State have to do anything about it? (in other words, I'd like to know more about who gets a say in what happens in international waters like the Salish Sea).

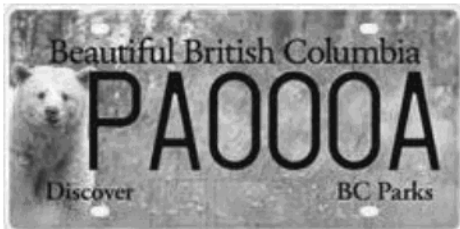

- \$104,259 - Living Oceans Society
- \$60,000 - Coastal First Nations
- \$6,100 - Surfrider Foundation – Vancouver Island
- \$25,000 - Ocean Legacy Foundation
- Federal and provincial agencies involved in the planning and response to tsunami debris are funded within existing budgets.
- The Province continues to support initiatives like The Great Canadian Shoreline Cleanup through funding from BC Parks. BC Parks provides up to \$500 per cleanup to community partners hosting cleanups in BC Parks, and up to \$5,000 per year.

Minister. I just spoke with Teck and our Ministry comms shops are preparing an IN. We can discuss tomorrow and next steps.

Here is a synopsis of the shutdown:

- Teck has made the decision to shut down the West Line Creek water treatment plant until the Advance Oxidation Process (AOP) add-on is fully operational.
- The AOP will convert remaining selenium in the effluent from selenite to selenate, a less bioavailable form of selenium.
- Teck's decision was based on recent fish tissue data which showed continuing accumulation of selenium in bull trout tissue within 2km downstream of the treatment plant.
- The hope is that selenium concentrations in fish will come down before spawning in the spring of 2018 –young fish are more susceptible to selenium effects.
- The shutdown will also result in increased non-compliance with nitrate concentrations, which are anticipated to exceed Level 2 effects benchmarks for benthic invertebrates.
- Teck is completing detailed design of AOP add-on to the treatment plant and anticipates the plant will be permitted, constructed and operational by the end of August 2018.
- There may be additional permit amendment requirements to dealing with residues and non-hazardous waste from the treatment plant.

Request: reporter wondering whether an LNG project can move toward being carbon neutral by purchasing carbon offsets in B.C.?

B.C. already allows a project to buy offsets to meet the carbon intensity benchmark of 0.16, so I am wondering about a project voluntarily buying offsets (over and above paying the carbon tax that is currently \$30 a tonne).

I ask because environmentalists say LNG Canada in particular would blow through B.C.'s climate targets for 2050, but LNG Canada is mulling the purchase of carbon offsets (LNG Canada will already be below the 0.16 provincial benchmark, so it does NOT have to buy carbon offsets for the purposes of meeting the benchmark. But as a good corporate citizen, LNG Canada is studying the purchase of carbon offsets to help B.C. meet long-term climate goals, I am told.)

**Suggested response:**

An LNG production facility could use BC greenhouse gas offsets to reduce their greenhouse gas emissions to zero voluntarily.

If an LNG facility emits less than 0.16t CO<sub>2</sub>e/tonne LNG it will receive credits for its performance beyond the benchmark. The credits can be sold to other LNG facilities.

Background:

- LNG facilities in BC will pay the Carbon Tax on all fossil fuel they use. The tax is currently at \$30 per tonne CO<sub>2</sub>e and will rise to \$50 per tonne by 2021.
- LNG facilities in BC will also have to achieve a GHG benchmark of 0.16tCO<sub>2</sub>e/tonne LNG or purchase BC GHG offsets to reduce their intensity to this level.
- The Industrial Reporting and Control Act was put in place to enable the benchmark and a regulatory offsets program that includes a public registry: <https://mer.markit.com/br-reg/public/bc/index.jsp>
- The Government of BC purchases these same types of offsets to meet it's carbon neutral government commitment each year.

In the below email, sent after the government made an announcement barring Trans Mountain construction on public land until it “meaningfully” consults aboriginal communities, the deputy minister says that until new consultation policy is developed, the ministry’s work should continue as before.

Just wondering if that new consultation policy has been developed yet, and if not, what sort of timeline that would be on.

Colleagues:

On August 10th, 2017 government announced initial action on its commitment to protect British Columbia's interests in the face of the proposed expansion of the Kinder Morgan pipeline and associated increases in tanker traffic.

In addition to announcing the appointment of Mr. Thomas Berger, QC as external counsel, government also highlighted its commitment to fulfill its duty to meaningfully consult with Indigenous people and foreshadowed future work aimed at clarifying government's policy

framework for decision-makers. This memo provides you and your agencies with further information regarding these last two items.

The Province of B.C. currently has in place robust policies relating to the requirements of Indigenous consultation as it pertains to applications for Crown authorizations. These policies have been developed in response to changing jurisprudence, among other things, and are subject to refinement and revision on an on-going basis. The recent announcement reaffirms government's commitment to fulfill its duty to consult, meaning that - until new consultation policy is developed and approved by government - Ministries' work on current permitting activities should continue as per current practice ensuring that legal requirements for Indigenous consultation are met.

Government also announced its intent to review relevant policies to further meet its commitments to defend our air, land and water. Any changes to these policies will take the form of new advice to decision-makers. While this work is underway, it is not yet complete. Until it is, the current policy framework under which your decision-makers operate remains unchanged.

I trust this memo clarifies some of the most relevant aspects of government's recent announcement, and assists you and your agencies in continuing to fulfill your constitutional and statutory duties.

The specific one that prompted my query comes from my own experience booked at Big Bar arriving the day before the evacuation. I asked later about the booking and was told all bc park bookings affected by wildfires were considered cancelled and refunds would be sent. We never got one. So it made me wonder about others affected since most parks up this way were shut down for weeks.
