The first three years of the WSA are a transition period to bring in approximately 20,000 existing non-domestic groundwater users into the current water licensing scheme and its first-in-time, first-in-right (FITFIR) priority system. If you are an existing non-domestic groundwater user, you are encouraged to apply within the three-year transition period to maintain your date of precedence. If you submit your application on or before December 31, 2017, your application fees will be waived.

We work with the CCG in Unified Command (described here: https://www2.gov.bc.ca/gov/content/environment/air-land-water/spills-environmental-emergencies/planning-prevention-response/partners-in-emergency-prevention/unified-command) to ensure a coordinated and effective response. Specific to hazardous material spills, and not other marine emergencies, we are also guided by the BC Marine Oil Spill Response Plan, which specifies (section 4.2) how we work with other federal agencies. Note the CCG has adopted the use of the Incident Command System since this plan was drafted.

Thanks for your inquiry.

- We share your constituent's concerns and Minister Heyman takes any potential risks to the
 environment, including potential risks to wild fish, very seriously. For this reason, the
 Ministry staff has been asked to inspect the fish plant facilities where underwater
 observations were made earlier this year.
- In British Columbia, the Waste Discharge Regulation under the *Environmental Management Act* governs discharges from fish processing plants into the marine environment. Discharge requirements in fish processing plant permits are site specific, and depend on a number of factors including the volumes and types of effluent produced, and the receiving environment into which the discharge is released. The requirements are designed to ensure that the environment is protected and pollution does not occur.
- The Ministry of Environment and Climate Change Strategy has conducted numerous
 compliance inspections on fish processing facilities around BC and findings from these
 inspections have triggered amendments to their permits. Permit amendments typically
 include more stringent requirements about the authorized discharge quantity and quality as
 well as effluent treatment works, monitoring and reporting requirements.
- Proposed amendments may also require the implementation of a much more stringent
 discharge and receiving monitoring program that will allow a company and the Ministry to
 collect data to better assess potential impacts to the receiving environment. The permits for
 the facilities seen in the video are either in the process of having their permit amended or
 are due for review in the near future.
- We will continue conducting compliance inspections of these and other similar facilities in the province to ensure that regulatory requirements are met and that the environment is protected.

- <!--[if !supportLists]-->• <!--[endif]-->Section 33 of the Park Act only permits subsurface rights to be granted under the *Petroleum and Natural Gas Act* or the *Oil and Gas Activities Act*, and does not allow any entry on or occupation, use or disturbance to the surface of the park.
- <!--[if !supportLists]-->• <!--[endif]-->This means that any drilling or exploration can only take place on lands adjacent to a park. The subsurface rights for exploration, development or production of petroleum or natural gas should not impact the ecological and recreational values for which a park was established, as anyone granted those rights can't enter a park or occupy or disturb the surface of land in the park.

Here is the information for your review:

- In British Columbia, pesticide sales and use are regulated under the Integrated Pest Management (IPM) Act and Regulation. Glyphosate use in forestry in BC is generally conducted under a Confirmation of a Pesticide Use Notice, which requires companies to develop a comprehensive Pest Management Plan (PMP) that outlines the specific elements of their Integrated Pest Management approach to controlling vegetation. As part of the development of this PMP, a public consultation process must be conducted according to the Regulation. Once a Confirmation is received that authorizes the use of the pesticide, companies must submit to the Ministry of Environment & Climate Change Strategy an annual Notice of Intent to Treat, which indicates the planned chemical treatments for the year, and an Annual Use Summary at the end of the year, which summaries total amount of pesticides used, and the total hectares treated using both chemical and non-chemical methods. Ministry inspectors conduct both field and office review inspections to verify compliance with the regulations, and have a range of enforcement tools available to address any instances of non-compliance.
- The IPM Regulation requires pesticide use in forestry to be done according to the principles of Integrated Pest Management, which seeks to use a wide range of tools, both chemical and non-chemical, to control pests. These include prevention of pest problems, proper identification of pests, use of monitoring and thresholds, appropriate treatment choices, and an evaluation of efficacy. A primary goal of IPM is to minimize the amount of pesticide used to control a pest. In addition, the required elements of the Pest Management Plan must also include a description of the environmental protection strategies and procedures that the authorization holder will follow, including strategies to protect fish and wildlife, riparian areas, and wildlife habitat from adverse effects of pesticide use. These requirements provide confidence that the judicious use of glyphosate in forestry is not having any adverse effects on forest health.
- All pesticides must be used according to label directions. In addition to label directions that
 establish buffers around sensitive aquatic or environmental features, provincial regulations
 require that for forestry uses, a 10 meter Pesticide Free Zone be established around or along
 all bodies of water, dry streams, and classified wetlands, providing further protection to the
 environment from any possible impacts from glyphosate use.
- Pesticides used in Canada are evaluated and registered by Health Canada's Pest Management Regulatory Agency, and registered active ingredients undergo periodic re-evaluations to determine if they are safe for human health and the environment. In 2015, Health Canada released the results from a comprehensive re-evaluation of glyphosate, in which they concluded that when used according to revised label directions, glyphosate use is not expected to pose risks of concern to the environment. These uses include the use of glyphosate in forestry.
