Request

I'm doing a story about books on hiking trails and whether publicizing trails has an impact on the environment.

There is a perception in Squamish that, after books on hiking trails are released, there is an influx of traffic to this trails, and outsiders bring in litter and damage the trails and the environment.

Wonder if the ministry could provide comment on this issue (environmental impact of publicizing trails) in general, not specifically on Squamish trails, unless you have information on that.

Recommended

- BC Parks is aware of the growing popularity of outdoor activities in the Sea-to-Sky corridor, where visitor numbers have grown throughout the corridor over the last 5 years – Joffre Lakes saw more than 100,000 visitors in 2016/17.
- BC Parks has developed strategies to manage this use. For example, year-round camping reservations are now required for Garibaldi Provincial Park, a popular backcountry destination, to protect the park ecosystem from overuse.
- By making Garibaldi sites reservable throughout the year, we're helping to provide more flexibility and certainty for travellers planning trips, as demand for the area grows.
- BC Parks is working to educate park visitors around safe and sustainable recreation, and encourages stewardship practices, including packing out what you bring in to the parks.
- To help ensure trailhead and backcountry facilities are maintained, during the summer season, BC Parks staff are providing regular maintenance and enforcement patrols, and contracted park operator service levels have been increased.
- BC Parks has hired new full-time senior park rangers, who will carry out backcountry patrols. This includes two new fulltime senior ranger positions in Garibaldi and a full time senior ranger for the Pemberton area. We have also increased the complement of seasonal park ranger staff working in this area.

I am researching a story on the evolution of the campfire, from wood to the propane fire pit, now widely available in retail stores. Propane costs less than the firewood sold at BC Parks campgrounds, is much healthier, and can be used during campfire bans in summer.

Know a BC Parks official who might want to comment for the story?

Recommendation

- BC Parks continues to allow wood burning fires within the boundaries of our campgrounds, however, they are fully restricted during any and all fire ban/restricted periods.
- During the fire ban/restricted period, campers may choose to use propane fire pits as an alternative to wood burning fires.
- Park Operators provide firewood for sale, and some offer rental of propane fire pits, within the BC Parks campgrounds they are contracted to manage.

Request

Talked earlier with Fire Information Officer Donna Macpherson about campfire bans in general. One missing piece that she wasn't able to answer: Within provincial parks, are there specific parks that have year-round campfire bans in the complete park or portions of them. If yes, which ones and where, please?

Recommendation

Within provincial parks, are there specific parks that have year-round campfire bans in the complete park or portions of them.

Proposed Response:

- Within BC Parks there are a number of reasons why fires are not permitted, such as:
 - Parks that are strictly day use (e.g. Kalamalka Lake, John Dean);
 - Parks that allow backcountry camping however, no fires (e.g. Cypress); and,
 - Parks that allow fires in their front-country camping areas (e.g. Mt Robson Park – Robson Meadows campground) however, campfires are prohibited in their back-country areas (e.g. Mt Robson Park – Berg Lake Trail).
- The best source of information to assist in determining whether a particular park (or area of a park) allows campfires is the individual Park pages on the BC Parks website:
<http://www.env.gov.bc.ca/bcparks/explore/>
 - If the individual park site includes a campfire icon (see below), campfires are permitted at a designated location within the park.
 - If the “fire” icon is not included, campfires are prohibited throughout the park.



Associated legislation:

- Section 11.1 of the Park, Conservancy and Recreation Area Regulation prescribe where fires are permitted.

11 (1) A person must not start or maintain a fire in a park, conservancy or recreation

area in

- (a) a campground,
- (b) frontcountry, or
- (c) backcountry that is less than 2 000 hectares in size,

unless the fire is

- (d) in a fireplace provided by the ministry, and
- (e) not more than 0.5 metres in diameter and 0.5 metres in height.
