1. Synopsis:

- The U.S. Environmental Protection Agency (EPA) has announced that it will roll back greenhouse gas (GHG) emission standards for cars and light trucks for model years 2022 to 2025. These standards were developed under the Obama administration, and were agreed to by automakers in 2012. Under the Canadian Environmental Protection Act, Canada regulates vehicle emission—but does so in a harmonized approach with the U.S. by incorporating “the U.S. EPA regulatory standards by reference (as amended from time to time).” The implication of this approach is that, absent developing independent Canadian standards, a roll back in the U.S. is a roll back in Canada.

  - The standards would result in a financial benefit for British Columbians because of significant savings on fuel costs, while they would also help us to reduce our carbon pollution and achieve our GHG reduction targets.
  - B.C. supports keeping the standards in place. We will work with our federal government, as well as our Pacific Coast Collaborative partners in California, Oregon and Washington, to ensure this.

Dear Minister Heyman,

I would like to congratulate you on your appointment as Minister of Environment and Climate Change Strategy and commend the concrete steps your government has taken to date to protect B.C.'s water, land and air.

Over the past two decades, the Fraser Headwaters Alliance (FHA) has worked to promote conservation and responsible resource use in the Fraser River headwaters region which includes, among others, the communities of McBride, Dunster, Valemount and Blue River. One of our top priorities over the years has been to conserve the pristine Goat River watershed, which is one of the last, large, undeveloped watersheds feeding the Fraser River. I would like to invite you to meet with me to discuss the feasibility of creating a protected area, or a park, in this watershed.

The watershed is nestled between three existing provincial parks—Bowron Lake, West Twin and Ptarmigan Creek—as shown on the attached map. Protecting the Goat would connect and consolidate these fragmented parks. The Goat River watershed is part of B.C.'s unique, inland rainforest and provides habitat for mountain caribou, Chinook salmon, bull trout and other threatened species.

We strongly applaud the draft Canada-British Columbia conservation agreement to protect the Central Group caribou and look forward to similar work being done with respect to the Southern Group caribou, which ranges into the Goat River watershed. We hope that protecting the Goat River watershed will be recognized as a valuable, fast and inexpensive step in support of these efforts. The watershed's difficult terrain has made logging in much of the area unattractive. However, the risk of encroachment by industry into this pristine environment remains real. There is much support for protecting the Goat in nearby communities, including the District of Wells. We are currently in discussions with the District of Wells on an MOU that would promote eco-tourism within the watershed. The Lheidli T'enneh First Nation, on whose traditional territory the watershed is located, has also indicated its support.

I hope to be able to discuss these issues with you personally and would be happy to provide additional briefing materials ahead of the meeting.

On March 26, 2018, BC Parks will be announcing the initiation of a management planning process for K'waal Conservancy and Alty Conservancy, located 18 kilometres north of Hartley Bay and 60 km southwest of Kitimat on the North Coast in your constituency. The Conservancies were established in 2007 as part of the North Coast Land and Resource Management Planning and subsequent government-to-government agreements between First Nations and the Province of British Columbia.

For this management planning project, BC Parks is collaborating with the Gitga'at and Gitxaala First Nations as per the applicable Collaborative Management Agreements, and will be consulting with the Kitselas First Nation regarding their asserted traditional harvest area over Alty Conservancy. BC Parks will develop a draft management plan for public review and comment. The draft management plan will then be revised as needed based on comments from the public prior to releasing the final approved management plan.

This management planning process is a part of regular BC Parks business. Management planning projects are currently in progress for approximately 47 protected areas throughout the province. Management plans are the key tool used to guide decisions on appropriate recreational activities, facility development, and the conservation of natural and cultural resources in protected areas. This includes applying management zones to outline appropriate activities and facilities. Management plans are always developed with the involvement of First Nations, local governments, the public and other interest groups.

- The U.S. Environmental Protection Agency (EPA) has announced that it will roll back greenhouse gas (GHG) emission standards for cars and light trucks for model years 2022 to 2025. These standards were developed under the Obama administration, and were agreed to by automakers in 2012. Under the Canadian Environmental Protection Act, Canada regulates vehicle emission—but does so in a harmonized approach with the U.S. by incorporating “the U.S. EPA regulatory standards by reference (as amended from time to time).” The implication of this approach is that, absent developing independent Canadian standards, a roll back in the U.S. is a roll back in Canada.
