This is what we're dealing with. This is a video of a man charging at a sow grizzly bear (with 3 cubs) apparently because she was eating off his fruit trees. You will note, he charged first. He then shot her in the face. She is apparently still out there wounded with her three cubs depending on her for everything.

On Oct 22, 2018, at 5:10 PM s.22

wrote:

Good afternoon, Adam. I'm hearing concerning reports of serious conflict in Bella Coola and that bears are being shot and killed simply for being bears. I unfortunately witnessed confrontational behavior from locals first-hand when I was there a couple of months ago but had no idea it would escalate to this. In one instance, I encountered a man with a rifle who seemingly came out of nowhere while I was respectfully observing a Grizzly and her 3 cubs. I eventually got him to leave peacefully but a conservation officer and I heard gunshots from his area later that night and immediately were concerned for the bears. I spent every evening I was there doing bear safety education to anyone around and resolved more than a few issues to keep both humans and bears safe.

I'm hoping you can shed some light on what is being done to prevent this senseless and barbaric behaviour and how I can help further? It sounds like this conflict is, for the most part, entirely preventable by humans but instead bears are being killed 'due to safety concerns'. I'm advised by locals that 'help' only shows up after the fact. I.e. once a bear has already been compromised, wounded or killed. It sounds like the system is designed to ensure conflict instead of preventing it. Why are the humans not being held accountable by adhering to and following common bear safety protocols? Why are there not consequences and/or fines to encourage people to keep their land free of bear attractants? Having been there, I know that this is not always possible as people have fruit trees and bushes in their yards and live next to rivers where the salmon run. But perhaps these people could be checked in on to ensure they are not creating conflict with wildlife. To be educated, so they know proper bear safety and thus don't fear. Garbage, however, being left around etc is absolutely preventable and there should be consequences for doing so. Right now it sounds like bears are the only ones paying the consequences.

Just to be clear, I'm not judging here or blaming. I fully understand that you can educate until you're blue in the face and have protocols in place and still have issues. But, to me, it doesn't sound like everything that could be done is being done. Not by a long shot. **s.22** in a large law firm with offices all over the world so I get that it's impossible to get everyone to dance to the same beat. However, I'm really hoping that we can come up with a plan together. I also want people to know that there are now individuals outside of Bella Coola that are aware of this issue and we're looking forward to finding solutions that keep everyone safe.

On Oct 4<sup>th</sup>, 2018 at approximately 0700 hrs a resident of the Bella Coola Valley observed a grizzly sow and three cubs in his yard. The following took place:

Good afternoon, Mike. There is serious conflict in Bella Coola and bears are being shot and killed simply for being bears. I unfortunately witnessed confrontational behavior from locals first-hand when I was there a couple of months ago but had no idea it would escalate to this. In one instance, I encountered a man with a rifle who seemingly came out of nowhere while I was respectfully observing a Grizzly and her 3 cubs. I eventually got him to leave peacefully but a conservation officer and I heard gunshots from his area later that night and immediately were concerned for the bears. I spent every evening I was there doing bear safety education to anyone around and resolved more than a few issues to keep both humans and bears safe.

I'm hoping you can shed some light on what is being done to prevent this senseless and barbaric behaviour and how I can help further? It sounds like this conflict is, for the most part, entirely preventable by humans but instead bears are being killed 'due to safety concerns'. I'm advised by locals that 'help' only shows up after the fact. I.e. once a bear has already been compromised, wounded or killed. It sounds like the system is designed to ensure conflict instead of preventing it. Why are the humans not being held accountable by adhering to and following common bear safety protocols? Why are there not consequences and/or fines to encourage people to keep their land free of bear attractants? Having been there, I know that this is not always possible as people have fruit trees and bushes in their yards and live next to rivers where the salmon run. But perhaps these people could be checked in on to ensure they are not creating conflict with wildlife. To be educated, so they know proper bear safety and thus don't fear. There are also electric fence options. Garbage, however, being left around etc is absolutely preventable and there should be consequences for doing so. Right now it sounds like bears are the only ones paying the consequences.

Just to be clear, I'm not judging here or blaming. I fully understand that you can educate until you're blue in the face and have protocols in place and still have issues. But, to me, it doesn't sound like everything that could be done is being done. Not by a long shot. s.22 in a large law firm with offices all over the world so I get that it's impossible to get everyone to dance to the same beat. However, I'm really hoping that we can come up with a plan together. I also want people to know that there are now individuals outside of Bella Coola that are aware of this issue and we're looking forward to finding solutions that keep everyone safe.

When the incident was reported I reviewed the satellite images of the area to assess the risk and benefit of doing a ground search for the sow. The property is surrounded by vast wilderness. With a 6 day time delay searching in the dense woods for a stressed out mobile sow with birdshot injuries become more risky than beneficial for both public safety and animal health. I did however review all HWCR's in the valley from the date of the incident to the date of reporting, no reports were consistent with the sow. We then monitored the area closely for any sightings/conflicts afterwards.

The sow that was killed in conflict or **s**.22 on October 13<sup>th</sup> was found to have #6 lead bird shot in its left front leg, left front shoulder, and a couple birdshot pellets in its left face. Suggesting it was facing the shooter with head lowered. No obvious infection was present and all the entrance wounds were healed closed. The sow was otherwise very healthy. The sow matched the physical characteristic of the sow in the **s**.22 conflict and the cubs matched the age class and colouration. There were other behaviour indicators that suggest that it was the same sow. That said,

- The male voluntarily gave a statement describing in detail an incident that occurred on Oct 4<sup>th</sup> where he discharged a firearm at a grizzly bear to protect himself.
- The initial investigation resulted in enforcement action in the form of a written warning being issued the warning was for failure to immediately report the incident;
- On Oct 14<sup>th</sup>, the video of the incident was posted on YouTube by the wife of the male who shot the sow grizzly;
- The YouTube video quickly gained notoriety and several complaints were phoned and emailed to the COS;
- The investigation was re-opened and a second CO with an extensive background in similar situations was brought into the investigation;
- On Oct 18<sup>th</sup> the male was asked to come into the Conservation Officer office for a second interview which he voluntarily complied with;
- CO's attended the residence where the incident took place and observed that steps had been taken to address attractants prior to the incident taking place;
- The sow and cubs have not been positively identified since the incident and the COS is not pursuing the injured sow at this time;
- The incident is still under investigation by the Conservation Officer Service and a review of the file will be completed by early next week when additional enforcement action may or may not be taken.



On Oct 4<sup>th</sup>, 2018 at approximately 0700 hrs a resident of the Bella Coola Valley observed a grizzly sow and three cubs in his yard. The following took place:

- The male resident got a shotgun loaded with bird shot and left the residence to attempt to haze the sow and persuade the family unit to leave the property;
- His wife got a phone and videotaped the incident as it unfolded see YouTube

- The male ran across the driveway in the direction of the sow grizzly;
- The sow charged the male who defended himself at very close range with a single discharge of the shotgun;
- The shot was enough to distract the sow grizzly and the male retreated into the house;
- The injured sow grizzly followed but eventually retreated into the forest with her cubs;
- There was no contact between the male and the grizzly;
- The grizzly sow has not been positively identified since the incident and the extent of the wounds are unknown;
- On Oct 10<sup>th</sup> the male self-reported the incident to the Conservation Officer Service in Bella Coola;
- On Oct 14<sup>th</sup>, the video of the incident was posted on YouTube by the wife of the male who shot the sow grizzly;
- On Oct 18<sup>th</sup> the male was asked to come into the Conservation Officer office for a second interview which he voluntarily complied with;
- The incident is still under investigation by the Conservation Officer Service.

Good afternoon, Adam. I'm hearing concerning reports of serious conflict in Bella Coola and that bears are being shot and killed simply for being bears. I unfortunately witnessed confrontational behavior from locals first-hand when I was there a couple of months ago but had no idea it would escalate to this. In one instance, I encountered a man with a rifle who seemingly came out of nowhere while I was respectfully observing a Grizzly and her 3 cubs. I eventually got him to leave peacefully but a conservation officer and I heard gunshots from his area later that night and immediately were concerned for the bears. I spent every evening I was there doing bear safety education to anyone around and resolved more than a few issues to keep both humans and bears safe.

I'm hoping you can shed some light on what is being done to prevent this senseless and barbaric behaviour and how I can help further? It sounds like this conflict is, for the most part, entirely preventable by humans but instead bears are being killed 'due to safety concerns'. I'm advised by locals that 'help' only shows up after the fact. I.e. once a bear has already been compromised, wounded or killed. It sounds like the system is designed to ensure conflict instead of preventing it. Why are the humans not being held accountable by adhering to and following common bear safety protocols? Why are there not consequences and/or fines to encourage people to keep their land free of bear attractants? Having been there, I know that this is not always possible as people have fruit trees and bushes in their yards and live next to rivers where the salmon run. But perhaps these people could be checked in on to ensure they are not creating conflict with wildlife. To be educated, so they know proper bear safety and thus don't fear. Garbage, however, being left around etc is absolutely preventable and there should be consequences for doing so. Right now it sounds like bears are the only ones paying the consequences.

Just to be clear, I'm not judging here or blaming. I fully understand that

you can educate until you're blue in the face and have protocols in place and still have issues. But, to me, it doesn't sound like everything that could be done is being done. Not by a long shot \$.22 in a large law firm with offices all over the world so I get that it's impossible to get everyone to dance to the same beat.
