Dear stakeholder,

We've announced today that our government will be strengthening requirements for fish processing operations in B.C. The sector-wide audit clearly shows that more work needs to be done, and we are taking important and immediate steps to ensure permits are updated and strengthened. The protection of the marine environment, including the health and survival of our iconic wild salmon, is a high priority for this government.

Released today, the ministry's audit report inspected all 30 fish processing facilities authorized under *the Environmental Management Act* in British Columbia. Inspections were conducted to verify compliance with permit conditions, collect effluent samples, determine whether effluent discharge was causing pollution, and identify the best achievable technology for the treatment of effluent. - *We've announced the Climate Change Accountability Act, which sets new legislated targets of a 40% reduction in greenhouse gas emissions from 2007 levels by 2030, and a 60% reduction from 2007 levels by 2040. This sets the stage for a renewed climate action strategy to be released in the fall.*
- *We've renewed the Climate Solutions and Clean Growth Advisory Council. The Council has begun advising our government on ways to achieve sustainable economic growth while expediting BC's transition to a low carbon future.*
- *We've delivered on our mandate to implement an increase of the carbon tax by \$5 per tonne per year, beginning April 1, 2018. The increase will be paired with new climate-action rebate cheques to low and middle-income families.*
- *We've implemented phase 1 and are in consultations of phase 2 spills regulations that will increase responsibility, transparency and accountability for those who own and transport potentially dangerous products through our province. In addition, we have worked diligently to defend our coast in the face of an increase in heavy oil traffic through BC.*

**Suggested Response:**

A joint investigation into the tailings pond breach at the Mount Polley mine site, which includes the B.C. Conservation Officer Service, Fisheries and Oceans Canada, and Environment and Climate Change Canada, is ongoing.

- We recognize that the timeline for this investigation is significant. In general, the length of an investigation is dependent upon the complexity of the occurrence and the amount of information that needs to be gathered and considered.
- Both levels of government are committed to a thorough investigation within the timeframe of the federal statute of limitations.
- The COS does not comment on investigative staffing while a matter is under investigation.
