Your letter received January 10, 2018, to Minister Doug Donaldson, Minister George Heyman and Minister Lana Popham, regarding the clearing of land and proposals to construct bridges on both Carey and Herrling Island, located in the Fraser River has been referred to me to respond on behalf of the ministers.

The Ministry of Forests, Lands, Natural Resource Operations and Rural Development has received *Land Act* and *Water Sustainability Act* applications that are proposing to establish bridge connections between the bank of the Fraser River and 1) Herrling Island via Herrling Channel, and 2) Carey Island via Jespersens Channel.

Ministry staff are still reviewing the potential impacts of these proposals and the decision makers on these applications are aware of the concerns you raised. This ministry's review includes an assessment of the potential impacts to fish and fish habitat, hydrology and sediment transport. The applications are also being referred for comments to local governments (i.e. the Fraser Valley Regional District and the City of Chilliwack) and First Nations with an interest in the area.

The change in land use from tree farm to crop production on both islands is authorized by the Agricultural Land Commission and is outside of the jurisdiction of the applications currently under review by this ministry.

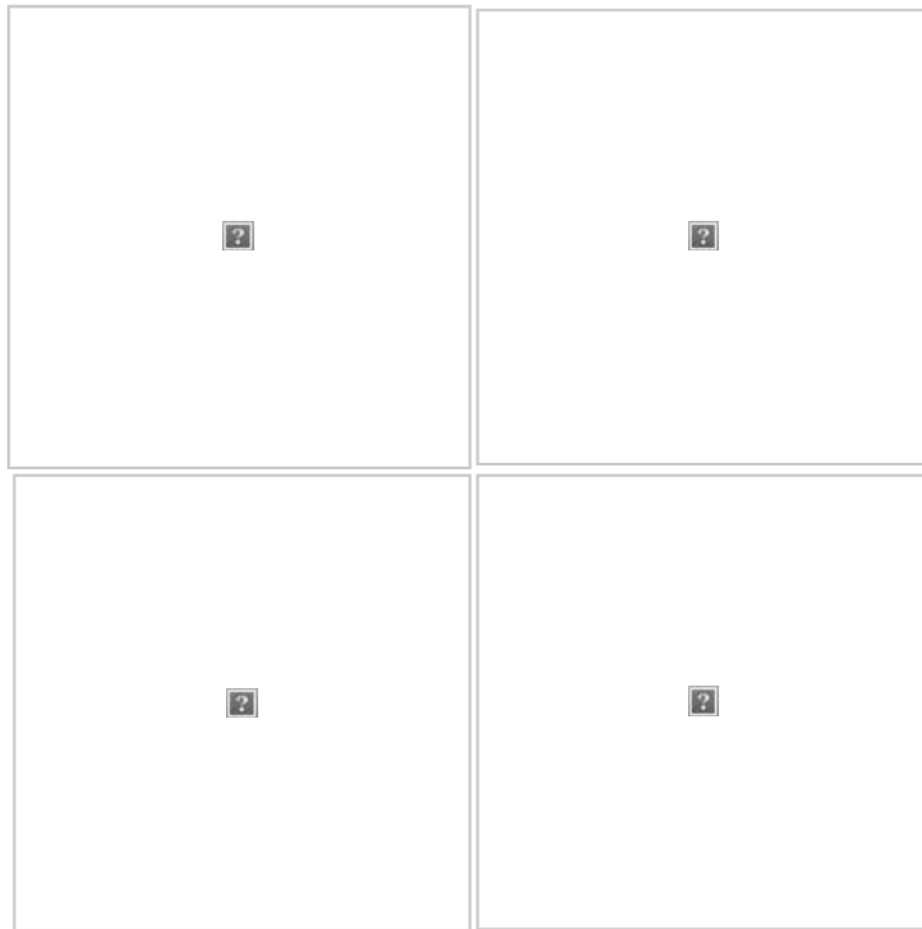

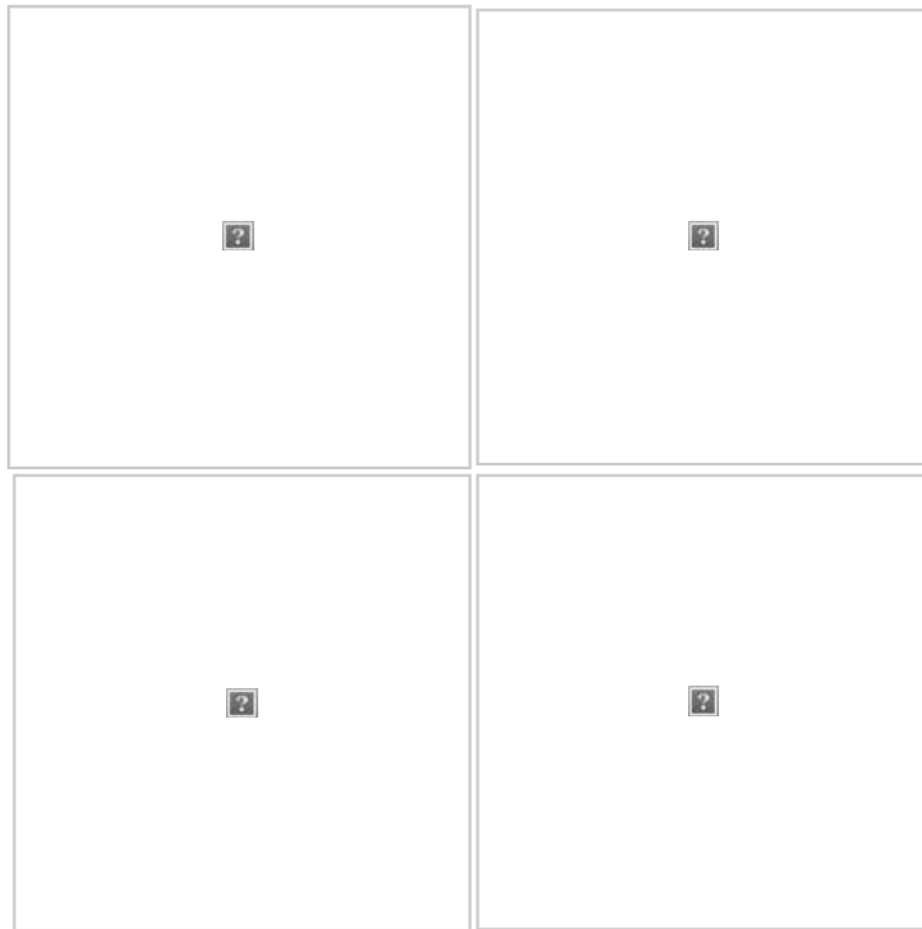
